## **Report of Independent Auditors**

To the Administrator of Boar's Head Provision Co., Inc. Bargaining Unit-VA 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Boar's Head Provision Co., Inc. The Plan is a defined contribution plan covering all members of United Food & Commercial Workers Local 400 of Boar's Head Provision Co., Inc. and Affiliated Companies (collectively, the "Company") employed at January 1, 1998 or have a minimum of one year of service after January 1, 1998. The Plan only provides for participant-directed investment programs. Effective August 1, 2016, participation to make elective deferral contributions begins on the first day of the calendar month, coincident with or next following the date the employee completes three months of service. Participants may enroll once eligible. Effective January 1, 2023, employees are immediately eligible to participate in the plan on date of hire. Participation in the profit-sharing contributions begins after the completion of one year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### Contributions

Participants may, upon their discretion, make contributions to the Plan through payroll deductions up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants age 50 and over have the discretion to contribute an additional \$7,500 for 2024 and 2023.

Participants may elect to rollover contributions into their participant account from another qualified plan.

The Company contributes to eligible participants as defined in the Plan agreement. Effective November 1, 2023, eligible participants received \$100 per month paid the month following the completed service requirements. November 1, 2021 through November 1, 2023 eligible participants received \$90 per month paid the month following the completed service requirements.

##### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, if any, and an allocation of earnings/losses on participant investments. Allocations are based on participant account balances, as defined.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the employer contributions portion of their accounts on the basis of years of continuous service under the following schedule:

Participants are also 100% vested in their accounts at normal retirement, death, or disability, as defined in the Plan agreement, if these events occur before the completion of two years of service.

**Distributions**

If the balance of a vested account exceeds \$1,000, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or a direct rollover to an eligible retirement plan, or, if meeting the terms of the Plan agreement for normal or early retirement, installment payments and annuities. Hardship distributions are permitted as specified by the Plan. If the balance of a vested account is \$1,000 or less and the participant has made no election, the Plan will pay the balance in a lump-sum as an involuntary distribution.

**Forfeitures**

Participants who terminate employment but have not become fully vested in the Company contributions, if any, and actual earnings portion on the Company contributions in their accounts, forfeit the unvested balances. Plan forfeitures are used to reduce the employer's contribution to the Plan. There were \$34,301 forfeited nonvested amounts available for use at December 31, 2024. There were \$74,800 forfeitures used to reduce employer contributions during the plan year ended December 31, 2024.

**Notes Receivable from Participants**

The Plan has a loan program under which it makes available loans to participants on a nondiscriminatory basis. Each participant is limited to a maximum of one loan. The loans cannot exceed \$50,000 or 50% of the participant's vested amount and must be paid back over a period not to exceed five years. If the purpose of the loan is to acquire a primary personal residence, then the term of the loan can be longer than five years. All loans bear a prime rate plus 1% prevailing interest rate (as defined in the Plan agreement). The outstanding notes receivable interest rates at December 31, 2024 ranged between 4.25% to 9.50%. Nationwide provides notices to participants regarding late, missing or insufficient payments relating to their outstanding loans.

**Administrative Expenses**

The Company is the administrator of the Plan and pays administrative expenses related to recordkeeping fees charged by Nationwide Financial Services, Inc., maintenance of participant accounts, and fees associated with testing and reporting services, such as the annual non-discrimination testing. As these expenses are incurred and paid by the Company, they are not included in the accompanying financial statements of the Plan. The Administrative expenses listed on the Statement of Changes in Net Assets Available for Benefits relate to Related Party and Parties in Interest transactions that are paid by the participants and are further discussed in Note 7 to these financial statements.

**2. Summary of Accounting Policies****Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with United States generally accepted accounting principles (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements.. Actual results could differ from those estimates and such differences could be material.

### Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Payment of Benefits

Benefits are recorded when paid.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as of December 31, 2024. See Note 4 for investment valuation information. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by third parties.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments, as well as interest and dividends earned.

## 3. Certified Financial Data

The following is a summary of investment balances and related investment information, including notes receivable from participants and related interest income, included in the accompanying financial statements and supplemental schedule which was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company, FSB, the custodian (the "Custodian") of the mutual funds, and the Nationwide Life Insurance Company, the insurance company of the unallocated fixed annuity contract (the "Insurance Company") as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### 4. Fair Value of Financial Instruments

The Company follows FASB guidance on fair value measurements. That guidance creates a common definition of fair value for recognition and disclosure purposes under U.S. GAAP. The guidance also establishes a hierarchy for measuring fair value and enhances disclosures about fair value measures required under other accounting pronouncements but does not change existing guidance as to whether or not an instrument is carried at fair value.

The guidance also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. The standard establishes three levels of inputs that may be used to measure fair value:

- Level 1 Quoted prices in active markets for identical assets or liabilities;
- Level 2 Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The Plan's valuation methodology used to measure the fair values of mutual funds were derived from quoted market prices as these instruments have active markets. The unallocated fixed annuity contract is a fixed return product with annual interest rate guarantees, after the first period. Deposits are guaranteed in both principal and interest by Nationwide Life Insurance Company. These investments are not available in an exchange or active market. The unallocated fixed annuity contract has been reported at fair value at December 31, 2024 and 2023.

The Best of America Fixed Contract is an unallocated, non-fully benefit responsive contract and is reported at fair value. Fair value is equal to contract value less any Contingent Deferred Sales Charge, as defined in the contract, if applicable, and Market Value Adjustment. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. The Market Value Adjustment is based on current and future crediting rates and the interest rate swap curve. Crediting rates are reset annually, which may vary from the interest rate applied to account balances at the end of the prior period. These rates were 2.20% for 2024 and 2.20% for 2023. Exchanges or transfers in the non-fully benefit responsive contract will be made at contract value in any amount which is not more than 20% of the contract value, as determined on the date which the amount to be exchanged will be released from the contract. The 20% limit will be reduced by all exchanges and transfers, which have been made at contract value during the twelve calendar months preceding the date of the exchange. Any exchanges or transfers that exceed the 20% limit will then be subject to an adjustment to fair value.

## **5. Partial Plan Termination**

On September 13, 2024, the Jarratt, Virginia plant was indefinitely closed, which led to over 20% termination of the plan participants. All affected participants became 100% vested in their accrued benefits on that date.

As a result of this partial plan termination during the year ended December 31, 2024, affected participants received distributions totaling \$1,255,233. In addition, loan principal offsets aggregating \$199,423 were applied against participant account balances. Both the distributions and loan principal offsets are included within the benefits paid to participants reported in the Statement of Changes in Net Assets for the year ended December 31, 2024.

## **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants will become 100% vested in their accounts.

## **7. Tax Status**

On December 31, 2014, the Plan adopted the prototype non standardized profit-sharing plan with CODA. The prototype plan received an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the written form of the underlying plan documents is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and that any employer adopting these forms of the plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the Plan is exempt from taxation. The Plan has been amended since its adoption; however, the Plan administrator believes that the Plan is currently designed and is operating in conformity with the Code.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is not subject to income tax examinations for years prior to 2021.

## **8. Related Party and Party in Interest Transactions**

Plan investments include an unallocated fixed annuity contract and mutual funds that are managed by the Custodian and the Insurance Company, and therefore these transactions qualify as party in interest transactions. Party in interest investments total \$1,271,123 and \$1,755,011 as of December 31, 2024 and 2023, respectively. Notes receivable from participants of \$313,088 and \$470,756 qualify as party in interest transactions at December 31, 2024 and 2023, respectively. Fees paid for services rendered by related parties and parties in interest of \$117,910 for the year ended December 31, 2024 were based on customary rates for such services and were paid by the Plan.

## **9. Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date that the financial statements were available for issuance.
