We have performed audits of the financial statements of GCE International, Inc. Employees' Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets in liquidation available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of GCE International, Inc. Employees' Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Emphasis of Matter

As discussed in Note 3 to the financial statements, the Plan Sponsor adopted a plan amendment to terminate the Plan effective July 31, 2023. As a result, the Plan has changed its basis of accounting from going concern to the liquidation basis used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to that matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of GCE International, Inc. Employees' Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about GCE International, Inc. Employees' Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1 Description of Plan

The following description of the GCE International, Inc. Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective December 31, 2010, the Plan was frozen and no additional benefits will be accrued by employees for future years of service.

General

Prior to December 31, 2010, the Plan covered substantially all employees of the Company employed in Pennsylvania. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan sponsor is GCE International, Inc. (the "Company" or "Plan Sponsor"). The Board of Trustees is responsible for oversight of the Plan. The Plan's investment advisors determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Plan's Board of Trustees.

Funding Policy

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023, the Company made contributions of \$533,305 and \$180,000, respectively. The Company's contributions met the minimum funding requirements of ERISA for 2024 and 2023.

Pension Benefits

Employees with one or more years of service are entitled to annual pension benefits beginning at normal retirement age (65). The amount of monthly pension benefits was \$7.50 for each calendar year in which a member worked 1,000 hours. Since 1998, the Plan has been amended to increase monthly pension benefits for future service as follows:

The Plan permits early retirement at age 62 and the completion of 10 years of service, whichever is later.

Upon retirement of a married member, the pension benefit payments will take the form of a joint and survivor annuity with 50% continuation, unless the member and the spouse each elect an alternate form of payment. The pension benefit received will be the actuarial equivalent to the pension benefit payable under the life annuity form.

Pension benefit payment methods are as follows:

- i. A ten-year certain and life annuity option whereby a member may elect to receive a reduced pension for as long as the employee may live with a guarantee of 120 monthly payments; if the employee should die within 10 years after retiring, the balance of the guaranteed payments will be paid to the beneficiary; or
- ii. A contingent annuity option which provides a lifetime of income to a beneficiary. It provides the member with a reduced lifetime pension, commencing at retirement date, with 100%, 75%, 66-2/3% or 50% of the monthly payments continuing after death to the named contingent annuitant; or
- iii. A Social Security adjustment annuity option for early retirement providing for pension benefits which are larger prior to the commencement of Social Security payments; or
- iv. A lump-sum payment for those participants who have terminated their employment and whose balance of vested actuarial present value of accumulated plan benefits is less than \$5,000.

Death and Disability Benefits

There is no death benefit under the Plan for an unmarried employee. If an employee has been married to his or her present spouse for at least one year and the employee dies within the period in which early retirement could have been elected, a pension benefit will become payable to the spouse equal to 50% of the monthly pension benefit that would have been payable had early retirement been elected on the date of death.

A participant whose employment is terminated because of total and permanent disability will be eligible to receive annual disability benefits equal to the normal retirement benefits which accumulated as of the date of termination.

Vesting

Effective December 31, 2010, participants became fully vested in accrued benefits credited to them through that date.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The Plan changed its basis of accounting subsequent to December 31, 2022 from the going concern basis to the liquidation basis.

The Plan adopted Accounting Standards Update ("ASU") No. 2013-07, *Presentation of Financial Statements (Topic 205) – The Liquidation Basis of Accounting*. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets in liquidation available for benefits.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Note 3 Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Benefits for all participants or beneficiaries who have been or could have been receiving benefits during the three-year period just before termination of the Plan. The benefits will depend upon the Plan provisions during the five years prior to the termination of the Plan.
- c. Other vested benefits insured by the Pension Benefit Guaranty Corporation ("PBGC") (a U.S. governmental agency) up to the applicable limitations.
- d. All other vested benefits (that is, vested benefits not insured by the PBGC).
- e. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

On August 11, 2023, the Plan Sponsor adopted a plan amendment to terminate the Plan effective July 31, 2023.

Note 3 Plan Termination (continued)

On November 29, 2023, in connection with the termination of the Plan, the Plan Sponsor adopted the following amendments effective February 1, 2024:

- a. One lump-sum payment in cash available to actively employed participants and terminated vested participants between the window of February 1, 2024 to until participants affirmatively elect a lump sum or immediate annuity, or until a group annuity is purchased equal to the present value of the normal retirement. The present value is based on the Applicable Mortality Table & Applicable Interest Rate as set forth in Section 1.3 of the Plan. However, this lump sum option would not be available after the point a participant selects a deferred or immediate annuity option upon Plan termination.
- b. Retirement date is amended to mean the date as of which a participant retires whether such retirement occurs on a participant's normal retirement date, early or late retirement date.
- c. As a result of the Plan's termination, annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- d. No disability benefits, other than those payable upon termination of employment, will be provided by the Plan.

In connection with the Plan termination, the Plan Sponsor entered into a group annuity contract with an insurance company for the annuity payment of participants effective May 30, 2024. The Plan paid the insurance company the amount of \$4,718,316 in 2024 in connection with the group annuity contract.

In August 2024, the Plan paid the PBGC the amount of \$530,701 which represents the total benefits of missing participants under the PBGC's Missing Participants Program.

Note 4 Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4 Fair Value Measurement (continued)

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

- *Pooled Separate Accounts* – For investments in pooled separate accounts, fair values of the underlying mutual funds are based on publicly quoted market pricing inputs (Level 2) and are used in determining the net asset value (NAV) of the pooled separate account, which is not publicly quoted.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 5 Tax Status

Effective January 1, 2020, the Plan was amended and restated based on Volume Submitter Defined Benefit Plan of FIS Business Systems LLC, which received an opinion letter from the IRS dated March 30, 2018 stating that the Volume Submitter Defined Benefit Plan was designed in accordance with the provisions of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes due from the Plan has been included in the Plan's financial statements.

The Plan received a favorable determination letter from the IRS dated March 21, 2024 stating that the termination of the Plan does not affect its qualification for federal tax purposes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

Note 6 Information Prepared and Certified by the Plan's Trustee

The following is a summary of the investment information regarding the Plan as of and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements that was prepared or derived from information provided by Lincoln Life and Annuity Company of New York, the Trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Trustee that such information is complete and accurate.

Note 7 Guaranteed Investment Contract with Insurance Company

The Plan entered into a benefit-responsive guaranteed investment contract with Lincoln Life and Annuity Company of New York (Lincoln) in relation to the Guaranteed Stable Value Account. Lincoln maintains the respective participant-directed contributions in a general account. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate, as shown on the contract specifications.

The interest crediting rate is declared on a quarterly basis. The contract amount maintained in the Guaranteed Stable Value Account is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on Lincoln's ability to meet its financial obligations from general assets. The Guaranteed Stable Value Account could limit the ability of the Plan to initiate or complete a transaction at contract value and could result in an adjustment to the net asset value. The contract value of the investment contract as of December 31, 2024 and 2023 was \$0 and \$1,925,553, respectively.

Note 8 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 9 Party-In-Interest Transactions

Certain Plan investments are managed by Lincoln Life and Annuity Company of New York, the Trustee, and therefore, these investment transactions qualify as party-in-interest transactions under ERISA.

Note 10 Subsequent Events

The Plan's management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
