Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Chromalloy 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan summary for a comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan in which contributions are made by employees and may be partially matched by Chromalloy Corporation (the “Company”). All non-collectively bargained employees of the Company and its participating affiliates become eligible to participate in the Plan after attaining age 18. Eligibility for collectively bargained employees is determined by the collective bargaining agreement (“CBA”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Participants may elect to reduce their eligible compensation by any whole percentage amount between 1% and 40% and have this amount deposited as pre-tax contributions into the investment funds selected by the participant. Effective January 2, 2024, participants may also elect Roth after-tax contributions. In accordance with the Internal Revenue Code (“IRC”), participants could not make contributions exceeding \$23,000 and \$22,500 for 2024 and 2023, respectively. In order to satisfy the necessary nondiscrimination tests required under ERISA and related regulations, certain participants designated as highly compensated employees may be limited in the amount of their pretax contributions. For any participant, the annual addition to the Plan (participant plus employer contribution) may not exceed the lesser of 100% of the participant’s compensation or \$69,000 in 2024 and \$66,000 in 2023. The Plan allows for catch-up contributions for participants age 50 or older as permitted by the provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001. Catch-up contributions were limited to \$7,500 for 2024 and 2023. The Company provides an enhanced Safe Harbor Match plan design to match 100% up to the first 3% of employee contributions, then match 50% on the next 2% of employee contributions (with a 4% maximum). These matching contributions are called “Safe Harbor Matching Contributions.” The amount of Company match for employees covered by a CBA is determined by the CBA. Employees covered under a CBA may receive profit sharing and/or transition contributions as outlined in the CBA.

Vesting

All participants are fully vested in all sources of contributions at all times.

Payment of Benefits

Participants are entitled to their vested account balance after age 59 ½, upon retirement at or after age 65, upon death, upon termination of employment, or upon permanent/total disability. Participants may elect to receive a lump sum payment, a direct rollover to an Individual Retirement Account or other qualified plan or an annuity. Participants may also choose to defer receipt of their benefits if their vested account balance is greater than \$5,000. Terminated participants with vested account balances between \$1,001 and \$5,000 who do not elect to receive a distribution of their account balance within a reasonable time following the termination will have their account rolled into a Vanguard Individual Retirement Account. Terminated participants with vested account balances of \$1,000 or less who do not elect to receive a distribution of their account balance will have their account balance automatically cashed out.

Hardship withdrawals are permitted if certain conditions are met.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, if any, and (b) Plan earnings, and may be charged with his or her withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Any Company contributions are invested in the same allocation as the participant's contributions.

Notes Receivable from Participants

Notes receivable from participants are permitted in accordance with the loan provisions in the Plan. Eligible participants can borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid through payroll deductions. Upon termination of employment, the participant may either repay any outstanding balance in full or incur a tax liability on the unpaid balance. At December 31, 2024 and 2023, there were outstanding notes receivable from participants bearing interest rates ranging from 4.25% to 9.50% with maturities from 2025 through 2039 and 4.25% to 9.50% with maturities from 2024 through 2037, respectively.

Forfeited Amounts

At December 31, 2024 and 2023, forfeited nonvested amounts totaled \$5,561 and \$220,884, respectively. In 2024, the forfeited amount used to pay administrative expenses was \$219,670.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, provided that such action results in the distribution of Plan assets and income thereon (after payment of Plan expenses) exclusively to active and terminated vested participants. In the event of Plan termination, participants' vesting would not be impacted since they are already 100% vested in their accounts.

Plan Administration

The Company is the Plan administrator (as defined in the Plan) and has appointed an employee benefit plans administrative committee to carry out certain actions of the Plan administrator's responsibilities. Vanguard Fiduciary Trust Company ("Vanguard") is the trustee, investment manager and record keeper for the Plan. It is intended that participants direct the investment of their accounts in accordance with Section 404(c) of ERISA.

Certain expenses of administering the Plan are paid by the Company and others are paid by the participant. Certain of these expenses paid by the participants may include recordkeeping, managed account, and loan expenses. Investment management expenses are paid by the respective investment fund and are included in net appreciation in fair value of investments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles ("U.S. GAAP").

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 7).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's realized gains (losses) and changes in unrealized gain (loss) on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosures of contingent assets and liabilities. These estimates and assumptions are based on management's best estimate and judgment. Management evaluates its estimates and assumptions on an ongoing basis using historical experience and other factors, including consideration of the current economic environment. Management adjusts such estimates when facts and circumstances dictate. As future events and their effects cannot be determined with precision, actual results may differ from those estimates and assumptions.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market risk, including global events. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 4 - TAX STATUS

The IRS issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended and restated since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or de-recognition of an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor’s regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are shares of a collective trust fund managed by Vanguard and mutual funds managed by an affiliate of Vanguard. Vanguard is the Plan’s trustee and, therefore, transactions with these funds qualify as party-in-interest.

Vanguard earns management fees, which are paid by the individual mutual funds and are reflected in the net appreciation in fair value of investments. These along with direct expenses paid for by the Plan qualify as party-in-interest transactions. Also, notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (trustee of the Plan).

NOTE 7 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurements and Disclosures*, defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair value of participation units held in a collective trust are based on the net asset values reported by the fund manager as of the financial statement date and recent transaction prices.

The Plan does not have any contractual obligation to further invest in any individual collective trusts. However, there are restrictions as to the redemption of the collective trust; there is an option for the Retirement Savings Trust to exercise a 12 month put (or unwinding) if the Company wanted to move out of the fund at the plan level and participants are restricted from moving directly into a "competing" fund (funds with short term durations such as money market or short-term bond funds). Participants cannot move money from the Plan's stable value fund to an investment option that is considered a competing investment option. Before participants can move money from the stable value fund to a competing investment option, they must place the money in a noncompeting investment option for 90 days. Then the participant may move the money to the competing investment option.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
