1. Description of Plan

The following description of the Batson-Cook Company 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of Batson-Cook Company and its affiliated companies (collectively, the Company) who have completed 3 months of service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on November 1, 1955.

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 60% of eligible compensation, as defined by the Plan document, not to exceed a maximum of \$23,000 for 2024, plus an additional \$7,500 catch-up deferral for participants age 50 and over. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Upon satisfying the eligibility requirements, employees are automatically enrolled in the Plan at 1% of eligible compensation, unless the employee elects otherwise. The automatic contribution rate will increase by 1% each July 1 up to a maximum of 6% of eligible compensation unless the employee elects otherwise. The automatic enrollment feature and contribution rate increase is not applicable for employees hired or rehired prior to November 1, 2018.

Matching contributions may be made at the discretion of the Company. During 2024, the Company made matching contributions equal to 50% of the first 6% of eligible compensation contributed by the participant.

The Company may also make non-elective contributions to the Plan to those participants who have completed at least 1,000 hours of service during the Plan year and are employed with the Company as of the end of the Plan year, or otherwise specified by the plan administrator. During 2024, there were no non-elective contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account and is charged with transaction fees for services received by the participant. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions and Company discretionary matching contributions plus earnings and losses thereon. Participants vest ratably in the Company's non-elective contributions and are 100% vested after three years of service, or upon the occurrence of total or permanent disability or death.

Payment of Benefits

At the time of death, disability, attainment of age 59½, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution or partial withdrawals. The participant's vested balance may also be withdrawn for certain hardship situations. Vested account balances less than \$7,000 may be automatically distributed without participant consent upon termination of service.

Forfeited Accounts

Forfeited non-vested account balances totaled \$4,000 and \$4,250 as of December 31, 2024 and 2023, respectively. These accounts may be used to pay administrative expenses or to reduce Company contributions. In 2024, forfeitures were not used to pay administrative expenses or used to reduce Company contributions.

Administrative Expenses

Certain account activity charges are paid from the accounts of the participant that incurred the charge. The Plan document permits certain administrative expenses to be paid by the Plan. These expenses related to recordkeeping services and investment advisory services that are paid to a service provider of the Plan qualify for party-in-interest transactions. Although it is not required to do so, certain expenses incidental to the administration of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and after approval by the Retirement Benefits Committee. The Company non-elective contributions are considered payable to the Plan after approval by the Retirement Benefits Committee. Any unfunded participant or Company contributions are included as a participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments.

Notes Receivable from Participants

The Plan does not allow for the issuance of new notes receivable from participants

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net change in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Plan's qualified institution.

4. Investments and Fair Value Measurements

Certain Plan investments include mutual funds and a money market fund managed by Fidelity. Fidelity is the qualified institution of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services and administrative services on those investments are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to several risks, such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are valued at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund held in a common collective trust that can be traded daily at its net asset value (NAV). The stable value fund invests in guaranteed investment contracts (GICs) and synthetic GICs, which are valued at contract value, as well as other investments which are carried at fair value (Level 1).

The stable value fund has redemption restrictions that limit the timing of withdrawals. Participant directed withdrawals may be made at any time. Transferred amounts must hold a non-competing investment option for 90 days before funds may be transferred to a competing fund. In addition, the trustee of the stable value fund reserves the right to require up to twelve months' advance notice for withdrawals directed by the Company.

6. Income Tax Status

In May 2021, the Plan that was based on a Volume Submitter Profit Sharing Plan with CODA (volume submitter plan) sponsored by Fidelity Management & Research Co. (FMRC) moved to a Non-Standardized PreApproved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC (doing business as Fidelity Institutional Asset Management), an affiliate of Fidelity. The Internal Revenue Service has opined and informed FMR LLC by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt and has no income subject to unrelated business income tax. The Plan's returns for the past three years are subject to examination by taxing authorities and may change upon examination.

1. Description of Plan

The following description of the Batson-Cook Company 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of Batson-Cook Company and its affiliated companies (collectively, the Company) who have completed 3 months of service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on November 1, 1955.

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 60% of eligible compensation, as defined by the Plan document, not to exceed a maximum of \$23,000 for 2024, plus an additional \$7,500 catch-up deferral for participants age 50 and over. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Upon satisfying the eligibility requirements, employees are automatically enrolled in the Plan at 1% of eligible compensation, unless the employee elects otherwise. The automatic contribution rate will increase by 1% each July 1 up to a maximum of 6% of eligible compensation unless the employee elects otherwise. The automatic enrollment feature and contribution rate increase is not applicable for employees hired or rehired prior to November 1, 2018.

Matching contributions may be made at the discretion of the Company. During 2024, the Company made matching contributions equal to 50% of the first 6% of eligible compensation contributed by the participant.

The Company may also make non-elective contributions to the Plan to those participants who have completed at least 1,000 hours of service during the Plan year and are employed with the Company as of the end of the Plan year, or otherwise specified by the plan administrator. During 2024, there were no non-elective contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account and is charged with transaction fees for services received by the participant. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions and Company discretionary matching contributions plus earnings and losses thereon. Participants vest ratably in the Company's non-elective contributions and are 100% vested after three years of service, or upon the occurrence of total or permanent disability or death.

Payment of Benefits

At the time of death, disability, attainment of age 59½, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution or partial withdrawals. The participant's vested balance may also be withdrawn for certain hardship situations. Vested account balances less than \$7,000 may be automatically distributed without participant consent upon termination of service.

Forfeited Accounts

Forfeited non-vested account balances totaled \$4,000 and \$4,250 as of December 31, 2024 and 2023, respectively. These accounts may be used to pay administrative expenses or to reduce Company contributions. In 2024, forfeitures were not used to pay administrative expenses or used to reduce Company contributions.

Administrative Expenses

Certain account activity charges are paid from the accounts of the participant that incurred the charge. The Plan document permits certain administrative expenses to be paid by the Plan. These expenses related to recordkeeping services and investment advisory services that are paid to a service provider of the Plan qualify for party-in-interest transactions. Although it is not required to do so, certain expenses incidental to the administration of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and after approval by the Retirement Benefits Committee. The Company non-elective contributions are considered payable to the Plan after approval by the Retirement Benefits Committee. Any unfunded participant or Company contributions are included as a participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments.

Notes Receivable from Participants

The Plan does not allow for the issuance of new notes receivable from participants

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net change in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Plan's qualified institution.

4. Investments and Fair Value Measurements

Certain Plan investments include mutual funds and a money market fund managed by Fidelity. Fidelity is the qualified institution of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services and administrative services on those investments are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to several risks, such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are valued at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund held in a common collective trust that can be traded daily at its net asset value (NAV). The stable value fund invests in guaranteed investment contracts (GICs) and synthetic GICs, which are valued at contract value, as well as other investments which are carried at fair value (Level 1).

The stable value fund has redemption restrictions that limit the timing of withdrawals. Participant directed withdrawals may be made at any time. Transferred amounts must hold a non-competing investment option for 90 days before funds may be transferred to a competing fund. In addition, the trustee of the stable value fund reserves the right to require up to twelve months' advance notice for withdrawals directed by the Company.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their Company contributions.

6. Income Tax Status

In May 2021, the Plan that was based on a Volume Submitter Profit Sharing Plan with CODA (volume submitter plan) sponsored by Fidelity Management & Research Co. (FMRC) moved to a Non-Standardized PreApproved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC (doing business as Fidelity Institutional Asset Management), an affiliate of Fidelity. The Internal Revenue Service has opined and informed FMR LLC by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt and has no income subject to unrelated business income tax. The Plan's returns for the past three years are subject to examination by taxing authorities and may change upon examination.
