## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the  
PipeLife Jet Stream, Inc. Retirement and 401(k) Plan  
Siloam Springs, Arkansas

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PipeLife Jet Stream, Inc. Retirement and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

PipeLife Jet Stream, Inc. (the “Company”) established the PipeLife Jet Stream, Inc. Retirement and 401(k) Plan (the “Plan”) on May 17, 2000. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees (other than leased and reclassified employees) of the Company who have at least six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, and in accordance with applicable sections of the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a stable value account option as investments for participants. The Company makes safe-harbor contributions each Plan year equal to 100% on the first five percent of each participant’s eligible compensation. The Company may also make a discretionary matching contribution each Plan year to participants equal to four percent of eligible compensation. No additional matching contributions were made for the years ended December 31, 2024, and 2023. Contributions are subject to certain limitations. The Company may also make additional profit-sharing contributions at the discretion of the Company’s Board of Directors. To be eligible for-profit sharing contributions, participants must be employed on the last day of the Plan year, unless due to death, disability, or retirement. Allocations are based on the proportion of each participant’s compensation to the total of all participants’ eligible compensation. During the years ended December 31, 2024, and 2023, the Company made profit sharing contributions totaling \$0 and \$486,539, respectively.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s contributions and Plan earnings. Each participant’s account is also charged with an allocation of administrative expenses (if paid by the Plan’s Trust). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their own contributions, plus actual earnings thereon, and their employer safe-harbor contributions. Vesting in the Company’s discretionary contribution and profit-sharing portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in their account after five years of credited service.

**Forfeited Accounts**

Forfeitures may be used to pay administrative expenses of the Plan, be reallocated as additional profit-sharing contributions, or to offset employer contributions. Unallocated forfeitures were \$78,728 and \$37,860 as of December 31, 2024 and 2023, respectively. During 2024 and 2023, \$39,749 and \$0, respectively, were used to offset employer contributions or reallocated as additional profit-sharing contributions.

**Payment of Benefits**

Upon termination of service, due to termination, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account balance or annual installments from the Plan. Participants may also delay distributions of their vested balance until the age of 72. Participants with a vested account balance of \$5,000 or less may not postpone their distribution until a later date. The Company may distribute the vested balance as a lump-sum to the participant without the participant's consent. There were no benefits payable to participants as of December 31, 2024 and 2023.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company.

**Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued based on quoted net asset value (NAV) of the shares held by the Plan at year-end.

*Stable Value Account:* Valued at the NAV, which is considered a practical expedient for fair value, by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Redemptions are available with a twelve month notice period. Additionally, there were no unfunded commitments as of December 31, 2024 and 2023.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - SETTING EVERY COMMUNITY UP FOR RETIREMENT ENHANCEMENT ACT (SECURE 2.0)**

In December 2022 SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in 2025 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

**NOTE 5 - RELATED-PARTY TRANSACTIONS**

A majority of Plan expenses are absorbed by the Company. Certain transaction-based expenses were deducted from participants' accounts by the recordkeeper. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for these expenses amounted to \$12,176 and \$5,174 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7 - TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
