Notes to Financial Statements

Note 1. Description of Plan

The following description of the Naterra International, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Naterra International, Inc. and Beauty Manufacturing Solutions, Inc. (the Employers) who are a minimum of twenty-one years of age and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended effective January 1, 2023 to exclude bonuses from eligible compensation and to modify the compensation rules for the first year of participation to remove matching employer contributions – other than 401(k) safe harbor matching employer contributions.

The Plan was amended effective July 22, 2024 to allow eligible employees to designate a portion or all deferral contributions to a Roth 401(k).

Contributions

Participating employees may contribute, through payroll deductions up to 90 percent of their eligible compensation up to a maximum as defined in the Internal Revenue Code, as deferred contributions. Effective January 1, 1997, the Plan is operating under a deferral election. The entry date to the plan shall be the first date of each month during the plan year in which the employee has been employed for one month. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Employers make matching safe harbor contributions equal to 100 percent of the employee's salary deferral contributions up to the first 4 percent of their eligible compensation. In addition, as of each Plan year-end, the Employers may make a special discretionary contribution equal to a certain percentage of employee compensation. No special discretionary contribution was made or declared for the year ended December 31, 2024 and 2023. Each participant's share is based on the ratio of their compensation to the total compensation for all participants. For a participant to qualify for a matching safe harbor contribution and special discretionary contribution, the participant must be employed on any day of the plan year.

At the discretion of the Plan Administrator, the participant may be permitted to deposit or rollover into the Plan, assets he or she has received from other plans. The rollovers will be placed in the participant's account based upon their election allocations in the Plan enrollment form, which would be 100 percent vested. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of Plan earnings and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Safe harbor employer matching contributions vest immediately. Vesting of special discretionary employer contributions in the participant's account is determined under the following schedule, based on years of credited service.

Years of Credited Service	Vested Percentage
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

However, the participant will always be 100 percent vested upon the normal retirement age, disability, or death. Regardless of this vesting schedule, participants will be 100 percent vested in their own contributions to the Plan.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of the non-forfeitable account balance. All notes must be a minimum of \$1,000. All notes must have a definite repayment period which range up to 60 months, and participants may have up to three outstanding notes at a time. The notes are collateralized by the balance in the participant's accounts and bear a reasonable rate of interest based on prevailing market conditions.

Payment of Benefits

Participants are entitled to receive their benefits under the Plan in the event of retirement, termination of employment, disability, or death. At the time a participant is entitled to receive a distribution under the Plan, the plan administrator will direct the trustee to pay the benefits in either one lump sum or, if elected by the participant and the vested account balance exceeds \$5,000, in installment payments. For termination of service due to other reasons, a participant may receive the value of the vested account balance as a lump sum distribution or rollover. The Plan increased the cash out level to \$7,000 on July 22, 2024 as part of provisions of SECURE2.0.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited amounts are used to pay Plan expenses first and then to offset Employers contributions to the Plan. \$0 and \$0 of forfeitures were used to pay plan expenses or to offset employer contributions for the years ended December 31, 2024 and 2023, respectively. Unallocated forfeitures as of December 31, 2024 and 2023 were \$12,046 and \$11,232, respectively.

Note 2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest is allocated to participant accounts on a pro-rata basis depending on the participant's account balance. Dividends are allocated based on the number of shares in a participant's account.

Contributions

Contributions from Plan participants and the matching contributions from the company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Plan Management's Review of Subsequent Events

The Plan administrator has evaluated all events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4. Fair Value Measurement

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Note 5. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and Fidelity Workplace Services is the record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions. After provisions for the expenses of administration, the proportionate interests will be distributed to the participants.

Note 7. Tax Status

Effective May 25, 2021, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section (IRC) 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Naterra International, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Naterra International, Inc. and Beauty Manufacturing Solutions, Inc. (the Employers) who are a minimum of twenty-one years of age and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended effective January 1, 2023 to exclude bonuses from eligible compensation and to modify the compensation rules for the first year of participation to remove matching employer contributions – other than 401(k) safe harbor matching employer contributions.

The Plan was amended effective July 22, 2024 to allow eligible employees to designate a portion or all deferral contributions to a Roth 401(k).

Contributions

Participating employees may contribute, through payroll deductions up to 90 percent of their eligible compensation up to a maximum as defined in the Internal Revenue Code, as deferred contributions. Effective January 1, 1997, the Plan is operating under a deferral election. The entry date to the plan shall be the first date of each month during the plan year in which the employee has been employed for one month. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Employers make matching safe harbor contributions equal to 100 percent of the employee's salary deferral contributions up to the first 4 percent of their eligible compensation. In addition, as of each Plan year-end, the Employers may make a special discretionary contribution equal to a certain percentage of employee compensation. No special discretionary contribution was made or declared for the year ended December 31, 2024 and 2023. Each participant's share is based on the ratio of their compensation to the total compensation for all participants. For a participant to qualify for a matching safe harbor contribution and special discretionary contribution, the participant must be employed on any day of the plan year.

At the discretion of the Plan Administrator, the participant may be permitted to deposit or rollover into the Plan, assets he or she has received from other plans. The rollovers will be placed in the participant's account based upon their election allocations in the Plan enrollment form, which would be 100 percent vested. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of Plan earnings and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Safe harbor employer matching contributions vest immediately. Vesting of special discretionary employer contributions in the participant's account is determined under the following schedule, based on years of credited service.

<u>Years of Credited Service</u>	<u>Vested Percentage</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

However, the participant will always be 100 percent vested upon the normal retirement age, disability, or death. Regardless of this vesting schedule, participants will be 100 percent vested in their own contributions to the Plan.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of the non-forfeitable account balance. All notes must be a minimum of \$1,000. All notes must have a definite repayment period which range up to 60 months, and participants may have up to three outstanding notes at a time. The notes are collateralized by the balance in the participant's accounts and bear a reasonable rate of interest based on prevailing market conditions.

Payment of Benefits

Participants are entitled to receive their benefits under the Plan in the event of retirement, termination of employment, disability, or death. At the time a participant is entitled to receive a distribution under the Plan, the plan administrator will direct the trustee to pay the benefits in either one lump sum or, if elected by the participant and the vested account balance exceeds \$5,000, in installment payments. For termination of service due to other reasons, a participant may receive the value of the vested account balance as a lump sum distribution or rollover. The Plan increased the cash out level to \$7,000 on July 22, 2024 as part of provisions of SECURE2.0.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited amounts are used to pay Plan expenses first and then to offset Employers contributions to the Plan. \$0 and \$0 of forfeitures were used to pay plan expenses or to offset employer contributions for the years ended December 31, 2024 and 2023, respectively. Unallocated forfeitures as of December 31, 2024 and 2023 were \$12,046 and \$11,232, respectively.

Note 2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest is allocated to participant accounts on a pro-rata basis depending on the participant's account balance. Dividends are allocated based on the number of shares in a participant's account.

Contributions

Contributions from Plan participants and the matching contributions from the company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Plan Management's Review of Subsequent Events

The Plan administrator has evaluated all events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4. Fair Value Measurement

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Note 5. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and Fidelity Workplace Services is the record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions. After provisions for the expenses of administration, the proportionate interests will be distributed to the participants.

Note 7. Tax Status

Effective May 25, 2021, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section (IRC) 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

We have performed an audit of the financial statements of Naterra International, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Naterra International, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Naterra International, Inc. and Beauty Manufacturing Solutions, Inc. (the Employers) who are a minimum of twenty-one years of age and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended effective January 1, 2023 to exclude bonuses from eligible compensation and to modify the compensation rules for the first year of participation to remove matching employer contributions – other than 401(k) safe harbor matching employer contributions.

The Plan was amended effective July 22, 2024 to allow eligible employees to designate a portion or all deferral contributions to a Roth 401(k).

Contributions

Participating employees may contribute, through payroll deductions up to 90 percent of their eligible compensation up to a maximum as defined in the Internal Revenue Code, as deferred contributions. Effective January 1, 1997, the Plan is operating under a deferral election. The entry date to the plan shall be the first date of each month during the plan year in which the employee has been employed for one month. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Employers make matching safe harbor contributions equal to 100 percent of the employee's salary deferral contributions up to the first 4 percent of their eligible compensation. In addition, as of each Plan year-end, the Employers may make a special discretionary contribution equal to a certain percentage of employee compensation. No special discretionary contribution was made or declared for the year ended December 31, 2024 and 2023. Each participant's share is based on the ratio of their compensation to the total compensation for all participants. For a participant to qualify for a matching safe harbor contribution and special discretionary contribution, the participant must be employed on any day of the plan year.

At the discretion of the Plan Administrator, the participant may be permitted to deposit or rollover into the Plan, assets he or she has received from other plans. The rollovers will be placed in the participant's account based upon their election allocations in the Plan enrollment form, which would be 100 percent vested. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of Plan earnings and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Safe harbor employer matching contributions vest immediately. Vesting of special discretionary employer contributions in the participant's account is determined under the following schedule, based on years of credited service.

<u>Years of Credited Service</u>	<u>Vested Percentage</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

However, the participant will always be 100 percent vested upon the normal retirement age, disability, or death. Regardless of this vesting schedule, participants will be 100 percent vested in their own contributions to the Plan.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of the non-forfeitable account balance. All notes must be a minimum of \$1,000. All notes must have a definite repayment period which range up to 60 months, and participants may have up to three outstanding notes at a time. The notes are collateralized by the balance in the participant's accounts and bear a reasonable rate of interest based on prevailing market conditions.

Payment of Benefits

Participants are entitled to receive their benefits under the Plan in the event of retirement, termination of employment, disability, or death. At the time a participant is entitled to receive a distribution under the Plan, the plan administrator will direct the trustee to pay the benefits in either one lump sum or, if elected by the participant and the vested account balance exceeds \$5,000, in installment payments. For termination of service due to other reasons, a participant may receive the value of the vested account balance as a lump sum distribution or rollover. The Plan increased the cash out level to \$7,000 on July 22, 2024 as part of provisions of SECURE2.0.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited amounts are used to pay Plan expenses first and then to offset Employers contributions to the Plan. \$0 and \$0 of forfeitures were used to pay plan expenses or to offset employer contributions for the years ended December 31, 2024 and 2023, respectively. Unallocated forfeitures as of December 31, 2024 and 2023 were \$12,046 and \$11,232, respectively.

Note 2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest is allocated to participant accounts on a pro-rata basis depending on the participant's account balance. Dividends are allocated based on the number of shares in a participant's account.

Contributions

Contributions from Plan participants and the matching contributions from the company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Plan Management's Review of Subsequent Events

The Plan administrator has evaluated all events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4. Fair Value Measurement

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Note 5. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and Fidelity Workplace Services is the record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions. After provisions for the expenses of administration, the proportionate interests will be distributed to the participants.

Note 7. Tax Status

Effective May 25, 2021, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section (IRC) 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
