### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Klover Companies Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### (1) Description of Plan

The following description of The Klover Companies Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all full-time employees of Klover SEPA, Inc. (the Plan sponsor or the Company), except employees who are covered by a collective bargaining agreement, non-resident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Management of the Company is responsible for the oversight of the Plan. Management also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### ***Eligibility***

For all contribution sources eligibility requires the employee to attain the age of 18. For employer profit sharing contributions, participants are also required to complete twelve consecutive months and 1,000 hours of service, as defined in the plan document. Upon satisfying the eligibility requirements, the employee will become eligible to participate in the Plan on the first day of the calendar month after such eligibility requirements are met, except for prevailing wage contributions which an employee is immediately eligible to participate in.

#### ***Contributions***

Each year, participants may defer a percentage of annual compensation (pre-tax and Roth), as defined by the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with a 3% pre-tax deferral rate unless they affirmatively elect not to participate in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes an annual safe harbor contribution of 3% of participant wages as defined by the Plan. The Company also makes quarterly employer contributions according to prevailing wage schedules that apply to particular public contracts subject to the Davis-Bacon Act or other federal, state, or municipal prevailing wage law, upon which employees work during the plan year. The prevailing wage contributions will reduce any other employer contributions. Other employer profit sharing and qualified non-elective contributions may be made to the Plan by the Company.

### (1) Description of Plan, Continued

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Company safe harbor contributions, and Company prevailing wage contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately 100% vested in their contributions, the Company's safe harbor contributions, and the Company's prevailing wage contributions, plus actual earnings thereon. Vesting in employer discretionary profit sharing contributions and earnings thereon is based on years of service. A participant becomes 100% vested after 3 years of service based on a cliff vesting schedule. A participant becomes immediately 100% vested on all contribution sources in the event of death, permanent disability, or attainment of early retirement age while an active employee.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are limited to the vested interest in the elective contribution and rollover accounts. Loan terms range from one to five years or longer for a loan used to acquire a principal residence. The loans are secured by the balance in the participants' accounts and bear interest at rates ranging from 6.50% to 9.50%. The loan interest rate is set at 1% above the prime rate, as defined, which remains fixed through the term of the loan. Principal and interest are paid ratably through payroll deductions.

#### *Payment of Benefits*

Upon termination of service due to death or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period. Participants who become disabled as defined in the Plan will receive 100% of their account balance.

For termination of service due to other reasons, a participant may receive the value of elective deferrals as a lump-sum distribution immediately and may receive their value of the vested interest in employer contributions upon reaching 55 years of age. The Plan permits in-service withdrawals of salary deferrals after a participant reaches age 59.5.

#### *Forfeited Accounts*

If a participant terminates employment prior to becoming fully vested, the non-vested portion of the participant's account is forfeited at such time defined in the plan document. These accounts may be used to reduce future employer contributions or satisfy fees incurred by the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,092 and \$2,942, respectfully. There were no forfeitures used in 2024.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the plan trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Contributions*

Contributions from plan participants and the matching and prevailing wage contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### (2) Summary of Significant Accounting Policies, Continued

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### *Subsequent Events*

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### (3) Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and investments at contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company FSB (Nationwide) and Ascensus Trust Company (Ascensus), the qualified institutions.

Certain information related to notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including notes receivable from participants held at December 31, 2024, and interest income on notes receivable from participants from the period of October 18, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, a qualified institution.

Nationwide held the Plan's investment assets as of December 31, 2023 and executed investment transactions for the period January 1, 2024 to October 17, 2024. Ascensus held the Plan's investment assets as December 31, 2024 and executed investment transactions for the period of October 18, 2024 to December 31, 2024.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

There were no significant transfers among investment levels during the years ended December 31, 2024 and 2023.

#### (5) Fixed Investment Contract with Nationwide

The Plan had a traditional fully benefit-responsive guaranteed investment contract (GIC) with Nationwide Life Insurance Company, maintained in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. Participant investments in the GIC totaled \$217,880 at December 31, 2023.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Nationwide, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment contract at contract value.

As of October 17, 2024, the GIC with Nationwide Life Insurance Company was terminated and fully liquidated. Proceeds from the liquidation were transferred to Ascensus.

### (6) Related Party Transactions and Party-in-Interest Transactions

For the period of January 1, 2024 to October 17, 2024, certain plan investments were registered investment companies and a guaranteed investment contract managed by Nationwide and its affiliates. Nationwide was also the Plan trustee; therefore, transactions related to these investments qualified as party-in-interest transactions, which were exempt under the prohibited transaction rules.

Ascensus became the Plan trustee effective October 18, 2024. The Vanguard Group, Inc. (Vanguard) has retained Ascensus, Inc., an affiliate of Ascensus, as a sub-contractor to provide certain recordkeeping and administrative services on behalf of Vanguard. Certain plan investments are registered investment companies managed by Vanguard. These transactions qualify as party-in-interest transactions. Fees paid by the Plan were \$76,957 for the year ended December 31, 2024.

### (7) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### (8) Tax Status

The Plan uses a non-standardized pre-approved plan document sponsored by Atlantic Pension Services, Inc. The non-standardized plan document received a letter from the IRS dated June 30, 2020, which states the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The prototype opinion is relied on by the Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
