Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the United Refractories Co. Thrift Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the United Refractories Co. Thrift Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of United Refractories Co. Thrift Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the United Refractories Co. Thrift Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note A - Description of Plan

General - The United Refractories Co. Thrift Savings Plan (the Plan), as restated January 1, 2021, is a defined contribution plan covering eligible employees of United Refractories Co. and Uni-Ref Inc., a participating employer (collectively, the Company). The Plan document is the governing instrument and should be referred to for a full description of the Plan and its provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees are eligible to participate in the Plan after completion of 60 days of service, with the exception of leased employees, whom are not eligible to participate in the Plan.

Employee Contributions – Participants may contribute pre-tax and Roth amounts as defined by the Plan, up to 100% of eligible compensation, in accordance with the Internal Revenue Code section 415 limits. Employees may also elect to make catch-up contributions provided they have reached age 50 by the end of the current calendar year. Participants may also contribute rollovers from other qualified plans. Effective January 1, 2021, newly eligible participants, unless electing otherwise, will be automatically enrolled in the plan at a rate of 1% of eligible compensation, which increases 1% each Plan year, up to 5% of eligible compensation. Current participants who have no salary deferral election, or who have made a salary deferral election that is less than 1%, will automatically be increased to 1%, unless they elect otherwise. Eligible compensation includes W-2 wages. All fringe benefits, reimbursements, or other expense allowances, moving expenses, deferred compensation, and welfare benefits, and deemed section 125 compensation, as defined under the terms of the Plan, are not considered eligible compensation. Eligible compensation is subject to annual limitations prescribed by the IRC.

Employer Contributions - The Company makes a Safe Harbor Matching Contribution to those participants whom are eligible to make salary deferrals in an amount equal to 100% of salary deferrals up to the first 3% of plan compensation, plus 50% of salary deferrals up to the next 2% of plan compensation. Safe Harbor Matching Contributions for the year ended December 31, 2024 amounted to \$365,561.

Participants may direct their own contributions, as well as the Company’s contributions, into any of a number of mutual funds, collective trust funds, or a fixed annuity fund maintained by Empower Trust Company, LLC.

Participant Accounts - Each participant's account is credited with the employee's and employer’s contributions, Plan earnings, and certain administrative fees, as appropriate.

Vesting - Participants are fully vested in the value of their contributions, as well as the Company’s Safe Harbor Matching Contributions, at all times. Prior to 2022, the Company made Matching Contributions and Employer Contributions which vested over time, as follows:

Forfeitures - The Plan permits the Company, at its sole discretion, to reduce its employer contributions or administrative expenses with forfeitures, which represent the unvested portion of participants’ accounts. In 2024, no forfeitures were used. There was no forfeited non-vested account balance at December 31, 2024 and 2023.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to a maximum of 50% of the vested account balance or \$50,000, whichever is less. Loans, which bear interest at a rate the plan administrator deems nondiscriminatory, are collateralized by the vested portion of the participant's account and repayments are made through payroll deductions, generally up to no longer than 5 years. Interest rates ranged from 3.25% to 9.50% at December 31, 2024 and 2023. Participant loans are considered assets of the Plan and are valued based on the unpaid principal balance plus accrued by unpaid interest.

Benefit Payments - The vested portion of individual accounts can be distributed upon the death, disability, normal retirement, early retirement, or termination for reasons other than death, disability or retirement. In-service distributions are generally available from certain accounts that are fully vested as long as the participant has attained the age of 59 ½ and the amount must be at least \$1,000. Additionally, in-service distributions are allowed from certain accounts as a qualified reservist distribution or upon a deemed separation of employment when an individual is on active duty for a period of at least 30 days while performing service in the uniformed services A participant may also withdraw money from certain accounts to satisfy certain immediate and heavy financial needs, as defined under the terms of the Plan, by means of a hardship distribution. Vested account balances that do not exceed \$5,000 may only be distributed in a single lump-sum payment. Vested account balances that exceed \$5,000 may be distributed in a single lump-sum payment or partial withdrawals or installments, but only with respect to minimum required distributions. Vested account balances that do not exceed \$5,000 may be rolled over to an IRA selected by the Company without consent.

Plan Termination - Although there is not a present intent to do so, the Company has reserved the right to terminate or partially terminate the Plan and, upon termination, all participants will become fully vested in any funds which have been allocated to them.

Note B - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

Contributions - Employee and employer contributions are recognized as additions to Plan assets in the year designated by the employee and Company, respectively.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (Note E). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans is recorded on the accrual basis. An allowance for notes receivable from participants has not been recorded as delinquent notes receivable from participants are recorded as a distribution and reduction of the participant loan balance based upon the terms of the plan document.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - The Plan permits the payment of Plan expenses to be made from the Plan's assets.

Subsequent Events - Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note C - Tax Status

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the Non-Standardized Pre-Approved Profit Sharing Plan used to set the guidelines of the Plan is qualified under Section 401 of the Internal Revenue Code (IRC), as amended, and the regulations thereunder, and the Plan is thereby tax-exempt within the meaning of Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax benefit if it is more likely than not the tax position would be sustained upon examination by the applicable authorities. The remainder of the tax position is required to be recorded as a tax liability. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed. The Plan currently has no uncertain tax positions and, therefore, no liabilities have been recorded.

Note D – Information Certified by the Custodian

For the years ended December 31, 2024 and 2023, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company, LLC, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets held at end of year as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Note E - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, “Fair Value Measurements and Disclosures,” establishes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs into three broad levels. Level 1 inputs are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are quoted prices for similar assets in active markets or inputs that are observable for the asset, either directly or indirectly through market corroboration, for substantially the full term of the asset. Level 3 inputs are unobservable and significant inputs developed by the plan sponsor based on the best information available about the assumptions market participants would use in pricing the asset. A financial asset’s classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used in measuring Plan assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Determined based upon the net asset value of shares held by the Plan and normally obtained from the National Securities Clearing Corporation, from the fund house, or a secondary pricing source, such as Interactive Data Corporation. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuities - Determined by the annuity provider and is generally based upon all contributions made by or on behalf of the participant to the fund, plus all interest credited to the fund, less any amounts transferred or distributed from the fund, less any applicable charges.

Collective Trust Funds - Determined based upon the net asset value of shares held as obtained directly from the fund house or investment provider. There are no unfunded commitments relating to these types of investments or significant restrictions on redemptions.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F - Party-in-Interest

On December 31, 2024 and 2023, the Plan's assets invested in the fixed annuity fund is maintained by Empower Trust Company, LLC. Transactions executed in this account are party-in-interest transactions. Fees paid by the Plan for third party administrative services and transactions fees totaled \$50,565 for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from the IRC and ERISA's rules on prohibited transactions.

Note G - Risks and Uncertainties

The Plan provides for various investment options into any number of mutual funds, a fixed annuity fund, or collective trust funds. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
