Note 1 - Plan Description

The following description of Gerflor USA Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Gerflor USA Inc.; Connor Sports Flooring, LLC; Stagestep Inc.; Connor Sport Court International, LLC; Snap Lock HoldCo, Inc. and Dumaplast US Inc. (collectively, the "Companies") who have completed one month of service and are age 18 or older, excluding those employees covered by a collective bargaining unit, leased employees, interns, all W2 contract employees, and nonresident aliens. Employees become participants in the Plan on the first day of the month following completion of the eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Companies match 100 percent of participant contributions on the first 3 percent of compensation deferred and 50 percent on the next 3 percent of compensation deferred in the form of employer safe harbor matching contributions. All participants who are eligible to participate in the Plan are eligible to receive employer safe harbor matching contributions.

The Plan also provides for discretionary profit-sharing contributions in an amount, if any, to be determined at the plan year end. A participant is eligible to receive the discretionary profit-sharing contribution if he or she is employed by the Companies on the last day of the year and has completed at least 12 months of service. There were no discretionary profit-sharing contributions made for 2024.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Participants are 100 percent vested in employer safe harbor matching contributions and any income or loss thereon after two years of service. Vesting discretionary contributions from the Companies, plus actual earnings thereon, are based on years of service. Participants are 0 percent vested until completion of their third year of service, at which point they become 100 percent vested. If a participant dies, becomes disabled, or reaches the normal retirement age of 65 while employed by the Companies, his or her interest in the Plan becomes 100 percent vested without regard to the vesting schedule.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account or any portion thereof. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Upon termination of service, for participants with account balances of \$5,000 or less, the plan administrator must distribute the participant's balance. If the participant does not make an election in accordance with plan guidelines, the plan administrator will distribute the participant's plan account balance as a lump sum. For participants with account balances in excess of \$5,000, no distribution will occur until a withdrawal request is made. A participant may elect to leave his or her account balance in the Plan, receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or roll over the account to another qualified plan or an IRA.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. The notes receivable are secured by the balance in the participant's account and bear interest at local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Voya Institutional Trust Company or its affiliates. Voya Institutional Trust Company is one of the trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except the fully benefit-responsive unallocated contract valued at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 6 for further discussion of the fully benefit-responsive unallocated contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Companies.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 7, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Ascensus Trust Company held the Plan's investments until November 11, 2024. As of that date, all plan investments and participant notes receivable were transferred to Voya Institutional Trust Company, who executes all related transactions. The investment and participant notes receivable balances and related income included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Ascensus, LLC, as agent for Ascensus Trust Company, and Voya Institutional Trust Company.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 5 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds and Exchange-traded Funds

Mutual funds and exchange-traded funds are valued at quoted prices reported in active markets.

Money Market Fund

Money market funds are valued at quoted prices reported in active markets.

Common Collective Trust Funds

The common collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

Note 6 - Investment Contracts

The Plan has a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.00 percent. When establishing interest crediting rates for this product, VRIAC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 7 - Subsequent Events

Subsequent to year end, the Progress Profiles America Inc 401(k) Profit Sharing Plan was merged into the Plan. Accordingly, assets of approximately \$886,000 were transferred into the Plan.
