NOTE 1 DESCRIPTION OF PLAN

The following description of the Murdock Chevrolet 401(k) Plan (the Plan) provides only general information regarding the Plan in place as of December 31, 2024. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan's original effective date was January 1, 1998. The amended and restated provisions of the Plan became effective January 1, 2021. The Plan is a single employer defined contribution plan for all full-time employees who have completed three months of service and are at least 21 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer up to 100% of their salaries or the maximum amount allowed by the IRS, whichever is less. The maximum allowed by the IRS was \$23,000 and \$22,500 (\$30,500 and \$30,000 for participants age 50 or older), for the years ended December 31, 2024 and 2023, respectively. The employer matches 50% of participants' contributions, not to exceed 3% of eligible compensation on a discretionary basis, this match was made for both of the years ending December 31, 2024 and 2023. There is also a profit sharing contribution available on a discretionary basis.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

There is no vesting for the first year of service. After the first year, participants vest 20% per year of service and are 100% vested after six years of service for the employer match contributions and earnings on the employer match. Participants are always fully vested in their elective deferrals and the earnings thereon.

Payment of Benefits

At termination or retirement, vested accounts less than \$5,000 may only be paid in a single lump-sum. For vested accounts more than \$5,000 a participant must consent to the distributions and may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, or partial withdrawals depending on the circumstances.

Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan Agreement to discontinue the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will be 100% vested and nonforfeitable.

Forfeited Accounts

The un-vested amounts forfeited by withdrawing participants are used to offset administrative expenses and reduce the employer matching contributions. For the years ended December 31, 2024 and 2023, expenses were reduced by \$14,678 and \$11,978, respectively, and employer contributions were reduced by \$56,197 and \$141,595 respectively from forfeited accounts. At year end December 31, 2023 and 2022, the forfeitures account balance was \$103,748 and \$6,437, respectively.

Plan Amendments

During the years ended December 31, 2024 and 2023 there were no Plan amendments.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Concentration of Credit Risk

The Plan maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash and cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of at least one significant unobservable input for the asset and have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurement

The Plan had \$9,247,663 and \$8,323,617 of investments in participation units held in pooled separate accounts through sub-accounts of the John Hancock Insurance Company at December 31, 2024 and 2023, respectively. The underlying securities in pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company denotes readily determinable fair value. These pooled separate accounts are classified as Level 1 in the fair value hierarchy.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation/(depreciation) in fair value of investments.

NOTE 4 INFORMATION PREPARED AND CERTIFIED BY THIRD PARTY ADMINISTRATOR

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by John Hancock Life Insurance Company.

- (1) The investment assets of the Plan.
- (2) The Plan's investment transactions and related income and loss.

NOTE 5 TAX STATUS

The Internal Revenue Service has determined and informed the third party administrator by a letter dated June 30, 2020 that the "Volume Submitter Profit Sharing Plan with CODA" is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's advisors believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the trust, which forms a part of the Plan, is exempt from federal taxes. No provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

The third party administrators charge fees for the services they provide. Administrative fees for these services were \$70,545 and \$56,782 for the years ended December 31, 2024 and 2023, respectively. These expenses were paid out of Plan assets. The Plan sponsor pays the other significant costs of the plan that are not paid out of available forfeitures. There were no administrative fees payable at year end December 31, 2024 and 2023.

Plan investments are in accounts administered by the John Hancock Life Insurance Company. John Hancock is the custodian of the Plan assets, National Benefits Services provides plan consulting, Private Advisory Group provides financial and consulting services to the Plan and K&C, CPAs provide auditing services to the Plan, therefore, these transactions qualify as party-in-interest.

NOTE 8 EXCESS CONTRIBUTION

Amounts payable to the Plan sponsor and participants totaling \$77,120 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to employee contributions of \$55,887 and a corresponding reduction to employer contributions of \$15,333. The excess employee contributions payable portion was distributed to the applicable participants prior to March 15, 2024.

NOTE 9 NONEXEMPT TRANSACTIONS

During the year ended December 31, 2024 there were unintentional delays by the Plan in submitting employee contributions of \$9,837 and employer contributions of \$4,799 (totaling \$14,636), these amounts were submitted 51 days late. Any lost gains on these Plan amounts will be paid by the Plan Sponsor and credited to the participants' accounts upon correction.

NOTE 10 RISKS AND UNCERTAINTIES

The Plan invests in pooled separate accounts. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 7, 2024, which is the date the financial statements were available to be issued.

Effective March 1, 2025 the plan assets transferred to a new record keeper, from John Hancock to Vanguard.
