### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Third Security, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Third Security, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 – Plan Description

---

The following description of the Third Security, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Third Security, LLC (the “Company”) and commonly controlled affiliates who are at least 21 years of age. The Plan does not cover collective bargaining employees or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Participants may contribute up to 90% of eligible compensation as pre-tax or Roth deferrals, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes an annual 3% safe harbor nonelective contribution. The Company may also make discretionary nonelective contributions. There were no discretionary nonelective contributions for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, an allocation of Plan earnings, and charged with an allocation of administrative fees. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions and the Company’s safe harbor contributions plus actual earnings thereon. Vesting in the Company’s discretionary nonelective contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after three years of credited service. Participants will become 100% vested upon normal retirement, death, or disability while employed by the Company.

#### *Payment of Benefits*

Upon retirement, death, disability, or termination, a participant can elect to receive installment payments or a lump-sum payment equal to the vested value of his or her account. In-service distributions are allowed, as defined by the Plan document.

#### *Administrative Costs*

Administrative expenses are paid by the Company and the Plan on a discretionary basis.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5 and \$3, respectively. These accounts will be used to pay Plan expenses or reduce employer contributions. For the year ended December 31, 2024, \$8 of forfeitures were used to pay Plan expenses. No forfeitures were used to reduce employer contributions.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Cash and Cash Equivalents*

At December 31, 2024, the Plan maintained non-interest-bearing cash of \$11,645 in a contribution account for funds received by the Trustee but not yet processed. This account is not insured by the FDIC.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures. Actual results may differ from those estimates.

### *Valuation of Investments and Income Recognition*

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Benefit Payments*

Benefits are recorded when paid.

### *Subsequent Events*

Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.

### Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The Plan is invested in the T. Rowe Price Stable Value Fund A at December 31, 2024 and 2023. This investment is composed primarily of synthetic investment contracts and is valued at the net asset value. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is a twelve month notice period if the Plan initiates a full redemption of the collective investment fund.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### **Note 4 – Investment Contract**

As of December 31, 2024 and 2023, the Plan has investments in the T. Rowe Price Stable Value Fund A which invests in investment contracts and security-backed contracts issued by insurance companies and other financial institutions. These contracts are considered to be benefit-responsive and presented at fair value. The average yields based on annualized earnings for the T. Rowe Price Stable Value Fund were 2.77% and 2.44% for the years ended December 31, 2024 and 2023, respectively. The objective of the T. Rowe Price Stable Value Fund A is to provide investors with a moderate level of stable income without principal volatility. However, there is no assurance that this objective will be achieved.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### Note 7 – Tax Status

The Plan is based on a non-standardized pre-approved profit-sharing plan sponsored by Newport Group, Inc. The Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Company has obtained the most recent favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Company believes the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.
