## INDEPENDENT AUDITOR'S REPORT

To the Trustees of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Essential Enterprise Solutions 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Essential Enterprise Solutions 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### **(1) DESCRIPTION OF PLAN**

The following description of the Essintial Enterprise Solutions 401k Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan, sponsored by Essintial Enterprise Solutions (the “Company”), is a defined contribution plan covering all employees who are 21 years old or older, except collective-bargaining employees, leased employees, non-resident aliens with no U.S. source of income, and residents of Puerto Rico. There is no minimum service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

Participants may contribute between 1% and 100% of pretax annual compensation, up to the maximum dollar amount permissible under the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute to the Plan at its discretion. In 2024, the Company provided discretionary matching contributions equal to 100% of the first 3.85% of base compensation that a participant contributes to the Plan. Employer contributions during the year ended December 31, 2024 were \$248,539. Participants may also contribute amounts representing distributions from other qualified plans.

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and rollovers and an allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with (c) certain administrative expenses and (d) allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their contributions, plus actual earnings thereon. Company matching contributions and income thereon are vested over five years, according to a graded schedule of years of credited service, as defined in the Plan.

Vesting in the Company's contributions also becomes 100% at normal retirement age, upon becoming totally disabled, or upon death.

***Forfeitures***

Forfeitures of non-vested Company contributions may be used to pay plan expenses or reduce Company contributions. Amounts available for future use as of December 31, 2024 and 2023 were \$417 and \$1,315, respectively. During the year ended December 31, 2024, \$15,906 of forfeitures were used to pay plan expenses.

***Payment of Benefits***

Benefit payments are permitted in the event of death, disability, termination of employment, or attainment of age 59½ while still employed. A participant (or participant's beneficiary in the event of death) receives an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment or in annual installments.

***Hardship Withdrawals***

Participants are generally not permitted to make in-service withdrawals from their accounts prior to the attainment of age 59½; however, the employer may authorize withdrawals from a participant's account in the event of "proven financial hardship." Hardship withdrawals are subject to specific statutory and regulatory requirements.

***Participant Loans***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within a period not to exceed five years. Loans to purchase a primary residence may be repaid over a period greater than five years as determined by the Plan administrator. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator based on regulatory guidelines.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

These financial statements of the Plan are prepared using the accrual method of accounting.

***Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

***Investment Valuation and Income***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

***Restatement***

The Company recorded an employer contribution receivable as of December 31, 2023. In 2024, management of the Company decided not to make this discretionary employer matching contribution to the Plan for the year ended December 31, 2023. The effect of this restatement decreases beginning net assets available for benefits by \$106,081. The 2023 Form 5500 did not record this contribution receivable and this restatement has no effect on the Form 5500.

### (4) FAIR VALUE MEASUREMENTS

Accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Money market funds: Valued at quoted market prices as of year-end.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value as of December 31, 2024 and 2023:

### **(5) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to amend or terminate the Plan at any time. In the event of a Plan termination, all participants are 100% vested in their accounts.

### **(6) TAX STATUS**

The Plan uses a volume submitter plan document sponsored by Professional Capital Services LLC. The Internal Revenue Service has determined and informed Professional Capital Services LLC by a letter, dated November 30, 2014, that the volume submitter plan and related trust under which it operates are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**(7) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(8) DELINQUENT PARTICIPANT CONTRIBUTIONS**

Certain participant contributions and loan repayments were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company during the 2021, 2020, 2019 and 2018 Plan years. Late remittances amounted to \$64,509, \$47,013, \$30,335, and \$19,660 for the years ended December 31, 2021, 2020, 2019, and 2018, respectively.

For the contributions not timely remitted, the Company will calculate and remit to the Plan an amount representing the earnings that the contributions would have earned if they had been deposited timely.
