Independent Auditor's Report

To the Plan Administrator of the Imperial Sugar Company Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Imperial Sugar Company Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits in liquidation for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, and the related notes to the financial statements, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets which provide benefits under the plan and certified to by qualified institutions and assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter — Plan Termination and Liquidation Basis of Accounting

As further discussed in Note G to the financial statements, the Board of Directors of the Plan approved a plan of liquidation on January 13, 2023, and management determined liquidation is imminent. As a result, the Plan used the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 (in liquidation) and the Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024 (in liquidation), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified information in the supplemental schedules related to assets which provide benefits under the plan and certified to by a qualified institution and assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

A. PLAN DESCRIPTION:

The following brief description of the Imperial Sugar Company Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined benefit, non-contributory pension plan, sponsored by United States Sugar Savannah Refinery LLC ("USSSR") (the "Company"), that, prior to plan freeze, covered substantially all non-union employees of the Company ("Imperial participant"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code ("IRC").

Effective March 31, 2003, the Plan was amended to freeze future benefit accruals for all participants. No new participants are permitted to enter the plan as of that date.

On June 21, 2012, both the Company and Savannah Foods & Industries, Inc. became wholly-owned subsidiaries of Louis Dreyfus Commodities Sugar Holdings LLC following a tender offer and merger.

Effective December 31, 2017, the Retirement Income Plan for Hourly Employees of Colonial Sugars, Inc. (the "Colonial Plan") was merged within and into the Plan. The Plan was amended to incorporate all projected benefits of the participants of the Colonial Plan and all benefit rights and features of the Colonial Plan shall continue as is. The Colonial Plan covers substantially all union employees of Imperial Savannah, LP's Colonial Sugar Refinery ("Colonial participant"), a wholly-owned subsidiary of Savannah Foods & Industries, Inc. Prior to the plan freeze, each employee of Savannah Foods & Industries, Inc. represented by the bargaining agreement was eligible to participate in the Colonial Plan after completion of one year of service in which at least 1,000 hours were worked.

Effective June 6, 2017, the Colonial Plan was amended to officially freeze all benefit accruals. No new participants were permitted to enter the plan as of that date.

Effective November 28, 2022, the USSSR purchased the assets of the Imperial Sugar Company and assumed sponsorship of the Plan at that time.

As further discussed in Note G, the Board of Directors approved a resolution to terminate the Plan and authorized the Retirement Plans Administrative Committee (the "Committee") to make any and all future decisions regarding the termination. The Committee formally amended the plan effective June 30, 2023 for the plan termination and to implement a temporary lump sum window prior to final distribution of the Plan's assets. In accordance with the Plan's termination provisions, all participants of the Plan became fully vested in their account balances as of that date. All assets of the Plan are expected to be distributed on or prior to December 31, 2025, and the Plan will cease to exist as of the date the assets are fully distributed.

Contributions and Funding Policy

The Company contributes amounts as are necessary to provide assets sufficient to meet the benefits to be paid to Plan participants. The Plan has met the minimum funding requirements of ERISA.

Benefits

An Imperial participant's normal retirement benefit is calculated using a formula taking into account a participant's years of service and average compensation, as defined by the Plan.

An Imperial participant may elect to receive their pension benefits in the form of a life annuity, a joint and survivor annuity for married persons, or 5, 10 or 15 year certain payments, based on reduction factors set forth in the Plan. A Colonial participant's normal retirement benefit is calculated using a formula taking into account a participant's years of service multiplied by a rate, as defined by the Plan.

A Colonial participant may elect to receive their pension benefits in the form of a life annuity, a joint and survivor annuity for married persons, or 10-year certain payments, based on reduction factors set forth in the Plan.

Lump sum distributions for both Imperial participants and Colonial participants are automatically paid directly to the participant or in the form of a direct rollover to an individual retirement account if the lump sum amount is less than \$5,000.

All Plan benefits are subject to the limitations prescribed by the IRC which includes provisions that limit the amount of retirement income which may be paid to an individual participant.

Death and Disability Benefits

If an Imperial participant dies after normal retirement, but prior to actual retirement, the surviving spouse will receive the greater of: (1) a five year certain annuity payment equivalent to 100% of the present value of the participant's accrued benefit or (2) a 50% joint and survivor annuity. Any Imperial participant who becomes disabled will be eligible for termination or retirement benefits.

In the case of death of an active or inactive Colonial participant with at least five years of vesting service prior to retirement or attainment of age 55, there is a benefit payable to the surviving spouse equal to 50% of the benefit the participant had accrued prior to the date of death, payable at early retirement. Disability retirement income benefits are equal to the Colonial participant's accrued benefit, however the participant will cease earning credited service as of the date they incur the disability.

Retirement Dates

Normal retirement is at age 65 for both Imperial participants and Colonial participants.

For an Imperial participant, early retirement is available to employees who are at least age 55 and have 5 years of service. For a Colonial participant, early retirement is available to employees who are at least age 55 and have 10 years of service. Benefits will be reduced for early retirement in accordance with the Plan. There is no mandatory retirement age.

Vesting

All Imperial participants are 100% vested in their benefits.

Colonial participants are vested in their benefits upon completion of 5 years of service. Effective June 30, 2023, participants became 100% vested in all accounts as a result of the plan termination.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting. As a result of the termination of the plan, the financial statements are presented using the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value which approximates liquidation basis. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefit payments are recorded when paid.

Plan Expenses

Investment related expenses, PBGC premiums, certain audit and administrative expenses are paid through the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Certain expenses incurred and paid, or are expected to be paid, through the Plan during the liquidation of the Plan were recorded as accrued expenses as of December 31, 2023.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump sum distributions, that are attributable, under the Plan's provisions, to the service employees have rendered and include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Vested benefits are benefits to which members are entitled regardless of future service with the Company. Nonvested benefits are dependent upon future services.

The actuarial present value of accumulated plan benefits is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The more significant assumptions underlying the actuarial computations used in the valuation as of December 31, 2023 are as follows:

The foregoing actuarial assumptions for the December 31, 2023 valuation were prepared with the knowledge of the plan termination effective in 2023 and were based on factors known for the final wind-down activity in 2024 and discounted to determine the actuarial present value of accumulated plan benefits as of December 31, 2023. The computation of the actuarial present value of accumulated plan benefits was made as of January 1, 2024. Had the valuation been performed as of December 31, there would be no material difference.

All accumulated plan benefits were paid out by the end of 2024. Subsequent to the December 31, 2023 valuation date, all accumulated plan benefits were paid out through normal monthly benefit payments or transferred pursuant to an annuity purchase agreement. Accumulated benefits for liquidation totaled approximately \$126.6 million, which includes normal monthly benefit payments paid by the Plan prior to May 1, 2024 and amounts transferred pursuant to an annuity purchase agreement. See Note G for additional information.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account - Valued at net asset value of units of the pooled separate account. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

(1) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits in liquidation.

The pooled separate account can be redeemed daily, has daily redemption notice periods, and has no unfunded commitments.

D. INSURANCE CONTRACT:

Prior to 1971 the Company had a contributory pension plan under a contract with Aetna Life Insurance Company ("Aetna"). When the Company created a new pension plan in 1971, the moneys under contract with Aetna remained there, but no contributions have been made since.

Employees who retired prior to 1971 and were receiving payments from Aetna continue to be paid by Aetna. When an employee who made contributions to the old plan retires after 1970, the employee's monthly benefit is calculated under both the new and old plans and the employee receives the higher of the two benefits. Upon the employee's retirement, the Company instructs Aetna to begin making payments to the retiree for the amount the employee would have received under the old plan.

The moneys under the contract with Aetna were invested in a portion of the Aetna general account until 2023 (see Note G for update), which holds primarily medium-to-long-term public and private placement bonds, including U.S. Treasury and agency securities, mortgage-backed securities and commercial mortgages.

The contract with Aetna specifies a minimum effective annual interest rate of 3%. Interest was credited each year based on the actual yield on investments of the underlying portfolio. The average annual effective interest rate for the year ended December 31, 2023 was 4.35%.

The Aetna contract was divided into two categories: Annuity Allocation and Unallocated Fund. The Annuity Allocation is money that is specifically allocated to individuals who are still active or have retired. The Unallocated Fund is money in excess of the amounts

needed by Aetna to fulfill its contractual obligation. This Unallocated Fund was available for withdrawal by the Plan, subject to the assessment of any outstanding charges according to the terms of the contract. As of December 31, 2023, there was no amount held in the Aetna contract. As a result of the plan termination, the Aetna contract was terminated. Certain funds were used to purchase an annuity buyout contract for Aetna to assume the liability of certain recurring benefit payments (see Note G) and the remaining money was transferred to other investments held at Principal Trust Company. A market value adjustment of \$197,507 was applied at the termination of the contract and is included in net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2023.

E. TAX STATUS:

The Plan has received a determination letter from the Internal Revenue Service (“IRS”) dated January 13, 2012, stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan was subsequently amended to terminate the Plan. The Company applied to the IRS for a final determination letter as part of the winddown process and received a final determination letter dated February 25, 2025. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan, and Aetna Life Insurance Company, a custodian of the Plan through November 30, 2023.

G. PLAN TERMINATION:

On January 14, 2023, the Board of Directors of the Company adopted a resolution to terminate the Plan in accordance with PBGC provisions and reporting requirements. The effective date of the plan termination is June 30, 2023. As a result of the plan termination, all participants became 100% vested in their accounts. Participants who had not commenced benefit payments were given the opportunity to receive a lump sum

distribution during an election period in 2023. Lump sum payouts made on December 20, 2023 totaled \$15,357,645.

During 2023, due to the termination of the Plan, the Company terminated its contract with Aetna and as a result, the liability associated with certain recurring benefit payments was transferred to Aetna. In 2023 the Plan transferred a net amount in cash of \$294,221 to Aetna and the ongoing benefit payments beginning August 1, 2023 will be satisfied by the insurance company under the terms of the contract.

In February 2024, the Plan entered into a contract with Massachusetts Mutual Life Insurance Company ("Mass Mutual") to transfer assets and liabilities associated with the annuitant participants that were receiving a recurring benefit from the Plan or who had not made an election to receive a lump sum. In 2024, the Plan transferred a net amount in cash of \$122,291,084 to Mass Mutual. All ongoing benefit payments beginning May 1, 2024 will be satisfied by the insurance company under the terms of the contract.

The Plan recorded a liability on the statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2023 of \$2,028,801 for professional and administrative fees paid or expected to be paid through the Plan due to the plan termination. These expenses were paid using plan assets during 2024.

In 2024 it was determined there is a surplus remaining in the Plan of approximately \$2.4 million. Certain funds may be used to reimburse the Company for final expenses, however, there is no reasonable basis for estimation for this amount as of the date of these financial statements. The Company plans to transfer the remaining surplus to the related 401(k) Plan. Assets are expected to be fully liquidated in 2025.

H. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, the management of investments held by the trustee and custodian are considered party in interest transactions.

I. RISKS AND UNCERTAINTIES:

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits in liquidation.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
