## **Notes to Financial Statements**

**December 31, 2024 and 2023**

### **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Crooker Construction, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a prototype safe harbor defined contribution plan covering all full-time employees of Crooker Construction, LLC (the Company) who are at least eighteen years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Managers.

Employees are immediately eligible to participate in salary deferral and employer safe harbor match contributions and are automatically enrolled at a withholding of 6% compensation, unless the employee opts out. Participants must have worked at least 950 hours during the first year to be eligible for match and profit-sharing contributions.

#### **Contributions and Funding Policy**

Participants may contribute a percentage of pretax annual compensation, as defined in the Plan, and/or also may make post-tax (Roth) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a number of mutual funds and one common collective trust as investment options.

The Plan's safe harbor match contributions are made by the Company as follows: 100% of deferrals up to 3% of compensation, and 50% of deferrals in excess of 3% of compensation up to 5% of compensation.

Employee deferral contributions and employer match contributions are funded on a payroll basis. Profit sharing contributions are funded annually at the discretion of the Company.

#### **Notes Receivable from Participants**

Participants are allowed to borrow from their 401(k) fund accounts up to the lesser of \$50,000, or 50% of their vested account balance. The minimum loan is \$1,000 and only one note may be outstanding for a participant at any time. The notes bear interest at the prevailing interest rate at the date of the loan, which is based on the prime rate plus 1% at the date of the note issuance. Such rates are fixed throughout the duration of the notes. Principal and interest are paid via payroll deduction under a level amortization schedule. Interest rates on outstanding notes receivable range from 4.25% – 9.5% for all outstanding loans as of December 31, 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

December 31, 2024 and 2023

### NOTE 1 - DESCRIPTION OF THE PLAN - CONTINUED

#### Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in safe harbor contributions prior to 2023 were immediate. Vesting in safe harbor contributions 2023 and forward are subject to 2-year cliff vesting. Vesting in the Company's pre-safe harbor match contributions and discretionary profit-sharing portions of their accounts is based on plan years of continuous service with the Company. A participant is 100% vested in his or her pre-safe harbor match and profit-sharing contributions after six years of credited service, as follows:

#### Payment of Benefits

Upon termination of service, a lump-sum or installment payment distribution is automatically distributed to a participant if the vested account balance is \$5,000 or less. If the vested account balance exceeds \$5,000, the participant may elect to leave the funds in the Plan until retirement or take a distribution at their discretion, subject to applicable withholding taxes. The Plan is subject to the Internal Revenue Service (IRS) automatic rollover rules for automatic distributions in excess of \$1,000. The minimum distribution for hardship withdrawals is \$500. Participants may withdraw rollover source funds at any time.

#### Forfeited Accounts

Forfeitures of non-vested account balances of terminated employees may first be used to pay for the Plan's administrative expenses. Any remaining forfeitures may be used to reduce future employer match and profit sharing, as applicable. On December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,732 and \$17,219, respectively. The forfeiture total for December 31, 2024 consist of \$4,807 forfeitures, \$317 unallocated assets, and \$1,608 unclaimed property. Also, in 2024, administrative expenses of \$24,874 were paid from forfeited non-vested accounts.

#### Secure Act 2.0 of 2022

The Plan adopted/implemented certain provisions of the Secure Act 2.0 in good faith, as follows: self-certification of hardship withdrawals, update of dollar limits for force-out distributions, increased catch-up limits, and exceptions to 10% penalty on early distributions for terminal illness and domestic abuse.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustees.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Reinvested dividends and capital gains distributions of mutual fund shares are classified as dividend income. Net appreciation (depreciation) includes the Plan's gains and losses and investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Most expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from the financial statements. Expenses paid by the Plan include recordkeeping fees, investment advisor fees, annual audit expense, and third-party administration fees.

#### Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 11, 2025, which is the date the financial statements were available to be issued.

### NOTE 4 – INVESTMENTS AND FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plans have the ability to access.
- Level 2- Inputs to the valuation methodology include:
  - Quoted prices for similar assets in active markets;
  - Quoted prices for identical or similar assets in inactive markets;
  - Inputs other than quoted prices that are observable for the asset;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies since December 31, 2023.

### NOTE 4 – INVESTMENTS AND FAIR VALUE MEASUREMENTS - CONTINUED

*Mutual funds:* Valued at the daily closing price as reported by the fund. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* for Invesco Stable Value Trust, contract value per unit is provided by the trustee and is determined by adjusting the fair value of net assets of the trust to the contract value and dividing the remainder by the number of units outstanding.

### NOTE 5 – INVESTMENT IN COMMON COLLECTIVE TRUST

The Plan invests in the Invesco Stable Asset Trust collective trust (Stable Value Fund). The Stable Value Fund invests in fixed income investments, including guaranteed investment contracts and synthetic guaranteed investment contracts. The Stable Value Fund pays for a wrap contract, which is a derivative investment meant to stabilize the per unit value of the Fund at \$1 per unit, by hedging against interest rate fluctuations.

The Stable Value Fund invests in fully benefit-responsive investments. However, there are certain plan sponsor-initiated events, including withdrawal from the investment option, which could delay or restrict payments from the Fund until underlying assets can be liquidated. The Trust requires a 12-month irrevocable notification for the Plan's withdrawal. A decision to liquidate the fund from the Plan has not been made.

### NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer accounts.

### NOTE 8 – TAX STATUS

The Company adopted a volume submitter non-standardized profit-sharing plan with a cash or deferral arrangement, which received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan as then designed is in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has determined that the Plan has no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 10 - VESTED TERMINATED BALANCES

As of December 31, 2024, there were \$46,586 of vested terminated balances for which participants had requested withdrawal.

### NOTE 11 – PARTY IN INTEREST TRANSACTIONS

The following were considered parties in interest to the Plan during the year ended December 31, 2024: Raymond James Financial Services (Raymond James), Downeast Pension Service, Inc. (Downeast), Lauren Corey Consulting, LLC, and Capital Bank and Trust Company (American Funds). During the year ended December 31, 2024, \$36,721 was charged for Raymond James investment advisory services, \$11,565 was charged for Downeast third party administration services, \$17,659 was charged for Lauren Corey Consulting, LLC audit services, and \$22,493 was charged for American Funds recordkeeping services.

American Funds receives 12(b) revenues (transaction-based charges) from the mutual funds in which the Plan invests. It uses the revenue to pay Raymond James and Downeast, and any remaining revenue is applied toward the Plan's charges for recordkeeping services, prior to invoicing the Plan. The audit expense and a portion of the third-party administration expense was paid from forfeitures.

Total American Fund balances as of December 31, 2024 and 2023 were \$9,375,135 and \$8,949,591, respectively.
