### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Raley's 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Raley's 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Raley's 401(k) Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Raley's 401(k) Retirement Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

### NOTE 1 – PLAN DESCRIPTION

The following description of the Raley's 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan, which became effective July 1, 1990, is a defined contribution plan covering all eligible employees of Raley's (the Company) and its subsidiaries. The Administrative Committee of the Company is responsible for administration and management of the Plan. All investments in the Plan are participant directed. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the Trustee of the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility** – Each employee who is not otherwise excluded from participation in the Plan is eligible to participate in the Plan after completing the eligibility requirements as stated in the Plan document. The Plan excludes the following:

- Employees whose employment is covered by the terms of a collective bargaining agreement, unless eligibility for that specific bargaining group has been provided for in the Plan document.
- Other various exclusions as defined by the Plan.

### **Contributions**

*Participant contributions* – Each year, participants may contribute between 1% and 75% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

*Employer contributions* – The Company makes mandatory matching contributions and nonelective employer contributions for each eligible group of employees as stated in the Plan document.

The Company may also make an annual discretionary nonelective contribution, as determined each year by the Company's Board of Directors. There were no discretionary nonelective contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

**Participant accounts** – Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, allocation of the Company's matching and nonelective contributions, allocation of plan earnings (losses), and charged with withdrawals, and administrative expenses. Allocations are based on participant's eligible compensation or account balances, as defined. Employer nonelective contributions are allocated to the account of each participant in the ratio of the participant's eligible compensation to the total eligible compensation for all plan participants. The benefit to which a participant is entitled is the value of the participant's vested account.

**Participants' investment options** – Participants direct the investment of their contributions into various options offered by the Plan. Participants may change their investment options at any time throughout the year directly with the Trustee.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan document, plan loans will bear a reasonable rate of interest determined by prime interest rate plus 2%, as published by the Wall Street Journal on the first business day of the month. Principal and interest is paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.25% to 10.50% with various maturities through September 2039.

**Payment of benefits** – On termination of service due to retirement, death, disability, or other reasons, a participant shall receive a distribution equal to the value of the participant's vested interest in his or her account in one of the following forms: (a) a cash out for vested account balances of \$1,000 or less, or (b) upon request, a participant may receive the value of the vested interest in his or her account as a lump-sum cash distribution, a rollover into an eligible retirement plan, or a combination thereof. Participants may also receive in-service distributions on account of hardship or after attaining age 59½. As of December 31, 2024, there were no benefits payable to participants that have elected to withdraw from the Plan but have not yet been paid.

**Vesting** – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions are vested for each employee group in accordance with the Plan document. The value of a participant's account becomes fully vested when the participant's normal retirement age is attained while an employee of the Company. A participant will also become 100% vested upon termination of employment due to death or disability.

**Forfeitures** – Forfeitures are the nonvested portion of a participant's account that are lost upon termination of employment. Forfeitures are first used to reinstate previously forfeited account balances of former participants, if any. The remaining forfeitures may be used to reduce employer mandatory matching contributions or discretionary contributions and to pay for eligible administrative expenses.

At December 31, 2024 and 2023, the balance of forfeited accounts was \$345,031 and \$337,778, respectively. During 2024, \$50,020 was used to reinstate accounts of former participants, \$1,039,480 was used to reduce employer's matching contributions, and \$37,154 was used for administrative expenses.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value. Principal Trust Company certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes net unrealized market appreciation and depreciation of investments and net realized gains and losses on the sale of investments during the period.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of benefits** – Benefit payments to participants are recorded when paid.

**Expenses** – The Plan's expenses are paid by the Plan or the Company, as specified in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. The Company provides bookkeeping and other administrative services to the Plan at no charge.

Certain expenses incurred in connection with the investment advisory and general administration of the Plan are paid by the Plan. Participants are assessed separate fees for the administration of loans and repayments thereof. Fees paid by the Plan and participants are recorded as deductions in the accompanying statement of changes in net assets available for benefits, net of any revenue sharing credits earned and received by the Plan (see Note 6).

Management fees and operating expenses charged to the Plan for investments in shares of registered investment companies (mutual funds), pooled separate accounts, and common/collective trusts are deducted from income earned on a daily basis as disclosed in the investment prospectus thus are not separately reflected in the accompanying statement of changes in net assets available for benefits.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are issued. The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were issued.

### NOTE 3 – CERTIFIED INVESTMENT INFORMATION

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and gives the lowest priority to unobservable inputs (Level 3).

The three levels of inputs within the fair value hierarchy are defined as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Pooled separate accounts* – Units held in pooled separate accounts (PSAs) are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information.

*Common/collective trusts* – Units held in common/collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CT is calculated based on a compilation of primarily observable market information.

The PSAs and CTs can be redeemed daily, and there are no redemption restrictions or notice requirements. There are no unfunded commitments as of December 31, 2024 and 2023.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Administrative Committee believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 – TAX STATUS**

The Plan document is a pre-approved non-standardized profit sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Plan investments include pooled separate accounts and common/collective trusts managed by affiliates of the Trustee. Accordingly, these transactions qualify as exempt party-in-interest transactions.

The Plan paid expenses related to the Plan's operations and investment management to various service providers.

Principal Life Insurance Company, and Principal Securities, Inc., affiliates of the Trustee (the affiliates), receive fees from the Plan, in accordance with a service agreement with the Plan, from affiliated or unaffiliated investment options for services they provide to these investment options, and from distribution and sale of shares of registered investment companies held by the Plan. These revenues are retained by Principal Life Insurance Company and are used first to pay Principal Life Insurance Company's recordkeeping services, second to fund the Plan's ERISA Budget Account, and third to be credited back to the Plan as a fee adjustment.

Funds retained by Principal Life Insurance Company in the ERISA Budget Account are used to pay plan administrative expenses at the direction of Plan management. Balance at ERISA Budget Account was \$86,561 and \$52,855 at December 31, 2024 and 2023, respectively, which has not been included in the accompanying financial statements or Form 5500.

During 2024, the credit received by the Plan as a fee adjustment totaled \$101,359. Fee adjustment is allocated pro rata to all participants with an account balance monthly.

### NOTE 7 – RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments, including mutual funds, pooled separate accounts, and collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
