Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Baylor Scott & White Health and Welfare Benefits Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

For the Years Ended December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN

The following description of the Baylor Scott & White Health and Welfare Benefits Plan (the “Plan”) is provided for general information purposes only. Participants should refer to various Plan documents, for each program offered, for more complete information.

General

The Plan is a welfare and fringe benefits plan designed to provide various benefits, including medical, prescription drug, dental, vision, flexible spending accounts for healthcare and dependent care, life insurance, accidental death and dismemberment, short and long-term disability, accidental injury, critical illness, hospital care, legal services, and the employee assistance program, covering substantially all active benefit eligible employees of Baylor Scott & White Health (BSW Health), a Texas non-profit organization, formerly known as Baylor Scott & White Holdings, and certain affiliates (collectively the “Employer” or “BSWH”). Certain eligible Central Texas, primarily the Greater Temple, Texas area, employees are entitled to long-term care benefits, and certain eligible retired employees are entitled to frozen health benefits under the terms of the Plan document. The Plan also provides life insurance benefit options to certain eligible retirees. All the benefits are fully insured, except for the medical care options and short-term disability. The Plan also offers a Health Savings Account (HSA) as another option. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Baylor Scott & White Benefits Operations Committee is responsible for administrative oversight of the Plan.

Effective January 2, 2024, US Bank replaced Wilmington Trust as the Plan's trustee (referred to as the “Trustee”, collectively referred to as the “Trustees”).

Scott and White Health Plan, doing business as Baylor Scott & White Health Plan (BSWHP), is a related party to the Plan and acts as a third-party administrator for the medical benefit.

Eligibility

The Plan provides benefit options to all eligible participants, as defined in the Plan document. Eligible employees may begin participating in the Plan on the employee’s date of hire.

Notes to Financial Statements - continued

Contributions

The Employer makes payroll deductions for active employee contributions. Contributions from other participants are remitted directly to the Trustee every pay period. Participant contributions are determined by the Employer with the assistance of an actuary for self-funded products, or the insured rate for fully-insured products. The Employer makes contributions as necessary to fund the payment of claims, premiums, and administrative expenses.

The Employer is responsible for any excess of benefit obligations over net assets available for benefits of the Plan. The Employer funds the entire cost of the premiums for the basic life, basic accidental death and dismemberment, and basic long-term disability. The Employer also funds short-term disability, and basic long-term care insurance for certain eligible Central Texas, primarily the Greater Temple, Texas area, employees. Participants may contribute specified amounts to extend insurance coverage or for the election of other benefit plan options. The HSA is only funded by participant contributions.

The Plan was amended, effective January 1, 2003, to freeze participation in postretirement medical benefits to those North Texas participants who met the eligibility requirements along with their dependents. The payment structure for medical retiree benefits was also changed effective January 1, 2003.

Effective January 1, 2003, the Plan was also amended to freeze participation in the life insurance option to those North Texas retirees already participating. The cost of this coverage and the maximum benefit was also changed.

Effective December 31, 2013, the Scott & White Retiree Medical Plan was amended to freeze participation in postretirement medical benefits to those Central Texas participants who met the eligibility requirements.

Effective January 1, 2019, the Plan was amended to include accidental injury and critical illness voluntary plans as a component of the welfare program, and Cigna was selected to provide such benefits.

Effective January 1, 2023, the Plan was amended to include a hospital care voluntary plan as a component of the welfare program, and Cigna was selected to provide such benefits.

Deposits With Service Providers

Deposits with service providers represent funds held by the claims service providers as required by their service agreements. These monies will ultimately be used for claim payments.

Plan Termination

Although it has not expressed any intention to do so, the Employer reserves the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, the remaining net assets of the Plan will be used first to provide future benefits to participants, and then to pay the costs of administering the Plan.

In June 2023, the Plan discontinued Other Post Retirement Benefits for those age 65 or older, with an effective date of January 1, 2024.

Rebates

The Plan is eligible for certain incentives and volume prescription rebates. Rebates due to the Plan as of year end are reported as a receivable, with the offset being netted against benefits paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, except for benefits and premiums paid, which are recorded when paid.

Cash

Cash includes deposits with financial institutions which, at times, may be in excess of federally insured limits. As of December 31, 2024, approximately \$4,162,000, which is not covered by the Federal Deposit Insurance Corporation (FDIC), was included in cash.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of professional fees and administrative fees paid to third-party claims administrators, the trustee, actuary, and other vendors. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. The Employer pays additional administrative fees on behalf of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States (GAAP) requires management to make estimates and assumptions

that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will continue to occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics; all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible, that changes in these estimates and assumptions in the near term would be material to the financial statements.

Valuations of Investments and Investment Income

Money market funds are stated at a net asset value of approximately \$1. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Other Benefit Obligations

Plan obligations at December 31, 2024 and 2023, for claims payable and claims incurred by active and COBRA participants, but not reported at that date, were estimated by an actuary using claims lag studies provided by the third-party administrators. These obligations will be funded through contributions from the Employer as obligations become due.

3. POSTRETIREMENT BENEFIT OBLIGATIONS

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to the end of the Plan year. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated Central Texas employees, and their beneficiaries and dependents, and (2) active Central Texas employees, and their beneficiaries and dependents after retirement from service. Prior to an active Central Texas employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary. The resulting amount is derived by applying actuarial assumptions to historical claims-cost data in order to estimate future annual incurred claims costs per participant. Adjustments are made to such estimates for the time value of money (through discounts for interest), and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The discount rate used in determining the accumulated postretirement benefit obligation at December 31, 2024 and 2023, is 4.6% for both years. For the 2024 Plan year, the annual assumed rate of increase in the per capita cost of covered medical and prescription drug benefits is 6.3% for those under and over the age of 65. This rate is assumed to decrease gradually to 4.5% by 2031, for those under the age of 65, and remain at that level thereafter.

The weighted-average health care cost-trend rate assumption may have a significant impact on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point, it would increase the accumulated postretirement benefit obligations as of December 31, 2024 and 2023, by approximately \$10,000 and \$19,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations. The Medicare Prescription Drug, Improvement, and Modernization Act of 2003 introduces a prescription drug benefit under Medicare (Medicare Part D) as well as a federal subsidy to administrators of retiree health care benefit plans that are at least actuarially equivalent to Medicare Part D. The effects of the Employer's Medicare subsidy are not reflected in the Plan's obligations. The Medicare subsidy amount is paid to the plan sponsor and does not flow into the Plan. The subsidy amount may be used for any valid business purpose. As a result, the Medicare subsidy does not reduce the amount of benefits that need to be covered by the Plan assets and future Employer contributions.

5. CERTIFICATION OF PLAN TRUSTEES

Accordingly, the Trustees (US Bank for the period January 2, 2024 through December 31, 2024, and Wilmington Trust for the period January 1, 2023 through January 1, 2024), qualified institutions, of the Plan have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments included in the accompanying schedule of assets held at end of year as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

6. FAIR VALUE MEASUREMENTS

As defined in Accounting Standards Codification (ASC) 820, "*Fair Value Measurement*", fair value is based on the prices that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, ASC 820 establishes a three-tier fair value hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability;

inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability are unobservable and developed based on the best information available in the circumstances.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The carrying value of participant contributions receivable and administrative expenses payable are reasonable estimates of their fair value due to the short-term nature of these financial instruments. The Plan's investment in the money market fund is valued at net asset value, which is determined using quoted prices in active markets for identical instruments at year-end. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023.

7. INCOME TAX STATUS

The trust funding the Plan has received an exemption letter from the Internal Revenue Service (IRS) dated February 2, 2001, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the "Code") as a Voluntary Employee Beneficiary Association (VEBA). The Plan and trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. Although the Plan has been amended since receiving the determination letter, the Plan sponsor believes the Plan is being operated in compliance with the applicable requirements of the Code, and therefore, believes the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS.

The Plan has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY TRANSACTIONS

The Plan incurred third-party administration expenses of approximately \$18,006,000 and \$17,259,000 from BSWHP recorded in administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. The Plan accrued approximately \$316,000 and \$944,000 of expenses payable to BSWHP, as of December 31, 2024 and 2023, respectively. The Plan also accrued approximately \$26,405,000 and \$25,231,000 in rebate claims receivable from the BSWHP, as of December 31, 2024 and 2023, respectively, for pharmacy rebates. Pharmacy rebates totaling approximately \$31,361,000 and \$28,457,000 have been netted with benefits paid, net in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

The money market fund is managed by the Trustee and, therefore, those investment transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers.

10. SUBSEQUENT EVENTS

BSW Holdings and Baylor Scott & White Health Merger

Effective January 1, 2025, BSW Holdings merged into Baylor Scott & White Health (BSW Health), a Texas nonprofit corporation. The primary purpose of this organizational change is to streamline the BSWH corporate structure. Effective on the same date, the Plan was amended for BSW Health to become the new Plan sponsor.
