INDEPENDENT AUDITOR'S REPORT

To the 401(k) Committee and Management
Midwest Railcar Repair Retirement Security Partnership Plan
Brandon, South Dakota

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Midwest Railcar Repair Retirement Security Partnership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

(1) Significant Accounting Policies

Nature of Business of Plan Sponsor

Midwest Railcar Repair, Inc. (the Plan Sponsor) and CarMath, Inc. (collectively, the Company) clean, qualify, and/or repair interior lining, exterior paint, or mechanical working of railroad cars in Brandon, South Dakota.

Basis of Accounting

The financial statements of the Midwest Railcar Repair Retirement Security Partnership Plan (the Plan) are prepared under the accrual method of accounting.

Use of Estimates

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value on a recurring basis as determined by Alerus Financial, N.A. (the Trustee) (Notes 4 and 8). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividend income is recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Net Change in Fair Market Value of Investments

The net appreciation in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year and the unrealized gains and losses in securities held at the end of the year.

Payment of Benefits

Benefits are recorded when paid.

(1) Significant Accounting Policies

Subsequent Events

Significant subsequent events have been evaluated through September 12, 2025, the date which the financial statements were available for issue.

(2) Plan Description

The following description of the Plan provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company who have completed 3 months of service and have attained the age of twenty-one are eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, not to exceed certain limits established by the Internal Revenue Service (IRS). Participants who attain age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company currently matches 100 percent of employee contributions up to 3 percent of compensation and 50 percent of employee contributions after 3 percent up to 5 percent of compensation. Contributions are subject to certain IRS limitations.

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and contributions to a Roth 401(k) account are included in the participant's gross contributions. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participant's Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

The Plan instituted automatic enrollment in which the Plan Sponsor automatically withholds 3 percent of the employee's compensation upon becoming eligible to participate unless otherwise elected by the participant. Contributions are automatically invested in the appropriate target date fund unless the participant elects other investment options. The Plan increases the participant's automatic enrollment by one percentage each year up to a maximum of five percent of compensation.

(2) Plan Description

Payment of Benefits

Benefit payments are made as soon as administratively feasible following the first valuation date after the date on which a participant is terminated from employment. Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account by either a lump-sum distribution or through installments. Benefits less than \$1,000 are made as soon as administratively feasible after the participant's termination of employment. A participant with an account balance of \$1,000, but less than \$5,000, may receive a rollover distribution into an individual retirement account set up by the Plan Administrator.

Hardship Withdrawals

Should a plan participant experience a hardship, they may elect to withdraw all or part of their vested account from the Plan. Hardship withdrawals are e-certified by the participant when the distribution request is made. The Trustee may, at their discretion, approve all or part of the withdrawal request. Hardship withdrawals are recorded as distributions in the period in which they are paid.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the employer's matching contribution, (b) the employer's profit-sharing contribution, and (c) plan earnings (losses), and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options

Participants may direct contributions to any of the funds offered by the Plan. Participants may change their investment options as often as they wish. Participants may elect to discontinue contributions at any time.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Prior to January 1, 2018, vesting in the Company's matching and profit-sharing contributions, plus actual earnings (losses) thereon, is based on years of credited service. A participant becomes 20 percent vested after two years of credited service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after six years of credited service, or if less than six years, upon reaching normal retirement age, total disability, death or upon termination of the Plan. Participants are immediately vested in Company matching and profit-sharing contributions made after January 1, 2018.

Forfeitures

Forfeited, nonvested account balances totaled \$5,887 and \$5,558 at December 31, 2024 and 2023, respectively. Nonvested account balances are forfeited, unless participants return to employment and contribute the distribution received at termination within a specified time. The Plan allocates forfeitures to reduce future employer contributions. No forfeitures were used to reduce the employer matching contribution during 2024 or 2023.

(3) Administrative Expenses

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. The Company has, at its discretion, absorbed certain other administrative expenses pertaining to the Plan. If not paid by the Company, these administrative expenses become the responsibility of the Plan.

(4) Information Certified by Trustee

The Plan's investments are held by Alerus Financial, N.A., the Trustee, who executes investment transactions and performs all accounting functions associated with the Plan's investments. The Trustee determined the fair value of investments at December 31, 2024.

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended December 31, 2024 and 2023. Information contained in the following has been certified by the Trustee:

Statements of Net Assets Available for Benefits (except for employer and employee contributions receivable and liabilities)

Statement of Changes in Net Assets Available for Benefits (except for contributions, benefits paid to participants, and administrative expenses)

Supplemental Schedule of Assets Held at Year End

The Plan invests in mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

(5) Income Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The IRS has ruled that the form of the prototype plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has not been amended since receipt of the most recent IRS determination letter. The Plan Administrator and third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Department of Labor (DOL) or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

(7) Participant Withdrawals

Vested, undistributed account balances of separated Plan participants total approximately \$860,000 and \$774,000 at December 31, 2024 and 2023, respectively.

(8) Recurring Fair Value Measurements

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Fair value measurements are framed in a three-level hierarchy defined as follows:

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level Two: inputs include:
 1. quoted prices for similar assets or liabilities in active markets;
 2. quoted prices for identical or similar assets or liabilities in inactive markets;
 3. inputs other than quoted prices that are observable for the asset or liability;
 4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 inputs must be observable for substantially the full term of the asset or liability.
- Level Three: inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following tables present the assets carried at fair value as of December 31, 2024 and 2023, respectively, in the accompanying statements of net assets available for benefits by fair value hierarchy, as described above.

(8) Recurring Fair Value Measurements

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market: Valued at \$1 per share.

(9) Party-in-Interest Transactions

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
