***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Altimetrik, Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Altimetrik, Corp. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ***A. Description of Plan***

The following description of the Altimetrik, Corp. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

*General:* The Plan is a defined contribution plan that became effective on September 1, 2001 covering all employees of Altimetrik, Corp. and Vattikuti Ventures, LLC ("the Company") who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. The investment committee determines the appropriateness of the plan's investment offerings, monitors investment performance and reports to the plan administrator.

Effective August 30, 2024, the Plan was amended to remove Vattikuti Ventures, LLC and Calibo, Inc. as participating employers in the Plan.

*Eligibility:* An eligible employee may participate in the Plan upon attaining age 18 and completion of one service hour and can enroll on the first of the month following their hire date. An employee is not eligible to participate if they are a union employee, certain nonresident aliens, leased employees, interns, temporary employees, seasonal employees and any individual who performs services to the Company where remuneration for services is not reported on a W-2.

*Contributions:* Each year, participants may contribute up to 25% of their annual compensation as defined by the Plan as a pre-tax contribution or a Roth contribution up to a yearly maximum per limitations imposed by the Internal Revenue Service ("IRS"). In addition, a participant may contribute up to 8% of compensation as an after-tax contribution. Participants who have attained age 50 before the end of the plan year are eligible to catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

The Company provides for a matching contribution, up to a maximum of 50% of participant's elective deferrals to the Plan, subject to a maximum of 3% of the participant's compensation. During the year ended December 31, 2024, the Company made a \$749,424 matching contribution to the Plan.

*Participant Accounts:* Each participant's account is credited with the participant's contribution and Company matching contribution, as well as allocations of the Company's plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

***A. Description of Plan (continued)***

*Notes Receivable from Participants:* Participants may borrow from their vested fund accounts. The maximum amount the participant can borrow is the lesser of \$50,000 minus the highest outstanding loan balance during the past year or 50% of the participant's account balance less any outstanding loans. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed 5 years, except for the borrowing for the purchase of a principal residence which is to be paid within 10 years. A maximum of two loans per participant is allowed at any one time.

*Payment of Benefits:* On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments, rollover funds or defer receipt of funds until age 73. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

*Forfeited Accounts:* At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$79,326 and \$5,678, respectively. These accounts may be used to reduce future employer contributions or pay administrative expenses. In 2024 and 2023, forfeiture accounts were not used to pay administrative expenses. Also, in 2024, employer contributions were reduced by \$44,458 from forfeited nonvested accounts.

***B. Summary of Accounting Policies***

*Basis of Accounting*

The accompanying financial statements are presented on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

***B. Summary of Accounting Policies (continued)***

*Contributions*

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan did not have excess contributions for the plan year ended December 31, 2024.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

The Plan participates in a revenue sharing agreement with certain providers. During the year ended December 31, 2024, the Plan received revenue sharing of \$128,121 which was used to pay investment advisory fees. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Subsequent Events*

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

***C: Fair Value Measurements***

The plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stocks, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

---

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily.

***F: Related-Party Transactions and Party in Interest Transactions***

The plan sponsor, Altimetrik, Corp. is also the plan administrator. During 2024, all of the members of the board of trustees were also plan participants.

Certain plan investments are managed by Bank of America N.A. Bank of America N.A. is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Effective January 1, 2018, Merrill Lynch provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Merrill Lynch. Merrill Lynch earns investment related revenue from processing fees, service fees, distribution fees and all other fees Merrill Lynch receives from a mutual fund or a collective trust provider, or an affiliate of such provider, or fees Merrill Lynch receives from a separately managed account that are attributable to the plan assets invested in these investments, excluding investments in plan participants' Self-Directed Brokerage accounts. This revenue is used to offset certain amounts owed to Merrill Lynch for its administrative services to the Plan.

If the revenue received by Merrill Lynch from such mutual fund service providers exceeds the amount owed under the MSA, Merrill Lynch remits the excess to the plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, the excess amount of shared revenue earned was \$11,072 and was credited to the plan's forfeiture account. The Plan or Plan Sponsor may make a payment to Merrill Lynch for administrative expenses not covered by revenue profit sharing.

***G: Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

***H: Tax Status***

The IRS has determined that when compliant prototype plans are adopted by employers on a word-for-word basis, the employers have automatic reliance as to the form of the plan, and are deemed to have a favorable determination letter for IRS purposes. The Company has adopted such a plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not, would not be sustained upon examination by the IRS or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***I: Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
