INDEPENDENT AUDITORS' REPORT

To the Trustees and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Natural Partners, Inc. 401(k) Profit Sharing Plan and Trust** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of Plan

The following description of the *Natural Partners, Inc. 401(k) Profit Sharing Plan and Trust* (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions:

A. General - The Plan, established as of January 1, 2007 and restated most recently as of May 2, 2024, is a defined contribution plan sponsored by Natural Partners, Inc. (the "Company") covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective May 2, 2024, the Plan was restated and amended to revise the Plan and Company names to Natural Partners, Inc. 401(k) Profit Sharing Plan and Trust and Natural Partners, Inc., respectively.

John Hancock Life Insurance Company (U.S.A) ("John Hancock Life") served as the Plan's asset custodian and recordkeeper through May 2, 2024. Effective May 2, 2024, the Plan transferred its assets to John Hancock Trust Company LLC ("John Hancock Trust"), the new trustee and custodian of the Plan, at which time John Hancock Retirement Plan Services LLC became responsible for the record keeping functions related to the Plan.

B. Eligibility - Employees are eligible to participate in the Plan on the first day of the calendar month coincident with or next following the date they attain 18 years of age.

C. Contributions - Participants may contribute from 1% to 90% of their compensation on a pre-tax or after-tax basis, as defined by the Plan, subject to certain limitations prescribed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified retirement plans. In addition, the Plan allows participants, attaining the age of 50 before the end of the Plan year, to make additional catch-up contributions to the Plan.

The Plan also allows for safe harbor contributions, to be made on a per pay period basis, and equal to 100% of the first 3% of the participant's compensation plus 50% of the next 2% of the participant's compensation deferred. The Company may also make discretionary matching and profit-sharing contributions to the Plan, however, no such contributions were authorized during the 2024 Plan year.

D. Participant accounts - Each participant's account is credited with the participants' contributions, the Company's discretionary matching and profit-sharing contributions, the Company's safe harbor contributions, and actual Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting - Participants are immediately vested in their elective and rollover contributions, the Company's safe harbor contributions, and the Company's discretionary matching and profit-sharing contributions, if any, plus actual earnings thereon.

F. Notes receivable from participants - Participants may borrow an amount not to exceed 50% of their vested account balance, up to a maximum of \$50,000 (but not less than \$1,000). Notes receivable must be repaid over a term not to exceed five years from the date the proceeds are received unless the entire proceeds are used to purchase the participant's primary residence, in which case the repayment period may be extended up to 30 years. The notes receivable are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

G. Payment of benefits - In general, distributions from the Plan will be made in one lump-sum payment in cash. If the value of a participant's vested benefit is more than \$5,000 on termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum payment amount equal to the value of his or her account, or annual installments over a certain period, and in no event exceeding the life expectancy of the participant as determined at the time of distribution. If the value of a participant's vested benefit is \$5,000 or less, a lump sum payment will be made to the participant. The Plan provides for the payment of benefits in amounts up to the entire vested balance in a participant's account upon one of the following:

- a. Termination of employment
- b. Death or disability of the participant
- c. Attainment of age 59 ½
- d. Demonstrated hardship

H. Termination of the Plan - Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA.

I. Administrative expenses - The Company has elected to pay certain administrative expenses on behalf of the Plan during 2024. The Plan has no obligation to reimburse the Company for such expenses. Participant loan origination fees are charged to the account of the participant requesting the loan.

(2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting - The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets and the reported amounts of additions and deductions from net assets. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Mutual funds, pooled separate accounts, and the common collective trust are reported at fair value. The stable value fund is reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used as of December 31, 2024 and 2023.

Mutual funds: Stated at net asset values, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Pooled separate accounts: Investments in sub-accounts of the Plan's group annuity contract with John Hancock Life are valued at unit value, which is based on the aggregate fair value of the underlying assets in relation to the total number of units outstanding. Unit value is the equivalent of net asset value ("NAV"), which is a practical expedient for estimating the fair values of these investments. Investments in the pooled separate accounts may be redeemed daily with a notice period of one day and had no unfunded commitments as of December 31, 2023.

Common/collective trust: Investments in the stable value common collective trust, which was comprised primarily of fully benefit-responsive investment contracts, were valued at the NAV of units of the bank collective trust. The NAV, as provided by the custodian, was used as a practical expedient to estimate fair value. Investments in the common collective trust may be redeemed daily with a notice period of one day and had no unfunded commitments as of December 31, 2023.

Stable value fund: Investments in fully benefit-responsive investment contracts are required to be reported at contract value rather than fair value. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

This is a guaranteed general-account backed fund investment that is issued by John Hancock Life Insurance Company. A rate of interest contractually guaranteed by John Hancock Life Insurance Company is credited to participant account balances. No redemption fees, early withdrawal charges, or market value adjustments are charged on participant transfers of assets into or out of the contract. Contract value is the most relevant measure of these contracts as it is the amount a participant would receive in a transaction, thus, it is excluded from the fair value hierarchy at December 31, 2024.

Fair value measurement - FASB ASC 820, Fair Value Measurement, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest.

Payment of benefits - Benefits are recorded when paid.

Risks and uncertainties - Investments held by the Plan are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent events - Plan management has evaluated subsequent events through October 13, 2025, which is the date the financial statements of the Plan were available to be issued.

(3) Information certified by the custodian

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life, the custodian of the Plan through May 2, 2024, and John Hancock Trust, the Plan custodian and trustee beginning May 2, 2024, has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments
- Interest and dividends on investments
- Notes receivable from participants
- Interest income on notes receivable from participants
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(5) Party-in-interest transactions

Certain Plan investments are managed by John Hancock Life and John Hancock Trust, the custodians of the Plan; therefore, transactions with John Hancock Life and John Hancock Trust qualify as party-in-interest transactions. Fees paid by the Plan to John Hancock Life and John Hancock Trust were approximately \$20,000 during the year ended December 31, 2024. There was also approximately \$15,000 paid for investment advisory services to other parties during the year ended December 31, 2024.

(6) Tax status

The Prototype Plan obtained a favorable opinion letter from Internal Revenue Service dated June 30, 2020, stating that the Prototype Plan was designed in accordance with the applicable regulations of the Internal Revenue Code ("IRC"). The Plan administrator has not obtained an individual determination letter for the Plan. The Prototype Plan has been amended since receipt of the opinion letter consisting primarily of changes to ERISA. The Plan sponsor and the Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
