Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dupre' Investments, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Dupre' Investments, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Dupre' Investments, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Dupre' Investments, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

(1) Plan Description

The Dupre' Investments, Inc. 401 (k) Plan (the "Plan") is a 401K profit sharing plan (a defined contribution plan), established in 1996, and, as amended, covers substantially all employees of Dupre' Investments, Inc. (the "Company") and certain related companies. The Plan, as amended, complies with the applicable provisions of the Employee Retirement Income Security Act of 1974.

The Plan allows eligible participants to elect to defer a portion of their compensation as a contribution to the Plan. Employees are vested immediately in their contributions and employer contributions plus actual earnings thereon.

Employer contributions are discretionary and subject to board approval. Employer matching contributions are equal to a uniform percentage of each tier of the eligible participant's deferral. Matching contributions were made for the years ended December 31, 2024 and 2023. Profit sharing contributions are allocated based on a percentage of the eligible participant's compensation to the total compensation of all eligible participants. Forfeitures are used to reduce administrative expenses of the Plan.

The Plan allows participants to direct contributions into various investment options. Participants may change their investment options in accordance with the Plan document.

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Terms for repayment of loans range from 1 to 5 years or in excess of 5 years if proceeds are used for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at a reasonable rate determined by the administrator. Principal and interest are paid ratably through payroll deductions.

Information regarding the Plan's provisions is available to participants through the plan administrator.

(2) Summary of Significant Accounting Policies

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The difference between fair value and cost represents unrealized appreciation or depreciation of investments.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants (“participant loans”) are carried at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, respectively, notes receivable from participants included accrued interest of \$0 and \$619. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, all loans were 100% secured by balances in participant’s accounts. There is no allowance for credit losses as of December 31, 2024 or 2023.

Benefit payments are recorded when paid.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

(3) Investment Contract with Insurance Company

The Plan participates in an allocated group annuity contract with Minnesota Life Insurance Company (Minnesota Life). Minnesota Life maintains contributions in general and separate accounts. The contract is included in the financial statements at fair value as reported to the Plan by Minnesota Life. Termination of the contract can only be initiated by the Plan sponsor or Minnesota Life. Upon termination, the accumulation value of each participant’s general account would be adjusted by the difference between the market rate and the renewal funds rate as of the date of discontinuance as follows: (1) If the renewal rate exceeds the market rate, the participant’s account is adjusted by the amount the renewal rate exceeds the market rate; (2) If the market rate exceeds the renewal rate, the participant’s account is adjusted by the amount the amount the market rate exceeds the renewal rate, reduced by six times the excess. Management has evaluated the benefit-responsiveness of the contract and has determined it is not fully benefit-responsive.

(4) Tax Status

The Plan has adopted a standardized prototype document from Minnesota Life Insurance Company (the Prototype Plan) which has received approval from the IRS. The Plan has been amended since receiving the latest IRS approval; however, the Plan administrator believes that the Plan through its adoption of the Prototype Plan and its current design, is operating in compliance with the applicable requirements of the Internal Revenue Code (IRC) and is qualified as tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has undertaken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, respectively, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Fair Value Measurements

Professional standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under professional standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The general account is valued based on discounted cash flows (income approach), using the crediting rate. The crediting rate, an unobservable input, represents average renewal rates applied to new funds deposited as well as expected rollover rates and an average withdrawal factor. There have been no changes in the methodologies used to value the investments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. (9) Party-in Interest Transactions

Investments are managed by Minnesota Life Insurance Company, the custodian of the Plan; therefore, investment transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$26,155 and \$27,067 for the years ended December 31, 2024 and 2023, respectively.

(10) Plan Termination

Although it has not expressed any intention to do so, Dupre' Investments, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

(11) Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

(12) Subsequent Event Review

The Plan's management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.
