Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **CareLink 401(k) Plan (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements December 31, 2024 and 2023

NOTE 1: DESCRIPTION OF PLAN

The following description of the CareLink 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established August 1, 1999 and restated January 1, 2022, is a defined contribution plan maintained for the benefit of employees of Central Arkansas Area Agency on Aging, Inc. d/b/a CareLink (the Employer, Plan Sponsor and Plan Administrator), who have met eligibility requirements as defined in the Plan. Generally, an employee is eligible to participate in the Plan at the next entry date upon the completion of one year of service. Entry dates are January 1 and July 1.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer utilizes the services of Ascensus, a third-party administrator, to process investment transactions and maintain participant account balances. Fees paid to Ascensus totaled \$13,486 and are reported on the statement of changes in net assets available for benefits as administrative expenses. Stephens Inc. is the Plan's investment advisor. Fees paid to Stephens Inc. totaled \$23,925 and are reported on the statement of changes in net assets available for benefits as investment expense.

Certain duties related to administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Other expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$30,600 for the year ended December 31, 2024.

Contributions

Participants may contribute their annual compensation, as defined in the Plan agreement, not to exceed limitations imposed by the IRS. The Employer may make a discretionary matching contribution not to exceed 3% of the participant's compensation. In addition, the Employer may make a discretionary profit-sharing contribution. The amount of matching and profit-sharing contributions, if any, are determined annually by the Plan Sponsor. Employer contributions are also subject to limitations imposed by the IRS.

Participants who are actively employed by the Plan Sponsor on the last day of the Plan year are eligible to receive matching and profit-sharing contributions made by the Employer. In addition, a participant who dies, becomes disabled or retires after reaching normal retirement age during the Plan year is also eligible to receive Employer matching and profit-sharing contributions, regardless of hours of service completed.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's matching contributions and allocations of (a) profit-sharing contributions and (b) Plan earnings, net of certain administrative expenses. Allocations are generally based on participant earnings or participant account balances, as specified in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Vesting

Participants are fully vested at all times in their own contributions, plus actual earnings thereon. Vesting in Employer contributions and earnings thereon is based on years of service, as defined in the Plan agreement. A participant is one hundred percent vested in Employer contributions upon retirement, permanent disability or death or after three years of service.

Investment Options

Contributions to the Plan are invested as directed by participants in one or more investment options offered by the Plan. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may range from one to five years. The loans are secured by the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan Administrator. Principal and interest are paid through payroll deductions.

Forfeitures

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. Forfeitures are used first to restore forfeited account balances for reemployed participants, and any remaining amounts may be used to pay administrative expenses or reduce the profit-sharing or matching contributions for the Plan year in which the forfeiture occurred. At December 31, 2024 and 2023, forfeitures totaling approximately \$3,000 and \$200, respectively, were available for future allocations. During the year ended December 31, 2024, forfeitures totaling approximately \$7,000 were used to pay Plan expenses.

Payment of Benefits

Upon termination of service due to death, disability, retirement or any other reason, a participant (or designated beneficiary) may elect to receive benefit payments in the form of a lump-sum payment, a direct rollover to another qualified retirement plan or a partial cash distribution, as specified in the Plan agreement. Participants who terminate employment with the Employer and have an account balance of less than \$1,000 may automatically receive a lump-sum distribution, if they have not elected otherwise, as specified in the Plan agreement.

Hardship Withdrawals

In case of immediate and heavy financial hardship, participants may withdraw all or a portion of their contributions. A withdrawal shall be deemed for purposes of an immediate and heavy financial hardship if the withdrawal is necessary for certain eligible expenses, such as medical care, the purchase of a principal residence for the participant, payment of tuition and related education fees for the next twelve months of post-secondary education, payments necessary to prevent eviction of the participant from his or her principal residence or to avoid foreclosure on said residence, payments for funeral or burial expenses or expenses to repair damage to the participant's principal residence.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and Ascensus. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

The Plan Administrator considers all notes receivable from participants to be fully collectible; accordingly, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified and reported as distributions at the time they are determined by management to be uncollectible.

Payments of Benefits

Benefits are recorded when paid. There were no amounts allocated to withdrawing participants that had not been paid at December 31, 2024 and 2023.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan's mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. There have been no changes in the methodologies used to value the mutual funds at December 31, 2024 and 2023.

NOTE 5: EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in mutual funds managed by Ascensus. In addition, Ascensus charges contract administration fees which are paid by the Plan and included in administrative expenses on the statement of changes in net assets available for benefits. These transactions qualify as exempt party-in-interest transactions.

NOTE 6: TAX STATUS

The Plan executed an adoption agreement for the Friday, Eldredge & Clark, LLP Nonstandardized Defined Contribution Plan (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

NOTE 6: TAX STATUS (Continued)

The IRS has determined and informed the Prototype sponsor by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe the Plan is qualified and the related trust is tax-exempt.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

NOTE 7: RISKS AND UNCERTAINTIES

The mutual funds in which the Plan's assets are invested are comprised of investment securities, which are exposed to various risks such as interest rate, market and credit risks. Certain mutual funds may invest in foreign securities. There are certain additional risks involved when investing in foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

NOTE 8: SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date that the financial statements were available to be issued.
