## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the  
Solutions Manufacturing 401(K) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Solutions Manufacturing 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C)(ERISA Section 103(a)(3) (C) audit). DECEMBER 31, 2024 AND 2023

#### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Solutions Manufacturing 401(k) Plan (the “Plan”) is provided for general information purposes only. As of September 1, 2024, the Plan changed its name to Solutions Manufacturing 401(k) Plan from Accutron 401(k) Plan. Participants should refer to the Plan document, and any amendments for a more complete description of the Plan’s provisions.

##### General

The Plan (before September 1, 2024) is a defined contribution profit sharing plan covering all employees of Accutron, Inc. and Solutions Manufacturing, LLC (the “Company” or “Employer”) who have completed twelve months and 1,000 hours of service and are age 21 or older. After September 1, 2024, the Plan covers all employees of Solutions Manufacturing LLC who have attained 21 and ninety days of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company is the sponsor and administrator of the Plan. Empower Trust Company, LLC is the custodian of the Plan.

##### Contributions

Each year, participants may elect to contribute a percentage of their annual compensation to the plan on a pre-tax or after-tax (Roth) basis up to the maximum amount allowed by the Internal Revenue Code (the “Code”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Company makes matching contributions equal to 25% of the participant’s elective deferral contributions that are not in excess of 8% of the participant’s compensation. The Company may also make a discretionary profit-sharing contribution at the discretion of the Company’s Board of Directors. Contributions are subject to IRS limits. The Company made discretionary profit-sharing contributions of \$620,185 and \$200,000 for the years ended December 31, 2024 and 2023.

All contributions are held in trust and invested by the Plan’s custodian in accordance with the options elected by the participants (i.e. all investments are participant-directed).

##### Participant Accounts

Each participant’s account is credited with the participant’s elective deferrals, employer contributions and earnings. Participants may elect to have contributions invested in any or all of the funds of the Plan. Allocation of employer contributions, investment income and administrative expenses are based on a participant’s compensation or account balance as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### Investment Options

Upon enrollment in the Plan, a participant may direct all contributions in a variety of investment choices as more fully described in the Plan’s literature.

##### Vesting

Participants are immediately vested in their elective deferrals and rollover contributions, plus actual earnings thereon. Participants are fully vested in employer discretionary contributions upon the completion of six years of service. See Note 10 relating to a 2024 partial plan termination and effects on vesting.

##### Payment of Benefits and Withdrawals

The Plan is designed to provide benefits at the time of retirement. However, if employment with the Company is terminated because of death, disability, or any other reason, a request for distribution of a participant's account balance is allowed. If a participant dies while classified as an active member of the Plan, the participant's beneficiary or beneficiaries are entitled to receive the entire participant's vested account balance. Should a participant become totally and permanently disabled while employed by the Company, the full value of the participant's account balance may be distributed upon request.

Upon termination of employment, the vested amount of the participant's account can be distributed to the participant in a lump-sum cash payment if the participant's vested account balance is less than \$5,000. If the account balance is greater than \$5,000, the participant's written consent will be required for any distribution including the election of a rollover distribution to a new qualified plan or installment payments. Otherwise, the Plan administrator will direct the custodian to begin required minimum distributions (RMDs) no later than April 1 of the calendar year after the participant reaches their RMD age, which under the provisions of the SECURE 2.0 Act is:

- Age 73 for individuals born between 1951 and 1959
- Age 75 for individuals born in 1960 or later

Subject to certain limitations prescribed by the Plan and the Code, participants may elect hardship withdrawals. In accordance with the Code, a 10% premature distribution penalty tax may also be imposed on such withdrawals from a participant's account. Recipients of hardship withdrawals are suspended for six months after receipt of the hardship distribution from making elective deferral contributions. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59 ½.

##### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or one-half of their account balance. The loans bear interest at the prime interest rate as of the date of the loan application and are secured by the balance in the participant's account. Loans are repaid through payroll deductions in equal payments over the term of the loan (up to five years or 10 years if for a primary residence). A participant may have no more than two outstanding loans from the Plan at any time. Participant loans at December 31, 2024 and 2023 totaled \$22,683 and \$44,697, respectively.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based on the terms of the plan document.

#### NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

##### Forfeited Accounts

Forfeited accounts are amounts forfeited by participants who have terminated their employment and are not fully vested in their employer account. The Plan document permits the use of forfeitures to reduce future employer contributions, offset plan administrative expenses or be reallocated among eligible participants for the Plan year. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,726 and \$7,067, respectively.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

##### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians, and insurance companies. See Note 4 for a discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded on the cash basis, which approximates U.S. GAAP. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

##### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

##### Payment of Benefits

Benefit payments to participants are recorded when paid.

##### Administrative Expenses

Plan administration expenses are paid out of Plan assets, unless otherwise stated. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

##### Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition or disclosure. As of December 31, 2024 the Plan's tax returns generally remain subject to examination by major tax jurisdictions for the last 3 years.

##### Subsequent Events

Management has evaluated subsequent events for disclosure and /or recognition in the financial statements through the date that the financial statements were available to be issued, which was September 22, 2025.

#### NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIAN

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the custodian of the Plan, has certified that the following investment information is complete and accurate:

- Fair value of investments and the carrying amount of notes receivable from participants as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Interest and dividends, net depreciation in fair value of investments, and interest income on notes receivable from participants as reflected in the Statement of Changes in Net Assets Available for Benefits for the Year Ended December 31, 2024.
- Investment information reflected in Schedule H, Part IV, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024.

As permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to the certified investment information.

#### NOTE 4 – FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date; and

Level 3 - Inputs to the valuation methodology are unobservable, inputs in situations where there is little or no market activity for the assets or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments measured at fair value using net asset value ("NAV"), or its equivalent, as a practical expedient are not classified in the fair value hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* – These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Fixed Annuities* – These contracts are valued at fair value by the Insurance Company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issues. A variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings are used in determining the reasonableness of the methodology. Certain unobservable inputs are assessed through review of contract terms (for example, duration of payout date) while others are substantiated utilizing available market data (for example, swap curve rate). These contracts are classified within Level 2 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – EXCESS CONTRIBUTIONS PAYABLE**

Excess contributions payable are amounts refundable by the plan to participants for contributions made in excess of amounts allowed by the IRS or the Plan document due to eligibility. At December 31, 2024 and 2023, excess contributions payable were \$24,953 and \$16,302, respectively.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain plan investments were held in investments managed by the Plan Custodian, Empower Trust Company, LLC. The Plan paid fees during the year for investment advisement, investment management and other services rendered by parties in interest. Participant loans are also considered party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become one hundred percent vested in their employer contributions.

#### NOTE 8 – TAX STATUS

The Company has adopted an approved volume submitter plan which received an Internal Revenue Service (“IRS”) advisory opinion letter dated May 26, 2021 that indicated the form of the Plan satisfied the qualification requirements of the Internal Revenue Code. The plan has not been amended since receiving the opinion letter. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and, the Plan to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

#### NOTE 10 – PARTIAL PLAN TERMINATION

As a result of a reduction of the Company’s workforce due to a sale of a division, it is likely that the Plan experienced a partial plan termination as defined by Code section 411(d)(3) for the 2024 plan year. Under the Code, a partial plan termination may occur if at least 20% of eligible Plan participants are terminated by the Company within the applicable period. If a partial plan termination occurs, full vesting in the employer’s contribution is required for the affected participants, but the remaining participants’ vesting continues to be determined per the Plan provisions.

#### NOTE 11 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities and insurance contracts. Investment securities are exposed to various risks such as interest rate, market, and credit risks. There are no reserves against the insurance contracts for credit risks of the issuer or otherwise. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
