Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of the Dominion Voting Systems, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Description of the Plan

The following description of the Dominion Voting Systems, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan, which went into effect May 1, 2011, that is generally available to all employees of Dominion Voting Systems, Inc. (the “Company”, “Employer”, “Plan Sponsor”, or “Plan administrator”). The Plan excludes nonresident aliens, independent contractors, and reclassified employees. Employees become eligible to participate in the Plan upon completing 30 days of service and attainment of age 21. Employees can enter the Plan on the first of the month coincident with or after meeting the Plan’s eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Contributions. The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute a percentage of their pre-tax compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. The Plan provides for an eligible automatic contribution arrangement (“EACA”) such that an eligible employee will be auto-enrolled into the Plan and have 4% of their compensation withheld as an elective deferral contribution. Participants who are auto-enrolled under the EACA can elect a permissible withdrawal within 90 days of their first automatic deferral. A participant’s total contributions cannot exceed \$23,000 (\$30,500 if age 50 or older) in calendar year 2024.
- Discretionary Employer Matching Contributions – The Employer may make matching contributions each payroll period based on a discretionary percentage of an eligible participant’s compensation and elective deferral contributions. During 2024, the Employer made a discretionary Employer matching contribution equal to 50% of a participant’s elective deferral contributions up to a maximum equal to the lesser of (i) 6% of the participant’s compensation or (ii) \$3,000.
- Discretionary Employer Contributions – The Employer may make an additional discretionary contribution to eligible participants who are employed by the Employer on the last day of the Plan year. This contribution is allocated to each eligible participant’s account in the ratio which each participant’s compensation bears to the compensation of all eligible participants. During 2024, the Employer did not make a discretionary Employer contribution.
- Rollover Contributions – Amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan’s investment funds at the direction of the participants. The total annual additions to a participant’s account may not exceed the lesser of \$69,000 or 100% of the participant’s compensation.

Investment Options. Participants may direct their investments into various pooled separate accounts, registered investment companies, and a common collective trust.

Participant Accounts. Each participant's account is increased and/or decreased, as applicable, with the participant's contributions (elective deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (discretionary matching and discretionary, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their elective deferral contributions, rollover contributions, discretionary Employer matching contributions, discretionary Employer contributions, and related earnings thereon.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms range from 1 month up to a maximum of 5 years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest based on similar loans from commercial lending institutions as determined by the Plan administrator at the time the loan is granted. Principal and interest payments are paid ratably through payroll deductions.

Payment of Benefits. Benefits to participants or beneficiaries are generally payable as a lump-sum, annuity, partial payments, substantially equal annual payments, or a specified dollar amount each year equal to the value of their vested account balance upon retirement, termination of employment, death or disability. Participant may also elect a rollover distribution of their vested account balance into another qualified plan or Individual Retirement Account. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Additionally, participants may elect in-service withdrawals of their rollover contributions account, upon attainment of age 59 ½, or for a qualified reservist distribution.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates. The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are contract administrator, recordkeeping, and other fees. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Pooled Separate Accounts (“PSAs”) and the Common Collective Trusts (“CCT”) are valued at the net asset value (“NAV”) of units held by the Plan at year end. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSAs and CCT less their liabilities. This practical expedient is not used when it is determined to be probable that the PSAs or CCT will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.
- Registered investment companies are valued at the quoted NAV of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Withdrawals to which this restriction applies include, but are not limited to, any whole or partial withdrawal of the assets of a Participating Trust that is initiated by the employer or sponsor of the Participating Trust, including without limitation, the termination of the Participating Trust, the withdrawal of its assets from the Fund, or certain communications designed to instigate redemptions as described in the SV Fund disclosure document. The Trustee may choose to disburse withdrawals as of a Valuation Date earlier than the valuation date provided if the Trustee determines, in its discretion, that the withdrawal is not detrimental to the best interest of the SV Fund and plans participating therein.

Note 4 – Certified Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodians of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment amounts, as shown in Note 3;
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- The investment information presented in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedule.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

Note 6 – Tax Status

The Plan Sponsor has adopted a Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received an opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are units of pooled separate accounts and a common collective trust offered by Principal Life Insurance Company ("Principal Life") and Principal Global Investors Trust Company ("Principal Global"). As Principal Life, Principal Global, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company are the custodians of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 8 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in registered investment companies, pooled separate accounts, and a common collective trust. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, there were four investments, respectively, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 9 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 29, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan document was amended for the following:

- Increased the automatic enrollment from 4% to 6%,
- Add an automatic escalation where participants will be automatically increase each March 1st by 1% per year up to a maximum of 10%,
- Hardship distributions were added, and
- In-Plan Roth rollovers were added.
