Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Renaissance Lakewood, LLC. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The initial effective date of the plan adoption was January 1, 2016, with an elective deferral to start effective June 15, 2016. The Plan is a spin-off from the Renaissance 401(k) Plan and DPT Laboratories, Ltd. 401(k) Plan which was originally effective July 1, 2012. The plan was amended on April 26, 2017. The effective date of this amendment is April 1, 2017. Any participants laid-off between February 2, 2017 and March 10, 2017 have become 100% vested. In addition, vesting percentages were selected (see Note 1 *Vesting*).

General

The Plan is a defined contribution plan that covers substantially all employees of Renaissance Lakewood, LLC. who have completed one month of service and are age 18 or older. Certain employees of the company are members of a union that provides retirement benefits. Those employees are not eligible to participate in the Plan. Newly eligible participants and existing participants who are not contributing to the plan and have not made an election are to be automatically enrolled in the Plan once they have completed one month of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

Contributions

The Company may, at its discretion, make a primary matching contribution of the participant's contribution, equal to a discretionary percentage, to be determined by the Company, of the participant's annual compensation, as defined by the plan. For 2024 the Company matched the participant's contribution to the lesser of 50% of deferrals or 5% of the participant's eligible compensation. Participants eligible to receive matching contributions are those that have completed 1,000 hours of service during the plan year, are age 18 or older, and are employed on December 31 for the plan year ended. Secondary profit-sharing amounts may be contributed at the option of the Company's management. No secondary profit-sharing amounts were made for 2024. The Company's contributions are subject to certain limitations.

Participants may elect to contribute up to the annual maximum amount allowed by the Internal Revenue Code (IRC). The Plan contains an automatic deferral feature in which the participant will be automatically entered into the Plan, once eligible, at a contribution rate of 6% of compensation, as defined by the Plan. If participants do not choose a different percentage, the percentage will be automatically increased each July 1 by 1% up to a maximum of 10%. Participants can make an election not to participate, or to choose a different percentage deferral. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

Participant Accounts

Participants may direct the investment of their contributions into various fund options offered by the Plan. Participants may change their investment options in accordance with Participant Direction Procedures as established by the Plan administrator. If a participant is automatically enrolled, the Plan includes a qualified default investment alternative. Company contributions are allocated to the participant's investment options in the same manner as that of the participant's elective contributions.

Each participant's account is credited with the participant's contribution(s) and allocation of the Company's contribution(s), Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and actual earnings thereon. Vesting in the Company's contribution portion of their accounts are vested immediately as of January 1, 2024.

Participant Loans Receivable

Participants may borrow from their fund accounts. The Plan administrator shall be authorized to establish a participant loan program to provide for loans under the plan. The loan program shall be established in accordance with Department of Labor Regulation section 2550.408(b)-1(d)(2) providing for loans by the Plan to parties-in-interest under said Plan, such as participants or beneficiaries. The loans are secured by the balance in the participant's account and bear interest, as determined by the Plan administrator. Principal and interest are paid via payroll deductions.

Loans receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution payment is recorded.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions payable at December 31, 2024.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's interest in their account, substantially equal installments, or partial withdrawals as determined by the plan. Any balance under \$5,000 is automatically paid out as is practical. In-service and hardship withdrawals are available in certain circumstances as defined by the Plan.

Forfeitures

Participant forfeitures of non-vested balances will be used to reduce any future employer contributions and pay the expenses of the Plan. During 2024 there were \$0 unallocated forfeitures applied. In the event there are no employer contributions or Plan expenses for which the forfeitures can be used, the forfeitures are allocated to the participants per the Plan agreement.

Administrative Expenses

Administrative expenses may be paid out of the Plan assets unless they are paid by the Plan sponsor. Loan administration fees are to be paid by the loan participant.

Termination of Plan

The employer shall have the right at any time to terminate the Plan by delivering to the trustee and plan administrator written notice of such termination. Upon any full or partial termination or upon the discontinuance of the employer's contributions to the Plan, all amounts credited to the affected Participant's combined accounts shall become 100% vested and shall not be subject to forfeiture.

NOTE 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be recognized to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

NOTE 3 - Information Certified and Provided by Principal Life Insurance Company

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company ("Principal"), the custodian, has certified the following information included in the accompanying financial statements and supplemental schedule:

- Investments and loans receivable from participants, as shown in the statement of net assets available for benefits and related disclosures as of December 31, 2024
- Investment income and interest income on loans receivable from participants, as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 - Fair Value Measurements

The Financial Accounting Standards Board (FASB)'s Accounting Standards Codification (ASC), ASC 820 *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB's ASC 820, *Fair Value Measurements and Disclosures*, are as follows:

- **Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- **Level 2:** Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices for the asset or liability that are observable
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means
 - If the asset or liability has a specified term, Level 2 inputs must be observable for substantially the full term of the asset or liability
- **Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value: Pooled separate accounts are primarily valued at NAV per share based on quoted market prices of underlying investments.

The method above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments may result in a different fair value measurement at the reporting date.

NOTE 5 - Party-In-Interest Transactions

Certain Plan investments are managed by Principal. Principal is the custodian, as defined by the Plan and; therefore, these investments qualify as party-in-interest transactions. The Plan sponsor paid certain administrative expenses related to the Plan for the year ended December 31, 2024.

NOTE 6 - Tax Status

Accounting principles generally accepted in the United States of America require Plan management to evaluate certain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no tax examinations for any tax period in progress.

The Plan was restated for the 2021 plan year. While the restated Plan document does not have a determination letter from the IRS, the Plan management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 - Risks and Uncertainties

The Plan invests in various types of investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
