Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Midwest Family Mutual Insurance Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Midwest Family Mutual Insurance Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

A. Description of the Plan

The following description of Midwest Family Mutual Insurance Company ("The Company") 401(k) Plan ("The Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of the Company who are age 18 or older with one month of service for non-elective contributions, defined as 1,000 hours, and is designed to provide retirement benefits. For elective and matching contributions, eligibility is reached after completion of one month of service and the employee has attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Each year, participants may contribute up to 100% (subject to an annual limit) of pretax annual compensation, as defined in the Plan, beginning the first day of the month after their hire date. The Plan also has a Roth feature that allows participants to make contributions from after-tax compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Each year, the employer may make a discretionary non-elective contribution to the Plan, historically amounting to 50% of eligible employee deferrals up to 8% of qualifying wages. Participants who have attained age 50 before the end of the Plan year are allowed to make catch-up contributions. Participants direct the investment of their contributions and any matching contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 8% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Unless participants elect otherwise, deferrals increase by 1% each January 1, until their deferral rate is 15%.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of Plan earnings and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

4. Vesting

Participants are vested immediately in their contributions plus actual earnings on the contributions. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 4 years of credited service. The vesting schedule of employer contributions is as follows:

Forfeitures of non-vested employer contributions may be used to pay administrative expenses or to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts were \$16,277 and \$23,095, respectively. Forfeitures applied to employer contributions during 2024 and 2023 were \$18,010 and \$8,585, respectively.

5. Notes Receivable – Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Interest rates on loans were between 4.25% and 9.50% for 2024 and 4.25% and 8.00% for 2023, and have maturity dates through 2036 at December 31, 2024. Principal and interest is paid ratably through bi-weekly payroll deductions.

6. Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments in the form of an annuity.

7. Administrative and Operating Expenses

The Company pays all administrative and operating expenses of the Plan with the exception of mutual fund fees paid to Principal under their service agreement, hardship withdrawal penalties, and expenses related to participants who terminated. Mutual fund fees are paid by the Plan, and hardship withdrawal penalties and termination expenses are passed on to the participant as a reduction of their benefit received, as well as any qualified domestic relations orders.

8. Investments

The Plan's investments consist of mutual funds, pooled separate accounts, and collective trusts held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. Investments are maintained in the accounts as directed by the participants.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The value of each account is based on the quoted share price or net asset value of the shares invested in each fund. Net earnings on investments include realized and unrealized gains and losses and interest and dividends recorded on an accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Unsettled trades are recorded as a liability for the net settlement amount.

Notes Receivable – Participant Loans

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as deemed distributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses pursuant to a service agreement with Principal Life Insurance Company are paid by the Plan and its participants through reduced investment returns. Principal also receives revenue from mutual fund service providers for services that Principal provides to the funds. This revenue is used to offset the cost of professional investment management and marketing costs.

Reclassifications

Certain reclassifications to the 2023 financial statements have been made to conform to the 2024 presentation.

C. Certification

The Company has obtained certifications from Delaware Charter Guarantee and Trust Company (d/b/a Principal Trust Company) in 2024 and 2023 that the following information is complete and accurate:

Investment Income
Market Value of Investments
Participant Loans

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair values hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. These funds are actively traded and are required to publish their daily net asset value and to transact at that price.

Common/Collective Trust Funds: Valued at the NAV of the units by such trust, which is considered by Plan management to be fair value. The unit value of the trust is calculated daily.

Pooled Separate Account: Valued based on the fund's daily NAV, which is considered by Plan management to be of fair value. The unit value of the funds is calculated daily.

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

E. Related Party Transactions

Certain Plan investments are managed by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company (d/b/a Principal Trust Company). The Plan also has a service agreement with Principal Financial Group, who also receives revenue from mutual funds for services they provide to the funds. Delaware Charter Guarantee and Trust Company (d/b/a Principal Trust Company) is the plan custodian, and therefore, these transactions qualify as exempt party-in-interest transactions.

F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

G. Tax Status

The Plan adopted a prototype profit sharing plan document of the Principal Financial Group which obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

I. Plan Amendment

Effective October 10, 2024, the automatic escalation maximum deferral limit was increased from 10% to 15%. The plan amendment also made effective the ability to perform Roth conversions within the plan.

J. Subsequent Events

The Plan has evaluated events and transactions occurring after December 31, 2024, for potential items required to be recognized or disclosed in the financial statements. Subsequent events were evaluated through October 6, 2025, the date the financial statements were available to be issued.
