A. Description of the Plan

The following description of Meyer Sound Laboratories, Inc. (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

1. **General.** The Plan is a defined contribution plan covering all full-time employees of the Company. Employees (participants) are eligible to participate in the Plan on the first day of the new quarter (January 1st, April 1st, July 1st, and October 1st), after completing three months of service and have attained age twenty-one. Effective on 4/1/2024, the entry dates have been changed to immediate or first pay period after the eligibility requirements have been met. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. **Contributions.** Participants may contribute a percentage of their compensation each year not to exceed the dollar limit set by law. The limit for year ended December 31, 2024 is \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to an additional \$7,500. Participants may be permitted to contribute distributions from other qualified defined-benefit or contribution plans. Effective on 4/1/2024, Roth deferral is added to the plan. Each year the company will contribute the following amounts:
 - a. The total amount of the salary reduction deferred by the participant.
 - b. A discretionary matching contribution equal to a percentage of the amount of the salary reduction of the participant, which percentage will be determined each year by the company.
 - c. A discretionary amount determined each year by the company.
3. **Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary profit-sharing contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Payment of Benefits.** On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Either for termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump- sum distribution.
5. **Vesting.** Participants are vested immediately in their salary reductions contributed to the plan plus actual earnings thereon.

6. **Vesting.** Vesting in the Company's contribution portion of their accounts is based on years of continuous service. The vesting schedule is as follows:

7. **Note Receivable from Participants (Loans).** Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.
8. **Forfeited Accounts.** Forfeitures of non-vested Company contributions may be used, subject to an election by the plan administrator, to pay all or any portion of administrative expenses incurred by the plan. Any such expenses not paid out of forfeitures can be used to restore previous forfeitures of participants' accounts. Any such forfeiture balance that is not used to pay administrative expenses or restore participant accounts will be used to reduce employer contributions. There was no forfeiture in 2024, and a total of \$409 was recorded for 2023.
9. **Subsequent Events.** The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.
10. **Administrative Expenses.** Certain expenses incurred in the administration of the Plan are paid directly by the Company.

B. Summary of Significant Accounting Policies

Accounting Method

The financial statements of the plan were prepared using the accrual method of accounting. This method, which recognizes receivables and payables, results in the recognition of income when earned and expenses when incurred.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported

amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable (loans) from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company, except for fees related to notes receivable from participants. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

C. Information Certified By the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustees, American United Life Insurance Company, have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.

D. Fair Value Measurements

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value of Financial Instruments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset of liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024, and 2023.

Registered Investment Companies – Valued at the net asset value (“NAV”) of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Stable Value Fund

In 2020, the Plan entered into a fully benefit-responsive contract with American United Life Insurance Company (AUL) totaling \$864,950 and \$1,916,490 at December 31, 2024 and 2023, respectively. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The interest rate is based on a formula established by the contract and was 1.75% and 1% for 2024 and 2023, respectively.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. The contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on AUL's ability to meet its financial obligations. AUL's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

F. Risk and Uncertainties

The Plan invests in various investment securities (mutual funds) which are exposed to the market, credit, and interest rate risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values on investment securities will occur in the near term and that such changes could materially affect the participant account balances and the amounts reported in the statement of net assets.

G. Tax Status

The company operates the Plan in accordance with a prototype plan document. The Internal Revenue Service has determined, in a letter dated October 20, 1997, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Since receiving its initial determination letter the plan has been amended. The Internal Revenue Service has again determined, in a letter dated January 20, 2005, that the amended prototype plan and related trust are designed in accordance with applicable sections of the IRC. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the Plan has taken an

uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in question. The plan administrator believes it is no longer subject to tax examinations for years prior to 2019.

H. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.
