**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**A. DESCRIPTION OF PLAN**

The following description of Southeastern Container, Inc. (“the Company”) Retirement Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. **General.** The Plan is a defined contribution plan covering all full-time employees of the Company who have completed 60 days of service. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.
2. **Auto Enrollment.** Newly eligible employees are automatically enrolled in the Plan at a deferral rate of 6%. Participants can change their deferral rate at any time. Employees may also waive entry to the Plan by signing a waiver and providing it to the Plan sponsor.
3. **Contributions.** Each year, participants may elect to contribute pre-tax deductible or after-tax nondeductible portions of his or her eligible compensation, as defined in the Plan, by any percentage up to a maximum amount which will not cause the aggregate contribution to the Plan to violate certain provisions of the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will contribute a safe harbor match of 100% of employee contributions up to 6% of the covered employee’s eligible compensation.

Employer contributions to the Plan are made for each pay period based on the Plan matching requirements described above.

4. **Participant Accounts.** Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s matching contributions and (b) Plan earnings (losses) less an allocation of investment fund expenses and administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
5. **Vesting.** Participants are immediately fully vested in their contributions and the employer contributions contributed plus actual earnings (losses) thereon.
6. **Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment account from (to) the participant loan account. Interest on loans is set at prime plus 1% and the loans must be paid off within 60 months. Loans are secured by the balance in the participant’s account and are limited to five per rolling 12-month period; only one loan may be outstanding at any given time. Principal and interest are to be paid ratably through periodic payroll deductions.

7. **Payment of Benefits.** Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments not to exceed 15 years. For termination of service due to other reasons, a participant may only receive the value of the vested interest in his or her account as a lump sum distribution.
8. **Forfeited Accounts.** There were no unallocated forfeitures as of December 31, 2024 and 2023.

**B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/ depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value in investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**C. CERTIFIED INVESTMENTS**

All information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the custodian of the Plan).

**D. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1    Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2    Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3    Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** The fair value of investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective investment trust:** This investment is a public investment vehicle valued using NAV provided by the administrator to the fund as a practical expedient. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The collective investment trust is not classified within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**E. COLLECTIVE INVESTMENT TRUST**

The Plan invests in a collective investment trust offering, the Vanguard Fiduciary Trust Company Retirement Savings Trust III (“the Fund”). The Fund is a collective trust fund with investments in contracts at fair value of the underlying investments, and then adjusted by the issuer to NAV. The Fund primarily invests in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at NAV. NAV represents contributions made to the Fund, plus earnings, less participant withdrawals. The risk of the collective trust and its net realizable value are dependent upon the financial stability of the issuing entity and its ability to fulfill the terms of the contract. For the Fund, there were no reserves established against contract value for credit risk at December 31, 2024 and 2023.

**F. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and collective investment trusts managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the custodian and third party administrator and, therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Parties-in-interest to the Plan include service providers such as the investment broker, the custodian of Plan assets, the third party administrator, the auditor, and the trustee. The broker, custodian, and administrator are outside service providers whose services are governed by signed agreements and paid by the Plan. The auditor's fees are paid by the Plan sponsor without using Plan assets. The trustee of the Plan is not compensated for serving in the capacity of fiduciary overseer, although as an employee of the sponsor, the trustee is also a Plan participant.

The Plan sponsor is the final party-in-interest to the Plan. All employer contributions are sourced from the sponsor, and all employee contributions are received from employees of the sponsor.

**G. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer accounts.

**H. TAX STATUS**

The underlying prototype non-standardized plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code, and therefore, the related trust is tax-exempt. The Company has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Currently, the statute of limitations remains open subsequent to and including 2021; however, no examinations are in process or anticipated.

**I. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
