INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the Agfa Corporation Employee Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Agfa Corporation Employee Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Agfa Corporation Employee Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

[1] General:

The Plan is a participant-directed, defined-contribution benefit plan, which was established and became effective December 1, 1999, as a successor plan of the Bayer Corporation Employee Savings Plan. The Plan covers all eligible union and non-union employees, as defined, of Agfa Corporation (the “Company”), and certain affiliates that have adopted the Plan. Employees are eligible to enter the Plan on their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, and the Internal Revenue Code of 1986 (the “Code”), as amended.

The Plan was amended and restated in its entirety effective January 1, 2015. The amended and restated Plan serves the purpose of incorporating amendments since its last restatement to bring the Plan into compliance with changes in the law described in Internal Revenue Service (“IRS”) Notice 2008-108.

Pursuant to an amendment effective April 1, 2018, and pursuant to an asset purchase agreement whereby the Agfa Healthcare Corporation spun off its imaging business unit to Agfa US Corp. effective April 1, 2018; Plan accounts of certain selected long-term disabled and former imaging employees and eligible imaging employees employed immediately prior to April 1, 2018, who became employees of Agfa US Corp. were transferred from the Agfa HealthCare Corporation Employee Savings Plan to the Plan.

In April 2023, the Company sold a division of its business, which resulted in a group of participants, and their associated balances of approximately \$25,300,000, being transferred out of the Plan into a newly created plan for the newly formed business.

[2] Plan administration:

The Benefit Plan Administrative Committee consists of certain representatives of the Company as administrators of the Plan. Vanguard Fiduciary Trust Company (“Vanguard”) serves as the trustee and record-keeper of the Plan.

[3] Contributions:

Participants can contribute 1% to 50% of their compensation, as defined, plus eligible catch-up contributions, subject to certain limitations. In the aggregate, before-tax, Roth and after-tax contributions cannot exceed 50% of annual compensation, plus catch-up contributions. Participants may roll over distributions received from other qualified plans. Pursuant to an automatic enrollment provision, a participant’s earnings are automatically reduced and contributed to the Plan as of the automatic enrollment date by 6% in the initial automatic enrollment year (subsequently increasing by 1% per year for each subsequent year until reaching 20%), unless the participant makes a different election or opts out prior to or after the automatic enrollment date.

The Company’s matching contribution for non-union employees is 100% of the first 3% of eligible compensation contributed to the Plan, plus 50% on the next 3% of eligible compensation contributed to the Plan. The matching Company contribution is invested proportionate to the participant’s contributions. Contributions are subject to certain limitations.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[3] Contributions: (continued)

The Plan Sponsor may elect to fund a discretionary contribution, up to 3% of eligible compensation, for those non-union eligible employees employed as of December 31 each year. For both 2024 and 2023, there were no discretionary employer contributions.

Effective January 1, 2015, the Plan was amended to allow the Company to make a union employee Company contribution at a specified percentage based on the union employee's age. A "Future Union Employee", defined by the Plan as a union participant who was hired or rehired after July 1, 2014 and is currently employed by the Company, becomes eligible after a 45-day probationary period.

Pursuant to an amendment effective April 1, 2018, an additional classification of union employee was defined. The classification is "New 2017 Carlstadt Union Employee" meaning a Carlstadt union participant who was hired or rehired on or after July 1, 2017 and is currently employed. The amendment also amended the Plan, effective July 1, 2017, to allow the Company to make a union employee Company contribution of 4.5% of compensation for each payroll period on behalf of each of its 2017 Carlstadt Union Employees after a 45-day probationary period is completed.

[4] Investment options:

The participants are permitted to direct the Plan investments into one or more of several investment alternatives, which currently comprise mutual funds, a common/collective trust, and money market funds.

[5] Vesting:

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's matching, discretionary and union Company contribution portion of their account, plus actual earnings thereon, is based on years of service; with the exception of union Company contributions to "Current Union Employees", defined by the Plan as a union participant who has been continuously employed by the Company since July 1, 2014, who are fully vested immediately, otherwise, a participant is 100% vested after three years of vesting service, or upon reaching normal retirement age (as defined), death, or termination of the Plan (as defined). In previous years it had been determined that the Plan was in a partial termination due to downsizing at the Company. Participants who were involuntarily terminated during certain prior periods and still had a balance in the Plan are considered fully vested. The Company fully vested participants who voluntarily terminated during those certain prior periods, in accordance with IRS guidance in effect at the time.

[6] Distributions and withdrawals:

Each participant is entitled to withdraw amounts in his/her participant account if the withdrawal is (a) after the participant's attainment of age 59½, (b) because of financial hardship, or (c) because of separation from service. A participant may withdraw his or her vested contributions, after-tax contributions, rollover contributions, and accounts transferred from a merged plan, subject to restrictions described in the Plan. Upon termination from employment, if a participant's account is \$1,000 or less, the participant will automatically receive a lump-sum payment, unless the participant elects otherwise. If the participant's account is greater than \$1,000 but not more than \$5,000, the participant's account will automatically be transferred to an Individual Retirement Account unless the participant elects otherwise. If the participant's account is greater than \$5,000, the participant may elect to have distributions paid in lump sum, direct rollover, in equal installments over a period of not more than 15 years, or partial distributions no less than \$500. Distributions are made in cash.

[6] Distributions and withdrawals: (continued)

The Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was signed into law on March 27, 2020 and provided optional distribution and loan provisions, as well as suspension of required minimum distributions (“RMDs”) for anyone required to receive an RMD in 2020. The Plan Sponsor has implemented the following provisions of the CARES Act and the Plan will be formally amended prior to December 31, 2025 as required by the Act, as amended.

Participants, who met specific conditions, were eligible to take a COVID-19 related distribution up to \$100,000 without a 10% early withdrawal penalty. Eligible distributions could be taken from January 1, 2020, through December 31, 2020, and be repaid within three years. The repayments were treated as tax-free rollovers into the participant’s account.

The Plan Sponsor elected to suspend paying RMDs to participants and beneficiaries that would otherwise be required to receive an RMD in 2020. However, participants and beneficiaries had a choice between receiving and not receiving the RMD for 2020. In addition, individuals that received an RMD prior to the enactment of the Act had until August 31, 2020, to rollover the RMD to an eligible retirement plan.

[7] Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

[8] Participant accounts:

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) Plan earnings (losses), may be charged with a per capita fee, and depending on the participant’s investments, an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

[9] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate of prime, as defined. Interest rates on outstanding loan balances ranged from 3.25% to 8.5% at both December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Participants, who met specific conditions, were eligible to take a COVID-19 related loan up to \$100,000 (an increase from \$50,000 previously allowed) for the period March 27, 2020 to September 22, 2020. Loan repayments due between March 27, 2020 and December 31, 2020 were suspended until January 1, 2021 for eligible participants, with the repayment amount re-amortized and the due date of the loan extended for up to 1 year.

[10] Forfeitures:

Forfeited non-vested accounts may be used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$44,038 and \$186,500, respectively, were used to reduce employer contributions. Forfeited non-vested accounts available at December 31, 2024 and 2023 were \$78,995 and \$4,264 respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of presentation:

The financial statements are prepared on the accrual method of accounting.

[2] Investment valuation and income recognition:

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[3] Payment of benefits:

Benefits are recorded when paid.

[4] Plan expenses:

Certain costs and expenses incurred in connection with the general administration of the Plan and the associated underlying trust are chargeable to the Plan. Certain other administrative costs associated with the Plan are paid by the Company. Participants who take a loan from the Plan incur a one-time fee for establishing the loan and an annual loan fee, which is charged directly to the individual participants' accounts.

[5] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard Fiduciary Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of shares held by the Plan at year-end, as a practical expedient. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding. The unit price is based on underlying investments, which are either traded in an active market or based on observable inputs such as market interest rates and quoted prices for similar securities. Participants can transact daily at NAV. If the Plan were to make a full accumulated book value withdrawal from the Vanguard Retirement Savings Trust III, a 12-month notice is required. For participant level transactions relating to the Vanguard Retirement Savings Trust III, reinvesting in a competing investment is prohibited for 90 days. The fund invests primarily in synthetic investment contracts backed by high-credit-quality fixed income investments and traditional investments issued by insurance companies and banks. The fund seeks to achieve its objective by diversifying among high-credit-quality investments and investment contracts that are structured to smooth market gains and losses over time.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE E - TAX STATUS

The IRS has determined and informed the Company by a letter dated June 27, 2017, stating that the Plan is qualified under the Internal Revenue Code ("IRC") and therefore the related trust is exempt from taxation. The Plan has been amended since receiving the tax determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE F - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are shares of mutual funds and a common collective trust managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the Plan trustee and record keeper and, therefore, these transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$96,000 and \$132,984 for the years ended December 31, 2024 and 2023, respectively. Annual recordkeeping fees are \$75 per participant, of which a portion is paid by participants and a portion is paid by revenue sharing credits, as defined.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE I - SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan implemented the "Super Catch-Up Contribution" provision of the SECURE 2.0 Act. This provision allows participants who attain ages 60 through 63 during the calendar year to make catch-up contributions up to \$11,250. Although the Plan has not yet been formally amended to reflect this provision, the Plan Sponsor intends to amend by the deadline of December 31, 2026.
