## REPORT OF INDEPENDENT PUBLIC ACCOUNTANTS

To the Plan Participants and Plan Administrator of  
The Middle River Aerostructure Systems Salaried Savings Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Middle River Aerostructure Systems Salaried Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal controls-related matters that we identified during the audit.

### 1. DESCRIPTION OF THE PLAN

The following brief description of The Middle River Aerostructure Systems Salaried Saving Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by MRA Systems, LLC (the Company). The Plan covers substantially all salaried employees of the Company. The Plan is subject to applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Middle River Employee Benefits Committee is responsible for oversight of the Plan. The Middle River Employee Benefits Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2022, the Plan was amended and restated.

#### **Recent Legislation**

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate relevant legislative changes in its Plan document by the prescribed deadlines.

#### **Contributions**

Participants may elect to make contributions each Plan year in the amount between 1% to 25% of their eligible compensation on a pre-tax or after-tax basis, subject to limitations imposed by law. Participants may also contribute amounts as rollover provisions representing distributions from other qualified defined benefit or defined contribution plans of a former employer. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Effective January 1, 2023, the Plan provides for employer matching contributions in an amount equal to 50% of participant contributions for eligible employees of up to 8% of their eligible compensation for all salaried employees and all salaried employees are eligible to receive an additional Company Retirement Contribution (CRC) equal to 3% of eligible compensation.

### 1. DESCRIPTION OF THE PLAN (continued)

#### Contributions (continued)

Prior to January 1, 2023, the employer matching contributions was 50% of participant contributions up to 7% of eligible compensation for salaried employees hired or rehired before January 1, 2013, and 50% of participant contributions up to 8% of eligible compensation for salaried employees hired or rehired on or after January 1, 2013. In addition, certain eligible employees hire or rehired on or after January 1, 2013 received the CRC.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, employer matching and CRC contributions, and Plan earnings and may be charged with certain loan and distribution administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The participant is entitled to a benefit that cannot exceed the participant's vested account.

#### Vesting

Participants are immediately fully vested in their employee contributions, any employer matching contributions and related investment results. Participants receiving CRCs and related earnings become 100% vested in the contributions at the earlier of reaching 3 years of eligible service or age 65 while employed with the Company.

#### Payment of Benefits

Participants are allowed to withdraw all or a portion of their unmatched after-tax contributions and rollover contributions, including earnings, at any time. Before-tax contributions may not be withdrawn while employed by the Company prior to age 59 1/2. Employer matching contributions and CRC may not be withdrawn while a participant is employed by the Company prior to retirement age. Pursuant to the SECURE Act, effective January 1, 2020, the age at which required minimum distributions must begin was increased for participants born on or after July 1, 1949 (from age 70 1/2 to age 72). Pursuant to SECURE 2.0, the required minimum distribution age increase from age 72 to age 73, effective January 1, 2023.

In the case of a hardship, a participant may elect to withdraw, as applicable, all or a portion of pre-tax contributions, including earnings, and matched after-tax contributions, including earnings. In order to make a hardship withdrawal, a participant must first withdraw the maximum unmatched after-tax contributions and rollover contributions.

On termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, or a direct rollover.

### 1. DESCRIPTION OF THE PLAN (continued)

#### Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 minus the highest outstanding balance of loans from any plan sponsored by the Company during the past 12 months or 50% of their vested account balance, subject to a \$500 minimum (except with respect to amounts attributable to any CRC, which are not available for loans). Principal and interest are paid by check or payroll deduction. Notes receivable from participants bear interest at a rate that reflects the current market rates charged by financial institutions for similar loans. The loans are secured by the balance in the participant's account.

#### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$66,845 and \$37,655, respectively. These accounts will be used to pay Plan expenses or to reduce future employer contributions. For the year ended December 31, 2024, \$27,677 was used to reduce the employer contributions and pay Plan expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Middle River Employee Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

#### **Investment Valuation and Income Recognition** (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are paid when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Contributions**

Employee contributions are recorded in the period that the Company makes payroll deductions from the participant's earnings.

Employer matching contributions and discretionary non-elective contributions are accrued at year-end and are credited to participants' accounts no later than the time (including any extensions thereof) prescribed by law for filing the Company's federal tax return for the Plan year for which the employer contributions are made.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### Administrative Fee Credit Account

Periodically, certain revenue sharing payments (e.g., 12b-1 fees, etc.) received from certain of the Plan's investment options. The revenue sharing payments may be recorded as Plan servicing credits in the Plan's dedicated administrative fee credit account or reallocated directly to participant accounts. Amounts deposited in the administrative fee credit account are used to pay on-going administrative expenses of the Plan.

For the year ended December 31, 2024, \$9,311 was used to offset recordkeeping invoices of the Plan. The dedicated administrative fee credit account gained \$9,295 in investment returns for the year ended December 31, 2024. As of December 31, 2024 and 2023, the dedicated administrative fee credit account balance was \$1,512 and \$1,528, respectively.

#### Subsequent Events

The Plan Administrator evaluated subsequent events and transactions through September 9, 2025, the date these financial statements were available for issue, and has determined that no material subsequent events have occurred, that would affect the information presented or require additional disclosure.

### 3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by the Company or Plan Administrator and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

### 4. FAIR VALUE MEASUREMENTS (continued)

The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price and are deemed to be actively traded.

*Stable value collective investment trust:* Valued at the daily closing price of the underlying assets as reported by the fund. The common collective trust held by the Plan publishes its NAV daily and transacts at that price.

### 5. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### 7. TAX STATUS

The IRS has determined and informed the Company by a letter dated October 22, 2013 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code).

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

### **7. TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **8. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
