Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Midwest Family Mutual Insurance Company Defined Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, the statement of accumulated benefits as of December 31, 2023, the related statement of changes in accumulated plan benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Midwest Family Mutual Insurance Company Defined Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

A. Description of the Plan

The following is a brief description of the Midwest Family Mutual Insurance Company Defined Benefit Pension Plan (the Plan). Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined benefit pension plan covering substantially all employees of Midwest Family Mutual Insurance Company (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee is eligible to participate in the Plan when they have completed one year of service (containing at least 1,000 hours worked) and have attained the age of 21.

Pension Benefits

Employees are entitled to annual pension benefits beginning at normal retirement age (65). The accrued benefit shall be an amount equal to (a) the Participant's Accrued Benefit as of February 27, 2023, determined according to the provisions of the Plan in effect on February 27, 2023, and excluding Compensation Years ending after December 31, 2022, plus (b) the Participant's Accrued Benefit determined on and after February 28, 2023, equal to (1) 1.47% of the Participant's Average Compensation not in excess of the Participant's Integration Level, plus (2) 1.85% of the Participant's Average Compensation in excess of the Participant's Integration Level, multiplied by (3) the Participant's Accrual Service earned on and after January 1, 2023 (not to exceed 35 years). For purposes of applying the 35-year limit on Accrual Service in (b)(3), Accrual Service earned before January 1, 2023, shall be counted.

The integration level compensation is covered compensation for the 5th plan year preceding the year the benefit is determined (covered compensation is the average of the Social Security taxable wage bases for each calendar year during the 35-year period ending with the year in which the participant attains normal Social Security retirement age). The Plan permits early retirement at age 55, if the employee has completed 4 years of service with the Company with accrued benefits reducing 1/15 for each of the first 5 years, and 1/30 for each of the next 5 years that commencement of payment precedes normal retirement date. Generally, employees may elect to receive the value of their accumulated plan benefits as a lump-sum distribution upon retirement or they may elect to receive their benefits as a life annuity payable monthly from retirement. Participants no longer working for the Company, may upon election, receive the value of their vested benefit in a single sum, if the value of their benefit is \$25,000 or less.

Funding Policy

No participant will be required to make any contributions to the Plan. The sole source of benefits will be Company contributions. The Company's funding policy is to make annual contributions to the Plan in amounts to fully provide for all employees' benefits by the time they retire. The contribution is calculated to meet the minimum funding requirements. Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Death and Disability Benefits

The death benefit payable to the beneficiary of a vested participant who dies before the date that benefit payments are scheduled to commence will be equal to 100% of the actuarial equivalent of their accrued benefit in cash or annuity. An active participant who has become totally and permanently disabled for a period of at least six months is eligible for a benefit of the actuarial equivalent of their accrued benefit at their disability retirement date in the form of a single life annuity with a 10 year certain period.

Vesting

Participants vest at varying levels dependent on years of service as follows:

B. Summary of Significant Accounting Policies**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions

Contributions are accounted for in the year for which they apply.

Valuation of Investments and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Fees

Administrative fees pursuant to a service agreement with Principal Life Insurance Company, are paid either by the Plan or the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in the net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Reclassifications

Certain reclassifications to the 2023 financial statements may have been made to conform to the 2024 presentation.

C. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are future benefit payments, including lump-sum distributions, which are attributable under the Plan's provisions to employees' service rendered to the valuation date. Accumulated plan benefits comprise of benefits expected to be paid to a) retired or terminated employees or their beneficiaries, b) beneficiaries of deceased employees, c) disabled employees and d) present employees or their beneficiaries. Compensation used to determine a participant's benefit is the average of an employee's monthly compensation for all compensation years ending after December 31, 2022.

The accumulated plan benefits for active employees will equal the accumulation of annual benefit accruals as of the benefit information date. Benefits payable under all circumstances - retirement, death, and termination of employment are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by an actuary from Principal Life Insurance Company and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements for items such as death or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of January 1, 2024, were (a) life expectancy of participants (the Society of Actuaries RP-2014 White Collar Generational Employee and Healthy Annuitant tables projected with mortality improvement Scale MP-2014), (b) retirement age assumptions (the Society of Actuaries 2003 Small Plan Aggregate Turnover Table by age 55 through 69, with 100% at 70 with termination rates now stopping at 54), and (c) investment return. The January 1, 2024, valuation included interest rates of 4.75% for participants in years 0-5 of service, 4.87% in years 5-20, and 5.59% thereafter. The assumed rate of asset return was 6.25%. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

The computation of the actuarial present value of accumulated plan benefits was made as of January 1, 2024. Had the valuation been performed as of December 31, 2023, there would be no material differences.

D. Plan Termination

In the event of termination of the Plan, the net assets are to be set aside for the benefit of participants in the order of priority described in the Plan and as prescribed by ERISA and its related regulations. Should the Plan terminate at some future time, its net assets might not be sufficient, on a pro rata basis, to provide participants benefits. Whether a particular participants' accumulated plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by then existing assets and the PBGC guaranty while other benefits may not be provided for at all. Information about the Plan agreement and the PBGC's benefit guarantee is contained in the Summary Plan Description, as well as other materials that are available from the Plan Administrator.

E. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). This hierarchy consists of three broad levels:

Level 1 – Quoted prices in active markets for identical financial instruments that are accessible at the measurement date.

Level 2 – Quoted prices in active markets for similar financial instruments, quoted prices for identical or similar financial instruments in markets that are not active, and models and other valuation methodologies using inputs other than quoted prices that are observable.

Level 3 – Models and other valuation methodologies using significant inputs that are unobservable for financial instruments.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The pooled separate accounts are measured at fair value using the fund's daily NAV, which is considered by Plan management to be the best approximation of fair value. The unit value of the funds are calculated daily.

The following table sets forth, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level any input that is significant to the fair value measurement:

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

I. Tax Status

The Plan obtained a determination letter dated February 28, 2023, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

J. Related Party and Party in Interest Transactions

Certain Plan investments with Principal Life Insurance Company are units of separate accounts managed by Principal Life Insurance Company and qualify as party-in-interest transactions. As described in Note B, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt from the prohibited transaction rules of ERISA.

K. Amendments

The plan was restated on July 1, 2023, with changes to the accrued benefit formula and compensation used for plan benefits among others.

L. Subsequent Events

The Plan has evaluated events and transactions occurring after December 31, 2024, for items required to be recognized or disclosed in the financial statements. Subsequent events were evaluated through, October 7, 2025, the date the financial statements were available to be issued.

Methods prescribed by law

Liability measure

Funding target is the present value of the benefits accrued on the valuation date.

Target normal cost is based on benefits expected to accrue during the current plan year and includes an estimate of plan expenses for the year.

Benefit accrual

All benefits paid at decrement are considered in total and then split to determine how much is included in funding target. The following pieces are included in the funding target.

- The portion based on the plan's definition of accrued benefit.

- The benefit portion in excess of the accrued benefit based on the ratio of the participant's years of service on the valuation date to the years of service the participant will have at the time of decrement.

The benefits included in target normal cost are calculated similarly, by splitting the benefits. The target normal cost is based on the difference between the amount included in Funding Target and an amount calculated assuming the participant accrues service through the end of the plan year.

Lump sum payments

Lump sum payments are valued using the plan's funding target interest rates as required, per IRS guidance. These rates are currently higher than the actual rates used to determine lump sum distributions. Therefore, plan liabilities do not currently recognize this additional cost and this may result in the plan not accumulating adequate assets. You may wish to consider additional contributions.

Methods selected by plan sponsor

Asset method

The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

Segment rates

24-month average with no weighting to prior law basis. Use rates where August is the last month included in the average.

PBGC premium basis

Variable rate premiums are calculated using census, market value of assets and the one-month average of corporate bond rates in effect on the valuation date. You elected this Standard interest method for the 01/01/2023 plan year and the method must be used for five years before a change can be made.

Vested benefits

A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant's vesting percentage applicable to each benefit on the valuation date.

The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The White collar base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.
