Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of SPROUTS FARMERS MARKET 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Sprouts Farmers Market 401(k) Plan is provided for general information purposes only. Participants should refer to the plan document for more complete information.

[1] General

The plan is a single-employer defined contribution 401(k) profit-sharing plan covering all full-time employees of Ronald Cohn, Inc. who have one year of service and are age twenty-one or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was merged into the Sprouts Farmers Markets Holdings, LLC Employee 401(k) Savings Plan on November 27, 2024. The Sprouts Farmers Market 401(K) Plan was then terminated.

The plan sponsor is Ronald Cohn, Inc.

The plan trustee is John Castanos and the plan custodian is Lincoln National Life Insurance Company.

[2] Contributions

Participants may contribute up to 90% of annual compensation as defined by the plan, not to exceed the annual dollar limit established by the Internal Revenue Service. Participant rollover contributions from other qualified plans are permitted. The plan sponsor can make both discretionary matching contributions and discretionary profit-sharing contributions. Discretionary contributions are determined by appropriate action of the Board of Directors.

[3] Participant Accounts

Participant accounts are credited with participant, company and rollover contributions. Plan earnings are allocated to participants accounts based on each participant's investment election. Company matching contributions are allocated based on the participant's eligible elective deferrals, as defined by the plan. Company profit-sharing contributions are allocated based on each participant's compensation, as defined by the plan, compared to total recognized compensation. Participant accounts are charged for administrative expenses on a pro-rata basis.

[4] Vesting

Participants are immediately vested in their elective contributions and rollover contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of service, with a participant becoming fully vested after six years of credited service.

[5] Investment Options

Upon enrollment in the plan and periodically as determined by the plan administrator and trustees, participants may direct contributions and account balances into any of the plan's investment options. A listing of these investment options and account descriptions can be obtained from the plan administrator.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

[6] Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or fifty percent of their vested account balance. Loan transactions are treated as transfers from the investment fund to participant note accounts. Loan terms range from one to five years or over any reasonable period commensurate with the period permitted by commercial lenders for the purchase of a primary residence. Loans are secured by the participant's vested account balance and bear interest at 1% higher than the prime lending rate of a commercial U.S. bank available within a reasonable geographic vicinity. Collections are made through payroll deductions by the plan sponsor.

[7] Payment of Benefits

Upon termination of service for any reason, a participant's vested account balance will be distributed in a single lump-sum amount as soon as administratively feasible following the event that entitles the participant to a distribution. In addition, the plan allows in-service distributions for those participants that qualify.

[8] Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts are first used to pay administrative expenses of the plan and then to reduce the employer's matching contributions. The forfeitures account balance was \$1,978 at December 31, 2023. The plan did not have a forfeiture account balance at December 31, 2024. Employer matching contributions and plan expenses may be reduced by forfeitures. No forfeitures were used in 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

[2] Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's administrator determines the plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

[3] Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

[4] Payment of Benefits

Benefits are recorded when paid.

[5] Expenses

Certain expenses of maintaining the plan are paid by the plan, unless otherwise paid by the company. Expenses that are paid by the company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

[6] Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Units of Separate Pooled Accounts (Level 1): Valued at quoted market prices of shares held by the plan at year end. The separate pooled accounts held by the plan are deemed to be actively traded.

Units of Separate Pooled Accounts (Level 2): Valued at the quoted market value of the account's underlying assets from an actively traded exchange.

NOTE 4 - GROUP ANNUITY CONTRACT

The plan entered into traditional fully benefit-responsive guaranteed investment contracts with Lincoln National Life Insurance Company (Lincoln) totaling \$262,838 at December 31, 2023. There were no investment contracts at December 31, 2024. Lincoln maintains the investments in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and earnings at a specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by the contract issuers and was 2.54% at December 31, 2023. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity dates.

These contracts meet the fully benefit-responsive investment contracts criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract values, as reported to the plan by Lincoln, represent contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the plan to transact at contract value with the issuers. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. The plan liquidated all contracts prior to the plan merger.

In addition, certain events allow the issuers to terminate the contracts with the plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the plan's investment guidelines, (2) a breach of material obligation under the contracts, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuers.

The information certified includes total investments and participants' notes receivable in the aggregate amount of none at December 31, 2024 and \$2,374,208 at December 31, 2023, and related income on investments of \$327,772 in 2024 and income on investments of \$320,832 in 2023.

NOTE 7 - RELATED PARTY TRANSACTIONS

Certain plan investments are units of separate pooled accounts and investment contracts with Lincoln National Life Insurance Company and managed by Lincoln National Life Insurance Company, the plan custodian, and therefore these transactions qualify as party-in-interest transactions.

NOTE 8 - PLAN MERGER

In 2023, Sprouts Farmers Market, Inc. purchased Ronald Cohn, Inc. dba Sprouts Farmers Market, the plan sponsor of the Sprouts Farmers Market 401(K) Plan. On November 27, 2024 the plan was merged into Sprouts Farmers Markets Holdings, LLC Employee 401(k) Savings Plan. All participant loans were transferred to the new plan. All participants became fully vested in all matching contributions through the merger date.

NOTE 9 - TAX STATUS

The Internal Revenue Service has determined and informed the plan sponsor by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The plan invests in various investment securities and an insurance contract. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There are no significant differences between the amounts presented on the financial statements and the amounts reported on Form 5500.

NOTE 12 - SUBSEQUENT EVENTS

The plan has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available to be issued, and represents that there are no subsequent events to be reported.
