Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Tricore Reference Laboratories 401(k) Plan (the Plan) was established by TriCore Reference Laboratories (the Company or Plan administrator) originally effective January 1, 1977 and most recently amended effective October 1, 2024. Prior to January 1, 2021, the Plan excluded leased employees, nonresident aliens, pro re nata (PRN), per diem Employees, and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Effective January 1, 2021, the Plan included PRN and Per Diem employees as eligible employees.

Effective September 15, 2023, the Plan was amended to allow In-Plan Roth Rollover Contributions.

Effective January 1, 2024, salary deferrals will use compensation earned during the Plan Year, including compensation earned while an Employee is not a Participant.

Effective August 1, 2024, the Plan was amended to allow notes receivable from participants.

Eligibility

Employees are eligible to make salary deferrals immediately upon employment without regard to age. Participants are eligible for the Company match components of the Plan upon completion of one year of service and attainment of 18 years of age.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 6% of eligible compensation. The Plan also includes an auto-increase provision whereby all participants contribution percentage is increased by 2% per year up to 10% unless they elect a different contribution percentage. Their contributions are invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Provisions of the Plan require the Company to make safe harbor matching contributions equal to 100% of salary deferrals up to 5% of the eligible compensation per payroll period. In addition, the Company performs a true-up calculation of the safe harbor calculation at year end.

Contributions (continued)

Effective October 1, 2024, the Plan was retroactively amended as of January 1, 2024, to revise the definition of compensation for purposes of calculating the safe harbor match to be based on Plan Year compensation. The Company may also make nonelective contributions or discretionary profit-sharing contributions in an amount to be determined at Plan year-end by the Company. There were no such contributions in 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's nonelective contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are applied evenly to all participants. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and employer safe harbor matching contributions, plus earnings thereon. Participants vesting in discretionary employer contributions is based upon years of service. A participant is 100% vested after five years of service. Participants who become permanently disabled while employed become 100% vested in the employer discretionary contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Effective January 1, 2024, the limit for involuntary distributions increased from \$5,000 to \$7,000 in accordance with the provisions of the SECURE 2.0 Act.

Expenses

The Plan's amended service agreement, effective September 21, 2017, with Lincoln Retirement Services Company, LLC provides for administrative expenses at a flat annual fee rather than reducing investment income. As part of this amendment, a Plan expense account was created, which may be used to reduce administrative expenses or allocated to participants. The account is funded by fees from certain investments and other amounts as directed by the Company under the Plan document. Administrative expenses totaled \$293,876 and \$285,061 for the years ended December 31, 2024 and 2023, respectively. The balance of the Plan expense account as of December 31, 2024 and 2023 is \$23,897 and \$24,946, respectively. During the years ended December 31, 2024 and 2023, \$66,826 and \$71,486, respectively, were used from the expense account to pay for plan expenses.

Forfeitures

Forfeited nonvested accounts may be used to reduce administrative expenses, to reduce future Company contributions or may be allocated to employees. During the year ended December 31, 2024 and 2023, there was no payment for administrative expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$4,706 and \$6,451, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Contributions

Contributions from participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefits are recorded when paid.

Expenses of the Plan

Certain administration fees, including the cost of the annual audit, investment custodianship fees, and the third-party administration fees and advisor fees, may be paid by either the Plan or the Plan sponsor, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation/depreciation of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through [Report Date], the date the financial statements were available to be issued. The Plan Administrator believes there are no significant events occurring subsequent to December 31, 2024, that would require adjustment to or disclosure in the financial statements, except that the Plan was amended January 1, 2025 to amend the definition of compensation for purposes of calculating the safe harbor match.

Lincoln Financial Group Trust Company, Inc., (LFGTC), the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information, and notes receivable and related interest income from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 nor December 31, 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Corporate Stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Self-Directed Brokerage Accounts: Accounts primarily consist of interest bearing cash, cash equivalents, corporate stocks, corporate debt instruments and unit investment trusts (exchange traded funds) that are valued on the basis of readily determinable market prices.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan holds an insurance contract with Lincoln National Life Insurance Company (Lincoln), who maintains the contributions in a general account. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 8 PLAN TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are managed by affiliates of LFGTC, the trustee of the Plan, therefore these transactions qualify as party-in-interest transactions. RBC Wealth Management is the investment advisor for the Plan. Transactions with RBC Wealth management qualify as parties-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 10 NONEXEMPT TRANSACTION

During 2024, the Company failed to remit employee contributions for certain payroll periods within the timeframe prescribed by the Department of labor. This is deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. In June 2025, the Company has fully corrected the prohibited transaction by depositing the lost earnings, filing the required Form 5330 with the Internal Revenue Service and paying the appropriate excise tax.
