Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Rockford Corporation 401(k) Retirement Savings Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

(1) Description of the Plan

The following description of the *Rockford Corporation 401(k) Retirement Savings Plan* (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

- A. General** – The Plan is a defined contribution plan with a 401(k) arrangement covering all employees of Rockford Corporation (the “Company”) who are 21 years of age and are not covered by a collective bargaining agreement or are a leased employee. The Plan was established on February 1, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan adopted the current restated plan document on January 24, 2022, in compliance with Internal Revenue Service (“IRS”) requirements to revise the retirement plan documents when the law changes.
- B. Contributions** – Each year, participants may contribute up to 60 percent of annual compensation and deferral percentages may be changed at the beginning of each payroll as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants over 50 years of age, who have reached the Plan’s contribution limit of 60 percent of eligible compensation or the annual IRS limit of \$23,000 for 2024, may make additional contributions to the Plan up to the IRS Catch Up Provision Limit of \$7,500 for 2024. Highly compensated employees (those who earned over \$150,000 in 2024) are able to contribute up to the annual IRS limit of \$23,000 for 2024, restricted to contributions based upon overall plan participation. Under the Safe Harbor Plan, the Company matches 100 percent of a participant’s contribution up to 3 percent of the participant’s eligible compensation and 50 percent of the participant’s next 2 percent of eligible compensation. The Plan allows for discretionary matching employer contributions at the percentage or flat dollar amount declared, if any, by the Board of Directors. The Company did not make discretionary nonelective employer contributions during 2024.
- C. Participant accounts** – Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings. Allocations are based on participant elections, earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.
- D. Vesting** – A participant’s voluntary contributions are fully vested and non-forfeitable. Employer nonelective contributions, qualified nonelective contributions, Safe-Harbor matching contributions and any earnings on those contributions, are fully vested. Employer matching contributions outside of Safe Harbor and the earnings on those contributions vest 20 percent per year of service beginning after one year of service, and become fully vested upon disability, normal retirement age, death, or after six years of service.
- E. Forfeitures** – There were no forfeitures during the Plan years ended December 31, 2024 or 2023. All forfeitures go into an investment account directed by the Company and earn investment gains and losses during the year. Forfeitures are used to reduce future employer contributions or to pay administrative costs for the Plan. The Company allocated \$0 from the forfeiture account towards employer administrative costs and employer contributions during the year ended December 31, 2024. Unused forfeited account balances were \$36 and \$36 at December 31, 2024 and 2023, respectively.

(1) Description of the Plan (continued)

- F. Expenses** – Effective December 1, 2013 by a Plan amendment, expenses paid by the Plan are allocated on a pro rata basis to participant accounts; this does not include expenses paid by the Company.
- G. Plan termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, affected participants will become 100 percent vested in their accounts.
- H. Notes receivable from participants** – Participants may borrow a minimum of \$1,000 from their fund accounts up to 50 percent of the vested amount of their account balance or \$50,000 reduced by any outstanding loan balances over the previous 12-month period, whichever is lower, for a term that generally cannot exceed five years and only one loan may be outstanding at a time. Loan transactions are treated as a transfer from (to) the investment funds to (from) the loan fund. The loans are collateralized by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Interest rates on outstanding loan balances at December 31, 2024 and 2023 ranged from 5.25 percent to 10.50 percent. Principal and interest is paid ratably through payroll deductions.
- I. Payment of benefits** – Upon termination of employment due to death, disability or upon reaching normal retirement age, as defined, the vested balance of a participant’s account may be distributed to the participant or beneficiaries either in a single lump sum or under a systematic withdrawal plan.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The financial statements of the Plan are presented on the accrual basis of accounting.

Investment valuation and income recognition – The investments of the Plan are recorded at fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. If a Level 1 input is available, it must be used.
- Level 2: Inputs other than quoted prices that are observable for assets or liabilities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Unobservable inputs, which contain assumptions by the party valuing those assets or liabilities. For Level 3 inputs, there is no market data or correlations with market assumptions. Examples would include limited partnership interests, closely held stock, etc.

(2) Significant accounting policies (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The following is a description of the valuation methodologies used for the investments held by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and money market fund: The Plan's mutual fund and money market fund investments are stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Investment in common/collective trusts: The Plan's common/collective trusts are stated at unit value, or the equivalent of net asset value, which is a practical expedient for estimating the fair value of the investment. The common/collective trusts have no unfunded commitments as of December 31, 2024 and 2023, and can be redeemed daily with no redemption notice period or other redemption restrictions.

The Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest.

Risk and uncertainties – The Plan provides for various investment options in mutual funds and other investment securities of which participants may elect for investment in any combination. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of benefits – Benefit payments are recorded when paid.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make assumptions that affect the amounts reported in the financial statements and accompanying notes. (5) Income tax status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the "Code"), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Plan management and the Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements and the Code and continues to be tax-exempt as of and for the year ended December 31, 2024.

(6) Parties-in-interest

Certain Plan investments are shares of mutual funds and a common/collective trust which are managed by Fidelity, which is also the custodian and trustee as defined by the Plan, and therefore these transactions qualify as party-in-interest. Administrative expenses paid by the Plan to Fidelity and other service providers for the year ended December 31, 2024 were \$17,758 of which none was employer administrative costs. These administrative expenses include fees paid by Fidelity to the profit sharing plan investment advisory firm hired by the Company to make recommendations regarding the Plan.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Rockford Corporation 401(k) Retirement Savings Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

The following description of the *Rockford Corporation 401(k) Retirement Savings Plan* (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

- A. General** – The Plan is a defined contribution plan with a 401(k) arrangement covering all employees of Rockford Corporation (the “Company”) who are 21 years of age and are not covered by a collective bargaining agreement or are a leased employee. The Plan was established on February 1, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan adopted the current restated plan document on January 24, 2022, in compliance with Internal Revenue Service (“IRS”) requirements to revise the retirement plan documents when the law changes.
- B. Contributions** – Each year, participants may contribute up to 60 percent of annual compensation and deferral percentages may be changed at the beginning of each payroll as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants over 50 years of age, who have reached the Plan’s contribution limit of 60 percent of eligible compensation or the annual IRS limit of \$23,000 for 2024, may make additional contributions to the Plan up to the IRS Catch Up Provision Limit of \$7,500 for 2024. Highly compensated employees (those who earned over \$150,000 in 2024) are able to contribute up to the annual IRS limit of \$23,000 for 2024, restricted to contributions based upon overall plan participation. Under the Safe Harbor Plan, the Company matches 100 percent of a participant’s contribution up to 3 percent of the participant’s eligible compensation and 50 percent of the participant’s next 2 percent of eligible compensation. The Plan allows for discretionary matching employer contributions at the percentage or flat dollar amount declared, if any, by the Board of Directors. The Company did not make discretionary nonelective employer contributions during 2024.
- C. Participant accounts** – Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings. Allocations are based on participant elections, earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.
- D. Vesting** – A participant’s voluntary contributions are fully vested and non-forfeitable. Employer nonelective contributions, qualified nonelective contributions, Safe-Harbor matching contributions and any earnings on those contributions, are fully vested. Employer matching contributions outside of Safe Harbor and the earnings on those contributions vest 20 percent per year of service beginning after one year of service, and become fully vested upon disability, normal retirement age, death, or after six years of service.
- E. Forfeitures** – There were no forfeitures during the Plan years ended December 31, 2024 or 2023. All forfeitures go into an investment account directed by the Company and earn investment gains and losses during the year. Forfeitures are used to reduce future employer contributions or to pay administrative costs for the Plan. The Company allocated \$0 from the forfeiture account towards employer administrative costs and employer contributions during the year ended December 31, 2024. Unused forfeited account balances were \$36 and \$36 at December 31, 2024 and 2023, respectively.

- F. Expenses** – Effective December 1, 2013 by a Plan amendment, expenses paid by the Plan are allocated on a pro rata basis to participant accounts; this does not include expenses paid by the Company.
- G. Plan termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, affected participants will become 100 percent vested in their accounts.
- H. Notes receivable from participants** – Participants may borrow a minimum of \$1,000 from their fund accounts up to 50 percent of the vested amount of their account balance or \$50,000 reduced by any outstanding loan balances over the previous 12-month period, whichever is lower, for a term that generally cannot exceed five years and only one loan may be outstanding at a time. Loan transactions are treated as a transfer from (to) the investment funds to (from) the loan fund. The loans are collateralized by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Interest rates on outstanding loan balances at December 31, 2024 and 2023 ranged from 5.25 percent to 10.50 percent. Principal and interest is paid ratably through payroll deductions.
- I. Payment of benefits** – Upon termination of employment due to death, disability or upon reaching normal retirement age, as defined, the vested balance of a participant’s account may be distributed to the participant or beneficiaries either in a single lump sum or under a systematic withdrawal plan.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The financial statements of the Plan are presented on the accrual basis of accounting.

Investment valuation and income recognition – The investments of the Plan are recorded at fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. If a Level 1 input is available, it must be used.
- Level 2: Inputs other than quoted prices that are observable for assets or liabilities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Unobservable inputs, which contain assumptions by the party valuing those assets or liabilities. For Level 3 inputs, there is no market data or correlations with market assumptions. Examples would include limited partnership interests, closely held stock, etc.

(2) Significant accounting policies (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The following is a description of the valuation methodologies used for the investments held by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and money market fund: The Plan's mutual fund and money market fund investments are stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Investment in common/collective trusts: The Plan's common/collective trusts are stated at unit value, or the equivalent of net asset value, which is a practical expedient for estimating the fair value of the investment. The common/collective trusts have no unfunded commitments as of December 31, 2024 and 2023, and can be redeemed daily with no redemption notice period or other redemption restrictions.

The Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest.

Risk and uncertainties – The Plan provides for various investment options in mutual funds and other investment securities of which participants may elect for investment in any combination. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of benefits – Benefit payments are recorded when paid.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent events – The Plan's management has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

(5) Income tax status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the "Code"), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Plan management and the Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements and the Code and continues to be tax-exempt as of and for the year ended December 31, 2024.

(6) Parties-in-interest

Certain Plan investments are shares of mutual funds and a common/collective trust which are managed by Fidelity, which is also the custodian and trustee as defined by the Plan, and therefore these transactions qualify as party-in-interest. Administrative expenses paid by the Plan to Fidelity and other service providers for the year ended December 31, 2024 were \$17,758 of which none was employer administrative costs. These administrative expenses include fees paid by Fidelity to the profit sharing plan investment advisory firm hired by the Company to make recommendations regarding the Plan.
