- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oaks Integrated Care, Inc. 403(b) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Oaks Integrated Care, Inc. 403(b) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance, with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Oaks Integrated Care, Inc. 403(b) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule, Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to the Financial Statements

Note 1: DESCRIPTION OF THE PLAN

The following description of the Oaks Integrated Care, Inc. 403(b) Savings Plan (formerly Twin Oaks Community Services 403(b) Plan) (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – Oaks Integrated Care, Inc. (the "Organization") established the Plan to provide employees with a systematic means of savings and investing for the future. The Plan was established on January 1, 2012. All permissible employees of the Organization, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. Deferrals begin on the first day of the month subsequent to enrollment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Steininger Behavioral Care Services ("Steininger") merged with Family Services of Burlington County to form Oaks Integrated Care, Inc. on January 1, 2012. The Plan includes accounts transferred from Steininger's previously existing 403(b) plan, plus any newly eligible employees of Oaks Integrated Care, Inc. after January 1, 2012. Eligible employees are all Oaks Integrated Care, Inc. employees hired after January 1, 2012, unless otherwise excluded, and former Steininger plan participants as of January 1, 2012. In order to become eligible for employer contributions, employees of the Organization must be 21 years of age and complete one year of service, including one thousand hours of service. Per diem, substitute, and temporary employees are excluded from employer contributions.

Plan amendments – The Plan was effective January 1, 2012, and has been amended to comply with various legal and regulatory changes.

Certified Investments – Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance and Lincoln Financial Group (the trustees of the Plan).

Contributions – Participants may contribute the maximum allowable amount of their eligible pay by means of payroll deductions, subject to limits prescribed by the Internal Revenue Code ("IRC") and other limitations specified in the Plan. The Organization matched 50% of up to 2% of employee contributions for eligible employees. The Organization also makes discretionary contributions based on a percentage of the participant's annual compensation for eligible employees. Participants are also allowed to transfer or rollover funds into the Plan from other qualified or 403(b) plans.

Participants' accounts - Each participant's account reflects employee monies deferred, the employer's contribution and allocations of the plan earnings, and charged with an allocation of administrative expenses. Allocations are based on a percentage of each participant's balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options – Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization's contributions into various investments offered by the Plan.

Note 1: DESCRIPTION OF THE PLAN (continued)

Vesting – Participants are immediately vested in their voluntary contributions, rollover contributions accepted by the Plan, and actual earnings thereon. Vesting in the employer's matching contributions and discretionary contributions of their account plus actual earnings thereon is based on years of continuous service.

Participants vest in the Employer's matching contributions is based on the following:

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$123 and \$117, respectively. Forfeitures of terminated participants' nonvested accounts are utilized to pay administrative expenses and to reduce the employer's contribution. Forfeitures of non-vested employer contributions are applied first to payment of Plan administration expenses and then used to offset employer contributions. If a participant leaves the employer and returns before incurring five consecutive one-year breaks in service, the participant may recapture the forfeited benefit. Plan expenses and employer contributions were reduced by \$618,600 and \$860,935 from forfeited non-vested accounts for December 31, 2024 and 2023, respectively.

Distributions – Upon termination, retirement, disability or death, a participant or beneficiary receives the vested amount credited to the participant's account according to provisions of the Plan document. In addition, under certain circumstances, hardship withdrawals are permitted.

Notes receivables from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of: \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or 50% of their vested account balance, reduced by any outstanding loan balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus one percent. This rate is adjusted quarterly for new loans. Note maturities generally range from one to five years.

Note 2: SUMMARY OF ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, the actual amounts could differ from those estimates.

Note 2: SUMMARY OF ACCOUNTING POLICIES (continued)

Investment valuation and income recognition – Investments held by a defined contribution plan are reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivables from Participants - Notes receivable from participants, if any, are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for estimated uncollectible amounts has been recorded as of December 31, 2024 and 2023. Delinquent notes receivables from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 3: FAIR VALUE MEASUREMENTS (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies – Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: INVESTMENT CONTRACT WITH INSURANCE COMPANY

Lincoln Group Fixed Annuity Contract (Stable value fund)

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Lincoln Financial Group (“Lincoln”) totaling \$7,424,682 for 2024 and \$6,260,595 for 2023. Lincoln maintains the contributions in its general account. The accounts are credited with earnings on the underlying investments and charged for participant withdraws and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 4: INVESTMENT CONTRACT WITH INSURANCE COMPANY (continued)

Lincoln Group Fixed Annuity Contract (Stable value fund) (continued)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no events that would result in the plan not being able to receive contract value; however some events may result in contract value not being immediately received. The following events could trigger termination by the issuer, resulting in the plan not being able to receive immediate contract value: (1) Any charges billed to the contract owner have not been paid to Lincoln within 30 days, (2) the plan ceases to meet the requirements of the Internal Revenue Code for purchasers of this contract, (3) at any time, following the end of the third contract year, the contract owner account is less than \$15,000, (4) at any time, following the end of the third contract year, there is no deposit activity for a 24 consecutive month period and the contract owner account is less than \$50,000, (5) the contract owner fails to furnish requested information or other documentation, (6) Lincoln discovers any misrepresentation of material information, (7) Lincoln discontinues offering this contract form the public, (8) the Plan terminates its recordkeeping agreement with Lincoln.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a break of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer

Note 5: PLAN ADMINISTRATION COSTS

During the years ended December 31, 2024 and 2023, the Organization elected to pay some of the Plan's administrative costs and not seek reimbursement from the Plan. The Plan did incur administrative expenses of \$60,223 in 2024 and \$50,318 in 2023.

Note 6: RELATED-PARTY TRANSACTIONS

The Plan invests in investment contracts and shares of registered investment companies managed by Lincoln Financial Group. Wilmington Trust National Association acts as the “passive trust” for Lincoln Financial Group acts as the trustee for only those investments as defined by the Plan. Transactions in such investments qualify as “party-in-interest” transactions which are exempt from the prohibited transaction rules.

Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions will be discontinued and all Plan participants will become fully vested in their accounts.

Note 8: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan Administrator believes the terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Company has received an opinion letter from the Internal Revenue Service dated May 1, 2025 stating that the form of the approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has reviewed and evaluated its tax positions taken in its previously filed annual reports and returns with the Internal Revenue Service (“IRS”) and or Department of Labor, and those expected to be filed in the future, and has concluded that in the event of an examination by regulatory authorities, the Plan’s positions would more likely than not prevail based upon the technical merit of such positions. Therefore, the Plan has concluded that no further benefits or liabilities are required to be recognized or disclosed in the financial statements.

The Plan is generally subject to routine audits by the Internal Revenue Service and or Department of Labor, for three years, however, there are currently no audits for any periods in progress.

Note 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 10: SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.
