### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brookfield Hospitality Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brookfield Hospitality Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### 1. Description of the Plan

The following description of the Brookfield Hospitality Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution retirement plan established by Brookfield Hospitality Properties, LLC (the “Company”) effective January 1, 2013, pursuant to a Termination Services Agreement entered into between the Company and Kerzner International North America, Inc.

The Plan is an adoption of a Prototype Non-Standardized Profit-Sharing Plan and Trust created under the provisions of Section 401(a) of the Internal Revenue Code (the “Code”), which includes qualified cash or deferral arrangements as described by Section 401(k) of the Code. The Plan covers substantially all nonunion employees of the Company’s entities with US source wages who are at least 18 years of age and have completed at least three months of service, as defined by the Plan. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Plan Administration**

Empower Trust Company, LLC serves as the trustee for the Plan. The Trustee also serves as the custodian of the Plan’s investments.

##### **Contributions**

Each year, participants may contribute up to 100% of compensation subject to limitations, as defined by the Plan, in the form of pre-tax salary deferral or after-tax Roth contributions. These contributions, subject to certain limitations under the Internal Revenue Code, allow for maximum pre-tax contributions of \$23,000 during 2024, plus catch-up contributions of \$7,500 for employees aged 50 or over. Additionally, in accordance with the Plan, participants may contribute amounts from other qualified plans as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment allocation at any time. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company shall make matching contributions in an amount equal to 100% of the first 2% of eligible compensation of the Participant’s contribution for each payroll period. Additionally, the Company may make an annual profit-sharing contribution, which is entirely at their discretion.

##### **Participants’ Accounts**

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### **Vesting and Forfeitures**

Participants are immediately vested in their contributions and amounts rolled over into the Plan, plus actual earnings thereon. Employer matching contributions vest at a rate of 20% per year of service and are fully vested after five years of service. Non-vested portions of employer contributions are forfeited as of the participant's termination date. Forfeitures are available to reduce future employer matching contributions and to offset administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$59,679 and \$9,791, respectively. During 2024, employer contributions of \$9,642 and administrative fees of \$17,000 were paid from forfeited non-vested accounts.

### **Notes Receivables from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to an amount not to exceed the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing interest rates as determined by the Plan. Principal and interest are paid ratably through payroll deductions. Loan terms range from one to five years or up to fifteen years for the purchase of a primary residence.

### **Payment of Benefits**

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments that are distributed in accordance with the Plan.

## **2. Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 8 for additional information on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was considered necessary as of December 31, 2024 or 2023. In accordance with the Plan, notes receivables in default are reclassified as distributions.

#### Administrative Expenses

The Company pays certain administrative expenses of the Plan, while other expenses are paid directly by the Plan. Expenses paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants or distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation or depreciation in fair value of investments.

#### Benefit Payments

Benefits are recorded when paid.

#### Date of Management's Review

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### 3. Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company LLC, the trustee of the Plan and qualified institution (Note 1), has certified that the data included in the accompanying financial statements and supplementary schedule is complete and accurate with respect to investments and notes receivable from participants as shown on the statement of net assets available for benefits as of December 31, 2024 and 2023, and net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 4. Related Party Transactions and Party in Interest Transactions

There were outstanding notes receivable from participants as of December 31, 2024 and 2023. These transactions qualify as party in interest transactions. The Plan also uses third-party service providers to perform administrative functions. Transactions with such providers are considered exempt party in interest transactions under ERISA.

### 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in

ERISA. In the event of any termination of the Plan, or upon complete or partial discontinuance of contributions, the accounts of each affected participant shall become fully vested.

#### 6. Risks and Uncertainties

The Plan invests in various investment securities. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

#### 7. Tax Status

The Plan is an adoption of a non-standardized prototype plan. The IRS has determined and informed the prototype sponsor by letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, the Plan has no liabilities for uncertain tax positions. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The following three levels of fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### December 31, 2024

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds*— Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (“SEC”). These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded with readily determinable fair values.

*Common Collective Trusts (“CCT”)*—Valued at the NAV as a practical expedient of the CCT as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, less liabilities and divided by the number of units outstanding. The CCT fund’s NAV is not considered to be readily determinable fair value. The CCT does not have a finite life, unfunded commitments, or significant restrictions on redemptions. Redemption frequency is daily.

The common collective trust is composed of the Putnam Stable Value Fund (the "Fund"). The Fund invests in high-quality guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions. Up to 75% of the Fund's assets are in security-backed investment contracts, including separate account products of insurance companies. The Fund also strives to maintain at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and stable value funds with investment policies and other provisions similar to those of the Fund.

The only event or circumstance in the ordinary course of business that would allow issuers to immediately terminate at an amount different from contract value would be if they were provided with fraudulent information about the Fund by its trustee. The Plan believes the occurrence of such an event or circumstance is not probable.
