## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Ito En US Group Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Ito En US Group Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ito En US Group Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ito En US Group Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. DESCRIPTION OF PLAN

The following description of the Ito En US Group Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan covering certain employees of Ito En (North America) Inc.; Distant Lands Trading Co.; Java Trading Co., LLC; Country Coffee Company, Inc. dba Distant Lands Coffee Roasters; La Minita Corp; Ito En (Hawaii) LLC; Mason Distributors Inc.; and Sentry Manufacturing, Inc. (together from here on referred to as the “Company”) who have completed three months of service and are age 21 or older. The Plan was established in 2002 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plans for each of the entities that make up the Company were merged in 2018.

*Contributions* - Participants may contribute up to an annual limit as allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common collective trusts as investment options for participants. The Plan also has an after-tax Roth option.

The Company contributes a Safe Harbor matching contribution equal to a uniform percentage of participant contributions.

*Participant Accounts* - Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contribution, (b) plan earnings (losses), (c) forfeitures, and (d) charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are immediately vested in their voluntary contributions, the Company’s Safe Harbor match (by law, vested immediately), and rollover contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Participants who were active in a participating employer’s plan that has been restated or merged into the Plan and whose vesting schedule has been amended due to this restatement, will be subject to the prior plan’s vesting schedule or the Plan’s vesting schedule, whichever is more favorable.

*Notes Receivable from Participants* - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Each participant is allowed to have a maximum of one loan outstanding. The notes are secured by the balance in the participant’s account and bear interest at 1% over the prime rate. During 2024, the interest rates charged on the notes receivable from participants ranged from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

The Plan retroactively adopted all provisions of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) that was signed into law on March 27, 2020. After March 27, 2020, the Plan allowed for two outstanding loans at one time and for extended loan repayments for up to one year. The Plan allows for an increase in the loan amount up to a maximum equal to the lesser of \$100,000 or 100% of their vested account balance; however, none of the CARES Act loans exceeded \$50,000. The CARES Act was a temporary provision. In 2023, the Plan returned to its standard plan agreement.

Payment of Benefits - Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account directly or a rollover to another qualified plan. Partial withdrawals or installments can be elected over a period not more than the assumed life expectancy.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$81,921 and \$58,117, respectively. These accounts are used to reduce employer contributions. No forfeitures were used in 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The excess contributions for the year ended December 31, 2024 and 2023 were \$715 and \$7,774, respectively.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) in fair value of investments. The Company has elected for the Plan to pay the audit fees incurred by the Plan.

Date of Management's Review - Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

different methodologies and assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Common Collective Trust* – The common collective trust is valued at net asset value (“NAV”). The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value since the fair value is not considered to be readily determinable. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

*Mutual funds* – The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the SEC. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded with readily determinable fair values.

### 5. PLAN TERMINATION

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### 6. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. There were no uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any tax periods.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 9. FIDELITY BONDING

The Company maintains a fidelity bond of \$500,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.

### 10. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Plan sponsor did not timely remit certain employee contributions and loan repayments of \$103,410, respectively, in accordance with guidelines set forth by the United States Department of Labor ("DOL") and Employee Benefits Security Administration ("EBSA"). These nonexempt transactions are expected to be corrected in 2025.

### 11. PARTY IN INTEREST TRANSACTIONS AND ADMINISTRATIVE EXPENSES

Transamerica Retirement Solutions is the Plan's recordkeeper. The Benefit Practice is the third-party administrator ("TPA") for the Plan. Accordingly, these transactions qualify as party in interest transactions. During the year ended December 31, 2024, the Plan paid to third-parties record keeping fees of approximately \$96,641 and TPA fees of approximately \$14,340. Aguiar Cabrera Maceo & Co., LLP is the Plan's auditor. The audit fee also qualifies as a party in interest transaction. During the year ended December 31, 2024, the Plan paid \$18,150 in audit fees. These amounts are included in administrative expenses in the statement of changes in net assets available for benefits.
