### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Columbia Memorial Hospital TSA/Thrift Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Columbia Memorial Hospital TSA/Thrift Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 – Description of the Plan

The following description of the Columbia Memorial Hospital TSA/Thrift Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan established for the benefit of eligible employees of Columbia Lutheran Charities, dba Columbia Memorial Hospital (the Hospital). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by a committee designated by the Hospital's Board of Trustees. Delaware Charter Guarantee and Trust Company, dba Principal Trust Company, and Principal Life Insurance Company (Principal Life) are the Custodian and Trustee of the Plan. Principal Life also performs custodial and recordkeeping services for the Plan.

**Eligibility** – Employees of the Hospital are eligible to participate in the Plan after attaining 21 years of age and upon completion of one year of service (with at least 1,000 hours), except for employees covered by a collective bargaining agreement that does not provide for participation in the Plan, "leased employees" as defined in the Internal Revenue Code (the IRC), and persons who perform services for the Hospital but are not treated as employees for payroll tax purposes. As of January 1, 2024, there is no longer an age requirement to be eligible for the Plan nor a full-service year requirement. Eligibility has been updated to completing 1,000 within an eligible 12-month period. This period is either the first 12 months of employment or any full calendar year thereafter. Qualifying employees may participate in the Plan on the first day of the month on or following the date that they meet the eligibility requirements.

**Contributions** – Participant contributions are not permitted in this Plan. The Plan provides for Hospital contributions in the form of basic and enhanced matching contributions related to the Columbia Memorial Hospital 403(b) Tax-Deferred Annuity (the 403(b) Plan), which is a separate, qualified employee benefit plan available to eligible employees of the Hospital, and profit-sharing contributions. These three categories of Hospital contributions are determined as follows:

*Basic matching contributions* – Participants who are not eligible for enhanced matching contributions and profit-sharing contributions are eligible for basic matching contributions. For each calendar year, the Hospital may make a discretionary basic matching contribution to the Plan of up to 25% of each participant's first \$1,000 of elective contributions to the 403(b) Plan. For the years ended December 31, 2024, and 2023, the Hospital made the maximum allowable basic matching contributions to the Plan, consistent with the Hospital's historical funding policy, which were remitted to the Plan in December 2024 and January 2023, respectively. Basic matching contributions totaled \$3,500 and \$4,000 for the years ended December 31, 2024 and 2023, respectively.

*Enhanced matching contributions* – Generally, participants who first became employees of the Hospital after May 4, 2006 (or for employees covered by a collective bargaining agreement with the Oregon Nurses Association subsequent to July 26, 2007), are eligible for enhanced matching contributions. In addition, participants who elected out of active participation in the Columbia Memorial Hospital Retirement Plan effective January 1, 2007 or 2008, are eligible to receive enhanced matching contributions.

Prior to January 1, 2024, for payroll periods beginning before the fifth anniversary of a participant's employment with the Hospital, the Hospital will make an enhanced matching contribution equal to 100.0% of the participant's elective contributions to the 403(b) Plan, up to 2.5% of the participant's compensation. For payroll periods beginning on or after the fifth anniversary of a participant's employment with the Hospital, the Hospital will make an enhanced matching contribution equal to 100.0% of the participant's elective contributions to the 403(b) Plan, up to 3.0% of the participant's compensation. After January 1, 2024, the Hospital will make an enhanced matching contribution equal to 100.0% of the participant's elective contributions to the 403(b) Plan, up to 3.0% of the participant's compensation for eligible employees. Enhanced matching contributions totaled approximately \$1,531,034 and \$1,069,435 for the years ended December 31, 2024 and 2023, respectively. The Hospital's enhanced matching contributions are generally funded to the Plan as earned by participants each payroll period.

*Profit sharing contributions* – Participants who are eligible for enhanced matching contributions are also eligible for profit-sharing contributions. For each eligible participant, the Hospital will make a profit-sharing contribution equal to 5.0% of the participant's compensation for each payroll period beginning on or after the later of (a) the participant's second anniversary of employment with the Hospital, or (b) the date that the participant becomes eligible for profit-sharing contributions. Profit sharing contributions totaled approximately \$2,074,728 and \$1,805,221 for the years ended December 31, 2024 and 2023, respectively. The Hospital's profit-sharing contributions are generally funded to the Plan as earned by participants each payroll period.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the Hospital's matching contributions, as well as allocations of the Hospital's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** The Hospital's contributions after May 4, 2006, are always fully vested and not subject to forfeiture for any reason. Participants are fully vested in the Hospital's contributions made before May 4, 2006, on the earlier of either (a) the date the participant reaches normal retirement age, dies or incurs total disability while an employee or (b) the date the participant has three years of vesting service. After January 1, 2024, new or rehired participants will fully vest after one year of service or the date the participant reaches normal retirement age or total disability while an employee.

**Benefits** – Upon retirement, death, disability, or other separation of service, participants (or their beneficiaries) will receive a lump-sum amount equal to the value of the participant's interest in his or her account, subject to the provisions of the IRC and applicable state laws. Upon separation of service, if a participant's account balance is \$1,000 or less (\$5,000 or less for beneficiaries or alternate payees), and the participant does not elect to receive a distribution, the Hospital may direct the Plan to automatically distribute the participant's account balance in a lump sum.

**Administrative expenses** – At the Hospital's discretion, administrative expenses of the Plan may be paid directly by the Hospital; certain other administrative expenses may be paid by the Plan. Expenses that are paid by the Hospital are excluded from the accompanying financial statements. Certain investment-related expenses are offset against net appreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of the financial statements in conformity with GAAP requires the use of estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation** – The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The investments are certified by Principal Trust Company and Principal Life Insurance Company.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Custodian and Trustee. See Note 5 for discussion of fair value measurements.

Contract value is the relevant measurement attribute for assets invested in fully benefit-responsive investment contracts, because contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Contributions** – Matching contributions are recorded in the year in which the related participant compensation is paid.

**Income recognition** – Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits** – Benefits are recorded when paid.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 13, 2025, which is the date that the financial statements were available to be issued.

#### **Note 3 – Certified Investment Information**

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, qualified institutions:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest, reflected on the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments reflected on the schedule of assets (held at end of year).

#### **Note 4 – Fully Benefit-Responsive Investment Contract (FBRIC) with Principal Life Insurance Company**

The Plan's guaranteed investment contract is invested in the Principal Fixed Income Guaranteed Option (the Contract), which is a fully benefit-responsive investment contract. Principal Life maintains the related contributions in its general account. The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **Note 5 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3):

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for the Plan's assets measured at fair value. There have been no changes to the techniques used as of December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* – The fair value of mutual funds is based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Deferred income annuities* – The Plan holds an investment in the Principal Pension Builder (the Pension Builder), which is an investment option that allows participants to purchase deferred income annuities issued by Principal Life. Participants may transfer investments in the Pension Builder to other investment options within the Plan. Transactions that occur prior to the commencement of guaranteed income payments are realized at the lower of contract value (or return of premium) or an adjusted contract value that takes into account the current rates of interest available in the marketplace as well as mortality factors. The fair value of the annuities is the value paid when funds are withdrawn prior to the income start date.

The methods above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Management believes that the valuation methods used by the Plan are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements as of the reporting date.

#### Note 6 – Related-Party Transactions

Certain of the Plan's investments are invested in mutual funds offered by Principal Funds, Inc. (an affiliate of the Custodian and Trustee). Therefore, transactions involving these parties qualify as party-in-interest transactions.

The Hospital is the sponsor of the Plan and paid certain administrative expenses of the Plan during the years ended December 31, 2024 and 2023.

The Custodian and Trustee provide certain administrative services to the Plan and receive revenue from investments held by the Plan for the services that the Custodian and Trustee provide. This revenue is used to offset certain amounts owed to the Custodian and Trustee for their administrative services to the Plan. The Plan or the Hospital may make a payment to the Custodian and Trustee for administrative services not covered by revenue sharing.

#### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

#### **Note 8 – Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Hospital by a letter dated February 8, 2018, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended and restated since receiving the determination letter, the Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment instruments which are exposed to certain risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements and supplemental schedule.
