1. Description of Plan

The following description of the Rayser Holdings, Inc. 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by C.R. Pharmacy Services, Inc. (the "Company") for the benefit of its employees. The Plan was formed October 1, 1976 and was most recently amended on August 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Delaware Charter and Guarantee Trust Company d/b/a Principal Trust Company (the "Trustee") is responsible for oversight of the Plan as well as determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Plan Operation

The Company is the Plan Sponsor and Plan Administrator. The Trustee of the Plan is Delaware Charter and Guarantee Trust Company d/b/a Principal Trust Company. The Trustee also acted as Custodian and Recordkeeper of the Plan for the years ended December 31, 2024 and 2023.

Eligibility

Employees who have attained the age of 18 and have completed three months of service with the Company are eligible to participate in the Plan for the purposes of salary deferrals following the first day of the month subsequent to the date of meeting eligibility requirements. Ineligible employees are (1) employees whose employment is governed by the terms of a collective bargaining agreement, (2) leased employees, (3) employees who are considered to be independent contractors, and (4) nonresident aliens.

Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, and may also elect Roth 401(k) contributions. Participant contributions cannot exceed the Internal Revenue Code (IRC) annual limits. The Company will automatically withhold 6% from each participant's compensation unless the participant elects a different percentage or elects to not participate in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes a discretionary matching contribution, matching 50% of elective deferral contributions up to 6%. The Company also has a discretionary contribution which is based on the decision of management of the Company. No Company discretionary contributions were made for the year ended December 31, 2024. Participants direct the investment of contributions into selected options offered by the Plan.

Participant Investment Account Options

The Plan is intended to comply with Section 404(c) of ERISA. Accordingly, the participants, rather than the Plan Administrator, are responsible for making investment decisions for their accounts. Participants direct the investment of their account balances into various investment options offered by the Plan. During the year ended December 31, 2024, participants had the option to direct the investment of their contributions into various registered investment companies, common/collective trust funds, pooled separate accounts under a group annuity contract, with the underlying investments in various mutual funds, and a guaranteed return account offered by the Plan.

Participant Accounts

Separate accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, an allocation of any Company contribution, and the participant's portion of earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

Vesting

A participant is 100% vested in his or her contributions and employer qualified non-elective contribution (QNEC) at all times. Vesting in other Company contributions, including the discretionary match, to their account plus earnings thereon is based on years of credited service. Participants vest 20% each year beginning after two years service until they are 100% vested after six years. To earn a year of service, a participant must be credited with at least 1,000 hours of service during a Plan year. A participant is entitled to 100% of his or her account balance upon death or if he or she endures a total and permanent disability while an employee of the Company.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; terms may be longer if the loan is for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. At December 31, 2024 and 2023, the notes bear interest between 4.25% and 9.50% and mature at various dates through 2029. Notes receivable from participants are valued at their unpaid principal balance plus accrued interest. Principal and interest are paid ratably through payroll deductions. Interest income on participants' notes receivable was approximately \$7,000 for the year ended December 31, 2024.

Distribution of Benefits

Participants are eligible to receive benefits upon termination of employment, attaining the age of 59 1/2, disability, or as hardship withdrawals subject to certain requirements. A participant may elect to receive the value of the vested interest in his or her account as lump-sum payment, or in substantially equal installments. Terminating participants with balances of \$5,000 or less who have not requested a distribution will receive an automatic cash withdrawal. Partial withdrawals or installments are allowed but only with respect to minimum required distributions, over a period of not more than the participant's life expectancy.

Forfeited Accounts

The portion of a participant's account balance that is not fully vested will be forfeited if the participant separates from service. The timing of forfeiture will be the earlier of the last day of the Plan year in which the former participant incurs five consecutive 1-year breaks in service or distribution of the entire vested portion of the participant's account. These forfeited amounts may be allocated to the remaining eligible participants or used to offset Plan expenses. Forfeited amounts that were used to reduce employer contributions to the Plan in 2024 totaled approximately \$9,000. There were no forfeitures available at December 31, 2024 and 2023.

Plan Termination

Although the Plan has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.

2. Summary of Significant Accounting Policies

Basis of Presentation and Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates and the difference could be material.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on investments held during the year are presented in the net appreciation in fair value of investments.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment transaction fees, record keeping service fees, and fees related to the administration of notes receivable from participants are allocated or charged directly to the participants' accounts and are included in administrative expenses.

Fair Value Measurements

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the FASB fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

Fair Value Measurements (Continued)

The level in the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety. The Plan uses valuation techniques in a consistent manner from year to year.

Securing Strong Retirement Act

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reform that began with the 2020 CARES Act. Most of the provisions of SECURE 2.0 became effective in 2024 and beyond. The Plan Administrator has determined which provisions apply to the Plan and their impact on the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

3. Certification of Investment Information

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed its independent auditors not to perform, and they did not perform, any auditing procedures with respect to the information certified by the Trustee except for comparing the information with the related information included in the financial statements and supplemental schedule.

The Trustee has provided the Plan Administrator with certifications as to the completeness and accuracy of the net assets available for Plan benefits as they relate to investments and notes receivable from participants held by the Trustee as of December 31, 2024 and 2023 and changes in net assets available for Plan benefits for the year ended December 31, 2024 as they relate to investment income, including net appreciation in fair value of investment and interest and dividends, and interest income on notes receivable from participants.

5. Guaranteed Investment Contract

The Plan is participating in a benefit-responsive guaranteed investment contract (GIC) with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. Because the GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At December 31, 2024 and 2023, the contract value reported on the statements of net assets available for benefits relates to evergreen contracts, as the contract has no set maturity date.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is set by Principal Life using a process similar to that used by banks or other insurance companies for similar products. The crediting rate is declared in advance and is reset semiannually. At December 31, 2024 and 2023, the crediting interest rate was a 4.75% and 4.65% effective annual rate, respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is in accordance with a fully benefit-responsive investment contract and is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. As of December 31, 2024, the Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with participants were probable or occurring.

In addition, an employer-level liquidation of the investment will be subject to either a twelve-month advance notice or a 5% surrender charge, whichever the employer chooses. Notification of the Plan's intent to terminate its interest may be revoked within 90 days, after which time, notice becomes irrevocable.

6. Party-In-Interest Transactions

Plan investments during the year were registered investment companies (i.e. mutual funds), common/collective trust funds, pooled separate accounts, and a guaranteed return account managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions.

7. Tax Status

The Internal Revenue Service (IRS) has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed the Trustee of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan Administrative Committee/Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Due to the tax exempt status of the Plan, the Plan does not have any significant tax uncertainties that would require recognition or disclosure. The Plan is no longer subject to income tax examinations for the years before 2021.

8. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will continue to occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
