### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of ATEK Companies Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 (in liquidation) and 2023 (ongoing) and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion on the Financial Statements***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ATEK Companies Savings Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ***Emphasis of Matter***

As discussed in Notes 1, 2 and 6 to the financial statements, the Board of Directors authorized the termination of the Plan, and management determined liquidation is imminent during 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. In performing an audit in accordance with GAAS, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the ATEK Companies Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of the following affiliated companies: ATEK Management, Inc.; Progress Casting Group, Inc.; ATEK Access Technologies, LLC (through divestiture date effective August 21, 2024); Red Mountain Ranch Corporation; ATEK Metal Technologies, LLC (through divestiture date effective May 8, 2023); ATEK Plastics, LLC, Solar Plastics, LLC, and ATEK Fuidall, LLC effective April 5, 2021 (collectively, the Employers). Employees of the Employers who attain age 18 are eligible to participate in the salary deferral portion of the Plan immediately coinciding with or following the date the age requirement is met. The Plan excludes collectively bargained employees and nonresident aliens. Participants are eligible for discretionary matching contributions and discretionary nonelective contributions after attaining age 18 and completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On September 6, 2024, the Plan management approved the termination of the Plan effective December 31, 2024. Participants were provided distribution options from the Plan and all assets have been distributed from the Plan as of December 31, 2024.

**Contributions**

The Plan includes a 401(k) salary deferral arrangement. Under this arrangement and subject to Plan provisions, participants may elect to contribute up to the maximum allowed of their eligible compensation to the Plan. The Employers automatically withhold 3% as pre-tax contributions unless the participant elects otherwise. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Employers may make a discretionary match or a discretionary nonelective contribution to the Plan. For the years ended December 31, 2024 and 2023, the Employers matched 50% of participant contributions up to 6% of the participant's eligible compensation. There were no nonelective contributions for the years ended December 31, 2024 and 2023. A participant must be employed on the last day of the Plan year and complete at least 1,000 hours of service during the year to receive an allocation of the Employers' nonelective contributions. Contributions are subject to certain limitations.

**Participant Accounts**

The Plan permits participants to direct the investment of their account balance under the Plan. Each participant's account is credited with the participant's contribution, and allocations of (1) the Employers' contributions, (2) Plan earnings or losses, and (3) administrative expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account.

**Vesting**

Participants are immediately vested in their voluntary contributions and Employers' matching contributions plus actual earnings thereon. A participant's nonelective account for contributions made prior to 2007 is 10% vested after one year of service, increasing 15% every year thereafter, with 100% vesting after seven years of service or upon death, total permanent disability, attainment of age 65 or early retirement age of 55. For nonelective contributions made after December 31, 2006, the participant's nonelective account is vested as follows:

The Plan also recognizes past service with Air Regent Investors, Inc., Cornerstone Fuels International, Inc., Crosby Manufacturing, Inc., Datakey Electronics, Inc, and Solar Plastics, Inc.

**Forfeitures**

Forfeitures may first be applied to offset Plan expenses and next used to reduce the Employers' matching contributions. There were unallocated forfeitures of \$0 and \$2,067 at December 31, 2024 and 2023, respectively. There were no forfeitures used to reduce the Employers' matching contributions for the years ended December 31, 2024 and 2023. There were \$2,187 and \$0 of forfeitures used to reduce administrative expenses for the years ended December 31, 2024 and 2023, respectively.

**Benefit Payments**

Upon termination of the Plan, participants received their benefits in the form of lump sum payments. Prior to Plan termination, the benefit to which a participant was entitled was the benefit that can be provided from the participant's account. Participants elected to receive the value of their account as a lump sum or periodic distributions upon termination, retirement, death, or disability. Account balances less than \$5,000 were automatically distributed in a lump sum payment without the participants consent. If the vested balance exceeded \$1,000, the amount was paid in a direct rollover to an Individual Retirement Account. The Plan also permitted in-service distributions if attained age 59 1/2 or incurred a financial hardship or disability, as defined in the Plan.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest is paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

As a result of the Plan termination effective December 31, 2024, the Plan sponsor determined that liquidation of the Plan is imminent during 2024 when distributions under the plan of liquidation commenced. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements.

Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts. Investments stated at fair value which approximates the amount the plan expects to collect. All expenses and income incurred as a result of the termination and liquidation have been recognized in the financial statements as of December 31, 2024.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Fair Value Measurements (Continued)**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds* – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee is determined and published daily. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. Participant transactions (purchases and sales) may occur daily.

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

The Employers, at their discretion, absorb certain administrative expenses pertaining to the Plan. If not paid by the Employers, the administrative expenses become the responsibility of the Plan.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 INVESTMENT INFORMATION CERTIFIED BY TRUSTEE**

Delaware Charter Guarantee and Trust Company dba: as Principal Trust Company, the qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants presented in the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

The Plan Sponsor elected to terminate the Plan effective December 31, 2024. As a result of the termination, participants become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RELATED-PARTY TRANSACTIONS**

Plan investments are held by Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the qualified institution; therefore, these investment transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
