Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The HC Companies, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter-Plan Merger

As discussed in Note 2 to the financial statements, the Board of Directors of The HC Companies, Inc., the Plan's Sponsor, voted on August 15, 2024, to merge the Classic Home & Garden LLC Retirement Savings Plan into the Plan effective January 1, 2025. All plan assets were transferred to the Plan on January 10, 2025. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1. Description of Plan

The following description of The HC Companies, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was established in 2015 by The HC Companies, Inc. (the Company and Plan Sponsor) to provide retirement benefits to eligible United States employees of the Company.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The assets of the Plan are maintained, and transactions therein are executed, by Principal Trust Company, the Plan's trustee. An employee is eligible to participate in the Plan if they are not certain sales representatives, a member of a union in which retirement benefits have been subjected to collective bargaining, or are not covered under another qualified pension or profit sharing plan maintained by the Company. An employee must have completed 60 days of service with the Company to be eligible for employee deferrals and the employer safe-harbor match.

Contributions: Each year, participants may make pre-tax contributions in any amount up to 75% of their annual compensation up to the statutory limits determined annually by the Internal Revenue Code (IRC). If participants do not make an initial election to make contributions at the time they are initially eligible to, participants shall be deemed to have made an initial election to have contributions made on their behalf in accordance with the Plan document at the rate of 3% of their compensation, as defined in the Plan document. The Company makes matching contributions equal to 100% of participant contributions not to exceed 3% of compensation and 50% of the amount of the participant's elective deferrals that exceed 3% of compensation but that do not exceed 5% of the participant's compensation. Additionally, the Company may make additional discretionary profit-sharing contributions. The Plan permits rollover contributions from other qualified plans.

Participant accounts: Each participant account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: Participants must direct contributions into various investment options as made available and determined by the Plan Administrator, which are more fully described in the Plan's literature. Participants may change their investment options any time throughout the year via telephone and/or internet access to the trustee.

Vesting: Participants are immediately vested in their tax-deferred, safe-harbor employer match and rollover contributions. If a participant has a separation from service on account of death, retirement or disability retirement, the participant will be deemed fully vested in their profit-sharing contributions.

Otherwise, vesting in profit sharing contributions shall be 0% until the employee has completed two years of vesting service, at which time they will become 20% vested with an additional 20% for each additional year of service completed. Participants are fully vested upon completion of six years of service. Service with certain prior employers, as defined in the Plan document, may be considered in the determination of vesting of contributions.

Funding: The Company's funding policy is to make contributions to the Plan as soon as administratively feasible.

Note 1. Description of Plan (Continued)

Payment of benefits: A participant or his or her beneficiary, upon termination, death, or retirement, may receive the vested interest in his account in the form of a lump-sum payment or periodic installments. Additionally, the Plan has provisions for an active participant to make hardship withdrawals from his or her voluntary contribution account, subject to limitations and restrictions. Balances of terminated participants of less than \$7,000 are automatically distributed to the participants.

Notes receivable from participants: The Plan allows for participants to borrow from their accounts a minimum of \$1,000 and a maximum of 50% of their vested account balance up to \$50,000. The interest rate must be a reasonable rate as determined by the Plan Administrator. Maturities on these loans must be greater than six months and not exceed five years, unless the loan is for the purchase of a home, in which case the loan maturity may be for a period of up to 10 years. The loans are secured by the balance in the participant's account.

Forfeited accounts: Forfeitures of terminated participants' nonvested accounts are first used to pay plan expenses and then to reduce Company discretionary and matching contributions. Any remaining forfeitures are then allocated to the remaining participants in the Plan. During 2024, no forfeitures were used to offset Company contributions and as of December 31, 2024 and 2023, there were no unapplied forfeitures.

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the term of the Plan document.

Note 2. Summary of Significant Accounting Policies (Continued)

Contributions: Participant contributions and Company matching contributions are recognized when the participant contributions are withheld from the participant's earnings. Company discretionary profit sharing contributions, if any, are approved by the Company's management at the end of the year and are recognized in the year of service.

Administrative expenses: Expenses of the Plan are paid either by the Company or the Plan, at the discretion of the Company.

Benefit payments: Benefits are recorded when paid.

Risks and uncertainties: The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, two funds made up approximately 25% of the Plan's total investments (both individually greater than 10%). This is considered a concentration of credit risk.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 10, 2025, the date the financial statements were available to be issued.

On January 1, 2025, the Classic Home & Garden LLC Retirement Savings Plan merged into the Plan. On January 10, 2025, the Plan received transferred funds of approximately \$2,400,000 in connection with the merger. The Plan document was also modified, effective January 1, 2025, to permit participant Roth deferrals and in-plan Roth rollovers by participants.

Note 3. Information Certified and Provided by Principal Trust Company, the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year-end.

Note 4. Fair Value Measurements (Continued)

Pooled separate accounts: Valued at the NAV of shares held by the insurance company in their pooled accounts at year-end. The Plan's interest in the pooled separate accounts is valued based on the information reported by the custodian.

Common/collective trust funds: Valued at the NAV of units of the common/collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan entered into a traditional investment contract with Principal Life Insurance Company, an affiliate of Principal Trust Company. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1% or greater than 3%. Such interest rates are reviewed on a semi-annual basis for resetting. The contract does permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5. Investment Contract with Insurance Company (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures of spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 6. Tax Status

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Party-in-Interest Transactions

The Plan invests in various common/collective trust funds, pooled separate accounts, and a guaranteed investment contract managed by Principal Trust Company (Principal), the trustee of the Plan, and affiliates and, therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, there were approximately \$160,000 of fees paid by the Plan to Principal.
