INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of the
403(b) Thrift Plan of Visiting Nurse and Hospice Care of Santa Barbara:**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 403(b) Thrift Plan of Visiting Nurse and Hospice Care of Santa Barbara (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects,

the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The Form 5500 – schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 – Description of the Plan

The following description of the 403(b) Thrift Plan of Visiting Nurse and Hospice Care of Santa Barbara (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The 403(b) Thrift Plan of Visiting Nurse and Hospice Care of Santa Barbara, established January 1, 2004, is a defined contribution plan for eligible employees of VNA Health and Affiliates (the Organization or Plan Administrator or Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2020 the Plan was amended and restated in its entirety to include all amendments since Plan adoption on January 1, 2004.

The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for distributions, waive required minimum distributions for 2020 that were made after April 1, 2020, and increase the age requirement for required minimum distributions. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service (IRS) guidance.

Contributions

Each year, participants may elect to defer up to 100% of pretax annual compensation, as defined in the Plan, subject to IRS limitations. The Organization contributes matching contributions equal to the lesser of 100% of the employee contribution or 4% of the employee's eligible compensation. Additional amounts may be contributed at the option of the Organization's board of directors. All assets of the Plan are participant directed and Plan participants may select from several investment options offered by the Mutual of America Life Insurance Company.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 – Description of the Plan (Continued)

Eligibility and Vesting

Employees become eligible to participate in the Plan upon date of hire. Furthermore, they become eligible for an employer match in the Plan following completion of 12 consecutive months of employment with at least 1,000 hours of service during that period, with some exclusions. The entry dates for employer contributions are the first pay date immediately following the completion of the service requirement. Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 100% vested in employer contributions made on or before December 31, 2016 after five years of credited service. Participants are immediately vested in employer contributions made on or subsequent to January 1, 2017.

Payment of Benefits

On termination of service, due to death, disability, or retirement, a participant may elect to receive their benefits in a lump sum or installment payments equal to the value of his or her account, or rollover their account into a new plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a terminating participant's balance is less than \$1,000 he or she will receive a lump-sum distribution automatically.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are used to pay any charges related to the termination of employment of the participant whose termination resulted in the forfeiture, and any other charges which are past due, then to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and none were used to offset employer contributions in 2024. As employer contributions after December 31, 2016 are fully vested, forfeitures are not expected to be significant.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 – Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative costs of the Plan are absorbed by the Organization and are excluded from these financial statements.

Note 3 – Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The Plan administrator believes that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the Code, and is currently being operated in conformity with the applicable requirements of the Code and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

Note 4 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

Note 5 – Information Certified by Insurance Company

The following is a summary of the plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Mutual of America Life Insurance, the insurance company of the Plan. The Plan Administrator has obtained certifications from the insurance company that information provided to the Plan Administrator by the insurance company related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

The insurance company also certified to the completeness and accuracy of \$2,325,897 of net appreciation in the fair value of pooled separate accounts and \$77,937 of interest and dividends related to the aforementioned investments for the year ended December 31, 2024.

Note 6 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Note 6 – Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The separate account investments consist solely of investments in mutual funds registered with the Securities and Exchange Commission. The units of pooled separate accounts are stated at fair value as determined based on the net asset value (NAV) of the underlying investments, as a practical expedient. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Investment Contract

The Plan holds an investment in the Mutual of America Interest Accumulation Account (the Account). The Account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The interest accumulation account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract value of the Account was \$2,909,368 and \$2,832,304 at December 31, 2024 and 2023, respectively.

Note 7 – Investment Contract (Continued)

Certain events can limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the Custodian to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The interest accumulation account does not permit the Custodian to terminate the agreement prior to the scheduled maturity date.

Note 8 – Termination of Plan

Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan subject to the provisions of ERISA.

Note 9 – Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Mutual of America. Mutual of America Life Insurance Company was the Plan's insurance company in 2024 and 2023, therefore, these transactions qualify as party-in-interest transactions.

Note 10 – Plan Loans

Participants may borrow from Mutual of America, subject to certain limitations. Plan loans are issued directly from the funds owned by Mutual of America, and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's account balance is reserved, or held in collateral, in the Mutual of America Interest Accumulation Account to cover the outstanding loan amount. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 50% of the Participant's vested balance. During 2020 the Plan implemented CARES Act provisions to allow for an increase in Plan loan amounts to the lesser of \$100,000 or 100% of the participant's vested balance for loans taken through September 22, 2020, and deferral of loan payments until December 31, 2020.

Note 10 – Plan Loans (Continued)

The loans bear interest ranging from 4.60% - 5.85%, which is commensurate with local prevailing rates as determined periodically by Mutual of America. Principal and interest are paid through regular semi-monthly payroll deductions by the participant to Mutual of America and generally must be repaid within five years (longer for residential loans). In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. When a distributable event occurs, an amount equal to the outstanding loan principal and interest are deducted from the account and the loan is repaid. As of December 31, 2024 and 2023, there were no loans in default.

The balance of the plan loans outstanding as of December 31, 2024 and 2023, are \$286,257 and \$223,188, respectively. Plan loans are not reflected in the statement of net assets available for benefits.

Note 11 – Subsequent Events

Subsequent events have been evaluated through October 8, 2025, the date that the financial statements were available for issuance.

The Securing a Strong Retirement Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022, and includes mandatory and optional provisions with effective dates in 2025 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.
