INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of
Marketing Alliance Group 401K Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Marketing Alliance Group 401K Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Marketing Alliance Group 401K Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of Financial Statements section of our report. We are required to be independent of Marketing Alliance Group 401K Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Note 1. Description of Plan

The following description of the Marketing Alliance Group (“Company”) 401K Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General-

The Plan is a defined contribution plan. Employees are eligible to join the Plan as an active participant on a quarterly basis after they have reached eighteen years of age and have completed one year of service, defined as one calendar year and 1,000 hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Contributions-

Each year participants may contribute up to 100% of pre-tax annual compensation, limited by IRS annual contribution limits, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts, mutual funds, and a guaranteed investment contract. The Company, at the option of the Board of Directors, may make matching contributions. Currently, the Company has elected to make matching contributions of 35% of base compensation contributed by the participant, up to a maximum Company contribution of 5% of compensation. There is no change in the funding policy from the prior year. Contributions are subject to certain statutory limitations.

Participant accounts-

Each participant's account is credited with the participant's contribution, earnings on participant account balances, and allocations of the Company's matching contributions. Allocations are based on participant earnings or account balances, as defined. Participant charges are charged to the participant’s account based upon participant requested services; all non-participant generated administrative expenses are paid using forfeitures or by the Plan Sponsor. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting-

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on the elapsed time method. A participant is 100% vested after five years of credited service.

Payment of benefits-

On termination of services, a participant generally will receive a lump-sum amount equal to the value of his or her vested account unless elected otherwise by the participant in certain situations.

Forfeited accounts-

Forfeitures of nonvested accounts are used to reduce employer contributions or to pay administrative expenses. Forfeitures totaling \$14,451 were used to reduce employer contributions and forfeitures totaling \$35,924 were used to pay administrative expenses for the year ended December 31, 2024. Unused forfeitures of nonvested accounts totaled \$883 at December 31, 2024, and will be used to reduce employer contributions or to pay administrative expenses in future periods.

Plan administration costs-

The Company absorbs significant costs of Plan administration related to legal, accounting, record keeping, and general administration. Expenses that are paid by the Company are excluded from these financial statements.

Note 2. Summary of Accounting Policies

Basis of accounting-

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition-

Plan assets are invested in pooled separate accounts, a collective investment trust, and a guaranteed investment contract, all with Principal Life Insurance Company (“Principal”), and in mutual funds. Pooled separate accounts, mutual funds, and the collective investment trust are valued at fair value as measured by the net asset value (“NAV”) of each account on the last day of the Plan year. The guaranteed investment contract is considered a fully benefit-responsive investment contract and is reported at contract value. The Plan administrator determines the Plan’s valuation policies utilizing information provided by investment advisers, custodians, and Principal. See Note 4 for additional information regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments in the accompanying statement of changes in net assets available for benefits includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Excess contributions payable-

Amounts payable to participants totaling \$77,216 and \$113,748 for contributions in excess of amounts allowed by the IRS in accordance with rules for highly compensated employees were recorded as accounts payable at December 31, 2024 and 2023, respectively. The Plan will distribute the excess employee contributions prior to March 15 of the following year.

Payment of benefits-

Benefits are recorded when paid.

Estimates-

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events-

Management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

Note 3. Investment Contracts - Fully Benefit Responsive

The Plan holds an investment contract which is considered fully benefit-responsive. The contract is traditional and is a guaranteed general-account backed group annuity contract that is issued by Principal. A rate of interest contractually guaranteed by Principal is credited to the participant account balances. The net crediting rate was 4.85% at December 31, 2024. No redemption fees, early withdrawal charges, or market value adjustments are charged on participant transfers of assets into or out of the contract. An employer-level termination of the Plan’s interest in the contract may be paid out in six installments over five years, or as a single sum subject to an early termination charge. Participant transactions are executed using contract value without adjustment. The contract is reflected at contract value within net assets available for benefits, and is measured, presented, and disclosed only at contract value, which was \$753,732 and \$0 at December 31, 2024 and 2023, respectively.

Note 4. Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1	Fair values are based on quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date.
Level 2	Fair values are based on inputs other than quoted prices included within Level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.
Level 3	Fair values are based on unobservable inputs used for valuing the asset or liability. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when a lower-level input is not available.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Valuation methodologies used for assets measured at fair value are as follows:

Pooled separate accounts: Pooled separate accounts (“PSAs”) are valued based on the underlying investments. They invest mainly in stocks, the majority of which have observable quoted pricing inputs. The NAV of the PSAs is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV. Therefore, we believe that this investment has a readily determinable fair value. The NAV is calculated in a manner consistent with GAAP for investment companies.

Mutual funds: Mutual funds are valued at a quoted market price available on the open market.

Collective investment trust: Collective investment trusts (“CITs”) are valued based on the underlying investments. They invest in a variety of pooled separate accounts and mutual funds, the majority of which have observable quoted pricing inputs. The NAV of the CITs is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the CIT can be redeemed at NAV. Therefore, we believe that this investment has a readily determinable fair value. The NAV is calculated in a manner consistent with GAAP for investment companies.

All pooled separate accounts, mutual funds, and collective investment trusts are considered Level 1 at December 31, 2024 and 2023.

Note 5. Party-In-Interest Transactions

Plan investments include shares of pooled separate accounts, a collective investment trust, and a guaranteed investment contract, all managed by Principal. Principal is the trustee for the Plan, and therefore, qualifies as a party-in-interest. Fees paid by the Plan to the trustee for investment management services totaled \$71,232 for the year ended December 31, 2024. Additional fees paid by participants to the trustee for participant requested services totaled \$19,791 for the year ended December 31, 2024.

Note 6. Plan Terminations

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Internal Revenue Service (“IRS”) has informed the trustee of the Prototype Plan, by a letter dated June 30, 2020, that the Plan is acceptable under Section 401 of the Internal Revenue Code (“IRC”) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

Note 7. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS, US Department of Labor, or Georgia Department of Revenue. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9. Market Risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Information Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule h, line 4i – schedule of assets held at end of year as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
