### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dodge Construction Network 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Basis for Opinion**

#### Note 1. Description of Plan

The following description of Dodge Construction Network 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Dodge Construction Network, LLC. The Charles Schwab Trust Company (the Directed Trustee), a division of Charles Schwab Bank, serves as the directed trustee to the Plan. The Directed Trustee is only permitted to invest the assets of the Plan as directed by the Plan Administrator, the Plan Sponsor, or another named fiduciary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986 (IRC), as amended.

Effective April 5, 2023, the Plan was amended to allow service with Principia Consulting LLC to be credited when determining eligibility to participate in the Plan and determining vested interests in accounts. Additionally, Principia Consulting 401(k) was merged into the Plan effective April 5, 2023.

**Eligibility:** Employees who have attained the age of 18 are eligible to contribute on the first day of the month following one full month of service. Temporary employees are excluded from participation in the Plan. Employees are eligible for matching and discretionary contributions if they've completed at least 1,000 hours of service.

**Contributions:** Participants may contribute up to the maximum percentage of compensation or dollar amount permissible under Section 402(g) of the IRC, not to exceed limits of IRC Sections 401(k), 404 and 415. Contributions are invested in various investment options as directed by the participants. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The Plan also include an automatic savings increase provision whereby a participant's salary deferral election will be increased by 1% each January 1<sup>st</sup> to a maximum of 15%.

The Plan Sponsor matches 100% of the participant's contributions to the Plan up to 1% of compensation plus 50% of the participant's contributions that exceed 1% of compensation up to 6% of compensation. The Plan Sponsor may make a discretionary contribution to the Plan, pro-rata based on the compensation of all benefiting participants. The Plan Sponsor did not authorize discretionary contributions for the years ended December 31, 2024.

**Participant accounts:** Each participant's account is credited with the participant's contribution, the Plan Sponsor's matching and discretionary contributions, and Plan earnings on such contributions and is charged with an allocation of administrative expenses. Upon enrollment in the Plan and anytime thereafter, participants may elect from among several investment vehicles offered by the Plan to which contributions on their behalf shall be directed. The benefit to which a participant is entitled is represented by the vested balance in the participant's account.

**Vesting:** Participants are immediately vested in their contributions and actual earnings thereon. The Plan Sponsor's matching contributions vest 100% at two years of service and discretionary contributions vest 100% at three years of service.

#### Note 1. Description of Plan (Continued)

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of the participant's vested account balance. The loans are secured by the balance in the participant's accounts and bear interest at a rate commensurate with market rates for similar loans. Principal and interest are paid ratably through payroll deductions over a period of five years or less, unless the withdrawal was for the purchase of a primary residence, in which case the period can be extended to 10 years. Participants can have no more than two loans outstanding at any given time. At December 31, 2024, the interest rate on outstanding loans ranged from 3.25% to 10.50%, maturing on various dates through May 2033.

**Payment of benefits:** Upon termination of service due to death, disability or retirement, participants or their beneficiaries may elect to receive 100% of the participant's account balance in either a lump-sum amount or in annual installments over a period of years in accordance with the Plan document. For termination of service due to other reasons, participants may elect to receive the value of their account balance in a lump-sum distribution, in equal installments, or as a direct rollover to another qualified plan. Benefits are recorded when paid. No amounts were allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid as of December 31, 2024 or 2023.

**Administrative expenses:** Administrative expenses consist of transaction fees which are paid by the participants by reducing the account balances of those participants initiating the transactions. For the year ended December 31, 2024, such expenses amounted to \$12,682. Administrative expenses also consist of other recordkeeping fees which amounted to \$106,000 for the year ended December 31, 2024.

**Forfeited accounts:** Unallocated forfeitures are used to pay administrative expenses or to reduce employer contributions. For the year ended December 31, 2024, forfeitures of \$54,082 were used to pay administrative expenses and forfeitures of \$78,109 were used to reduce employer contributions. As of December 31, 2024 and 2023, there were \$203,468 and \$141,629 of unallocated forfeitures, respectively.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements of the Plan were prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. During the year ended December 31, 2024, participants defaulted on notes receivable amounting to \$131,733. The Directed Trustee has issued 1099s to the participants to report the income generated from the defaulted notes receivable balances. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 7 for discussion of fair value measurements.

#### **Note 2. Summary of Significant Accounting Policies (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Fair value measurement:** Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Under the standard, fair value is defined as the exit price, or the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### **Note 3. Risks and Uncertainties**

The Plan invests in various investment options in combinations of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the related statement of changes in net assets available for benefits.

#### **Note 4. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to the entire amount of their account.

#### **Note 5. Tax Status**

The Plan uses a prototype plan document sponsored by the Directed Trustee, which received an opinion letter from the Internal Revenue Service (IRS) dated September 21, 2020, stating that the prototype document satisfied the provisions of the IRC. The Plan itself has not received a determination letter from the IRS and the Plan has been amended since the date of the opinion letter received by the Directed Trustee. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) of the IRC and is exempt from federal income taxes under Section 501(a) of such code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Additionally, certain administrative expenses are paid directly by the Plan Sponsor.

Certain Plan investments are invested in registered investment companies and common collective trusts managed by the Directed Trustee of the Plan. Accordingly, these transactions qualify as party-in-interest transactions.

The Plan issues loans to participants, which are secured by the balances in the participant's account, and which also constitute party-in-interest transactions.

A Plan expense account was established to hold revenue-sharing funds received from Charles Schwab, pursuant to an agreement. The Plan paid out of this account \$0 and \$0 in fees for direct expenses attributable to the Plan during the years ended December 31, 2024 and 2023, respectively.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are valued at the daily closing prices as reported by the Fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Stable value fund:** Stable value fund is a diversified portfolio of publicly traded fixed-income instruments, and is valued at NAV per unit based on the underlying investments comprising the fund based on audited financial statements. The current average credit quality of the underlying fixed-income investments is AAA and is benchmarked to the Prudential Core Conservative Bond Fund. These investments are available to be redeemed immediately, and there are no redemption restrictions or notice periods required. There were no unfunded commitments as of December 31, 2024 and 2023.

There were no significant transfers between Levels 1, 2 and 3 during the years ended December 31, 2024 and 2023.
