Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fleis & VandenBrink Engineering, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF THE PLAN

Fleis & VandenBrink Engineering, Inc. 401(k) Plan (the Plan) is a defined contribution plan under Section 401(k) of the Internal Revenue Code. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Participants should refer to the Plan agreement for complete information.

Eligibility - The Fleis & VandenBrink Engineering, Inc. 401(k) Plan is a defined contribution plan covering all full-time employees of F&V Companies, Inc. (the Company) who are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Employee contributions to the Plan are elective for participants of the Plan and are in the form of pre-tax or Roth salary deferrals, not to exceed the current IRS imposed limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollovers to the Plan from other qualified plans. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are automatically invested in a designated target fund until changed by the participant. All participants with a deferral rate of less than 6% will have an annual escalation of 1% up to a deduction rate of 6% unless the participant declines the automatic increase. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an investment contract as investment options for participants.

During the plan year, the Plan Sponsor identified a corrective qualified non-elective contribution (QNEC) of \$60,778. This amount has been recorded as an employer contribution receivable as of December 31, 2024 and was funded subsequent to year-end.

Participant Accounts - Each participant's account is credited with the participant's contribution allocations of plan earnings, and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - A participant's account balance, made of employee qualifying contributions and related investment earnings, vests immediately.

Payment of Benefits - Funds may be withdrawn from a participant's account upon the occurrence of one of the following: hardship, attainment of age 59-1/2, QDRO, death, total disability, termination of employment, transfer of employment, or attainment of age for required minimum distribution. Upon termination of service, a participant may elect to either receive distribution of a lump-sum amount equal to the value of the participant's vested interest in his or her account, or to transfer the value of the participant's account into another qualified retirement plan. Upon termination of service, the Plan allows for automatic rollover of vested account balances of \$5,000 or less.

Distributions and benefits are recorded when paid.

Notes Receivable - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Administrative Expenses - A portion of the administrative expenses of the Plan are paid by the Plan's sponsor. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value investments.

Forfeitures - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,150 and \$7,544, respectively. These amounts are to be used to reduce future company contributions or pay plan expenses. During the years ending December 31, 2024 and 2023, plan expenses were reduced by \$1,650 and \$1,125, respectively from forfeited nonvested accounts.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Valuation of Investments and Income Recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

The fully benefit-responsive investment contract is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the plan.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

All information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants from the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, Empower Annuity Insurance Company of America, and Empower Annuity Insurance Company, qualified institutions.

NOTE 4 - INCOME TAX STATUS

The Internal Revenue Service has reviewed and approved the plan document in a letter dated August 23, 2023. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in a benefit-responsive investment group annuity contract with Empower Annuity Insurance Company of America totaling \$450,021 and \$1,122,166 at December 31, 2024 and 2023, respectively. The account is credited with earnings at guaranteed credit rates, and charged for participant withdrawals and administrative expenses.

As described in Note 2, the contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus interest credited to the prior value of the investment, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The underlying assets held by the contract are general assets of the insurance company issuing the contract and consist primarily of bonds diversified across a range of fixed-income asset classes such as asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgages, and private equity. The contract provides for a guaranteed rate of interest for a specified period. The rate is reset every quarter as determined by Empower. A formula is provided for the contract to adjust renewal crediting rates to recognize the difference between fair value and the book value of the underlying assets. Empower guarantees that the rate will never be less than zero.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

In general, issuers may terminate the contract if the Plan representative announces its intention to terminate, cancel, or merge the Plan, the qualification status of participant employer or plan changes, there is a breach of material obligations under the contract and misrepresentation by the

contract holder, or failure of the underlying portfolio to conform to pre-established investment guidelines. The plan administrator does not believe that any events which would allow the issuer to terminate the contract are probable of occurring. There are not any events that would limit the ability of the Plan to transact at contract value so long as the group annuity contract remains in force.

NOTE 6 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology includes quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There are no level 2 or level 3 investments in the Plan.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The

mutual funds held by the Plan are deemed to be actively traded and are presented as level 1 in the fair value measurements table.

Units of pooled separate accounts: Valued at NAV of the units of pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the pooled separate accounts. This practical expedient is not used when it is probable that the fund will sell for an amount different from the reported NAV. The pooled separate accounts can be redeemed at NAV as of the measurement date and can be redeemed on a daily basis. There are no unfunded commitments.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities and the Company's common stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - TRANSACTIONS WITH PARTIES IN INTEREST

Empower Annuity Insurance Company of America served as one of the Plan's recordkeepers and custodians for the period ended December 31, 2024. Fees paid by the Plan to Empower Annuity Insurance Company of America amount to \$57,605 and \$28,398 for the years ended December 31, 2024, and 2023, respectively. The Plan paid Rockefeller Financial \$23,508 for advisory services during the year ended December 31, 2024. The Plan paid Merrill Lynch \$20,417 and \$31,395 for advisory services during the years ended December 31, 2024, and 2023, respectively. The recordkeeping, custodial and advisory service fees are included in administrative fees on the statement of changes in net assets available for benefits.

As described in Note 1, the Company pays a portion of the plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 10 - SUBSEQUENT EVENTS

Management of the Plan has evaluated subsequent events through the date of the independent auditors' report, October 7, 2025, which was the date the financial statements were available to be issued.
