INDEPENDENT AUDITORS' REPORT

To the Trustees
Car Toys and Wireless Advocates 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Car Toys and Wireless Advocates 401(K) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have an audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

Note 1 - Description of Plan

The following description of the Car Toys and Wireless Advocates 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan covering substantially all employees of Car Toys, Inc. and an affiliated company, Wireless Advocates LLC, (collectively “the Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees are eligible for participation in the Plan upon attaining the age of eighteen years and completion of six months of service, as defined in the Plan document.

Contributions

Participants may contribute up to 100% of eligible compensation (as defined in the Plan document), subject to the maximum dollar amounts allowed by the law. Contributions from participants can be either pre-tax or Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers from other qualified plans”).

Employer matching contributions are discretionary. Matching contributions, if any, will be made only on the first six percent of compensation deferred and will be allocated to the extent necessary to satisfy certain statutory tests. Participants must be employed on the last day of the Plan year in order to be eligible for the employer matching contribution. Matching contributions, if any, are funded annually. The Plan also contains provisions allowing the Company to make discretionary profit-sharing contributions.

No employer matching contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, and allocations of employer matching contributions, if any, and net Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants have full discretion to direct their proportionate share (vested and non-vested) of Plan assets to a variety of investment funds.

Vesting

Employee contributions and related earnings are 100% vested at all times. Employer contributions and allocated earnings thereon vest with individual participants based upon years of service, with 100% vesting after five years of service or at normal retirement age.

Forfeited Accounts

Unvested benefits of terminated participants are forfeited and used to offset Plan expenses or may be used to reduce the employer's matching contribution. For the year ended 2024, forfeitures in the amount of \$13,294

were used to pay Plan expenses. At December 31, 2024 and 2023, there were \$6,552 and \$1,898, respectively, of forfeitures included with net assets available for benefits to reduce future administrative expenses or employer discretionary matching contributions.

Notes Receivable from Participants

Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance. Loans have terms of not more than five years, except for the purchase of a primary residence, are secured by the balance in the participant's account and bear interest at 4.25% to 9.50%. Principal and interest are paid ratably through monthly payroll deductions.

Benefit Payments

Upon termination of service due to death, disability or retirement, a participant or his/her designated beneficiary may elect to withdraw his/her entire account balance, but the withdrawal can only be in the form of a lump-sum payment. If the value of a participant's vested account balance is \$1,000 or less, the participant will receive an immediate cash-out of his/her account balance as soon as administratively feasible. If the value of the participant's account is between \$1,000 and \$5,000, the participant may elect a cash distribution or rollover to an individual retirement account.

In the event of hardship (as defined by the Plan document), participants may withdraw some or all of their account balances, subject to the requirements of the Plan document.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Matching contributions from the Company are recorded in the period in which the related participant contributions are recorded.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation (depreciation) of investments represents the change in fair value of assets from one period to the next and includes realized gains and losses on investments.

Administrative Expenses

Plan expenses consist of contract administration fees, third-party administrator fees and professional service fees and are paid by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the audited financial statements were available to be issued.

Note 3 - Fair Value Measurements

Fair value is defined as an exit price, representing the amount that would be used to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability.

There are three levels that prioritize the inputs used in measuring fair values as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a describes the valuation methodology used for the Plan's assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange

Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: The stable value fund is valued at net asset value. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be issued if it were determined to be probable that the fund would sell the investment for an amount different from the reported net asset value. Participant transactions may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to impose a hold period at the contract level.

Note 4 - Information Prepared and Certified by Reliance Trust Company

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplementary Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5 - Tax Status

Effective January 1, 2022, the Plan was amended and restated, and the Company adopted a profit sharing non-standardized plan. The non-standardized plan administrator was informed in a letter dated June 30, 2020 from the Internal Revenue Service (IRS) determining that the non-standardized plan, as designed, is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of December 31, 2024, the Plan has not taken any uncertain positions that would require recognition or disclosure. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

Note 6 - Plan Termination

On October 2, 2025, the Plan trustees approved the termination of the Plan, effective October 17, 2025. As a result, all participants with an account balance remaining in the Plan as of October 17, 2025 became fully vested in all contribution sources, regardless of years of vested service. The termination also ceased both employee and employer contributions to the Plan, as well as the issuance of new participant notes receivable. The Plan has begun the process of liquidating and distributing all participant account balances.

At this time, the accompanying financial statements do not reflect any adjustments related to the termination. Management has evaluated the Plan's ability to continue as a going concern in light of the termination and determined that there are no significant uncertainties regarding the Plan's ability to settle all obligations in an orderly manner.

Note 7 - Partial Plan Termination

Wireless Advocates LLC filed for bankruptcy on January 23, 2023. This action, based on IRS rules, resulted in a partial plan termination. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the Plan Sponsor. If a partial plan termination occurs, full vesting is required for the terminated participants, but the remaining participants' vesting continues to be determined according to the plan provisions.

All terminated employees who were participants in the Plan were fully vested in their account balances at the date of the partial plan termination.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
