Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Springfield Workshop, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Springfield Workshop, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. Description of plan

The following description of Springfield Workshop, Inc. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all eligible employees of SWI Industrial Solutions, Inc., Springfield Workshop Foundation, Inc. and Choices Career Services, Inc. (collectively, the “Company”) who have performed two months of service of service and are age twenty-one or older. The Company operates in Missouri. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligible employees include all leased employees and staff of the Company with the exception of highly compensated employees, production workers, fork truck drivers, janitorial, lead workers, mowing crew, line leaders, balers, SWPA janitorial, and SWPA mowing.

b. Contributions

Each year, eligible participants may contribute a percentage of their annual compensation, as defined in the Plan, subject to contribution limits set forth by the Internal Revenue Service. Employees may elect to make contributions on the first day of the month following their plan eligibility date.

The Company may elect to contribute a discretionary matching contribution annually. For 2024, the Company contributed an amount equal to 100% of employee contributions up to 6% of Plan compensation.

The Company may also make a non-elective discretionary contribution to the Plan. Non-elective contributions will be allocated to eligible employees based on their Plan compensation as a percentage of total Plan compensation for the Plan year.

Discretionary matching contributions are made to eligible employees who have performed one year (1,000 hours) of service and are age twenty-one.

1. Description of plan (continued)

c. Participants' accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Vesting in the Company's discretionary matching contribution and non-elective contributions plus actual earnings thereon is based on years of service. A participant is 100% vested after four years of credited service for discretionary matching and profit-sharing contributions.

The vesting schedule is as follows:

e. Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount of the value of the participant's vested interest in their account. For required minimum distributions, a participant may elect to receive installments of their vested account balance.

f. In-service withdrawals

Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferrals.

Participants who have obtained the age of 59 ½ or upon disability are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

1. Description of plan (continued)

g. Participant investment rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

h. Forfeitures

Forfeitures of employer discretionary contributions are allocated evenly to eligible employees based on their Plan compensation as a percentage of total Plan compensation for the Plan year. For the year ending December 31, 2024, forfeitures available for the plan year 2025 amounted to \$630.

i. Parties-In-Interest

John Hancock Life Insurance Company (USA) is the trustee/custodian of the Plan investments and executing transactions therein. The third-party administrator is Farmer & Betts. The Plan sponsor is SWI Industrial Solutions, Inc. Roberts, McKenzie, Mangan and Cummings, P.C. is the independent auditor. Each of these entities are classified party-in-interest with respect to the Plan.

2. Summary of significant accounting policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

3. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

4. Administrative costs

During the year ended December 31, 2024, \$6,815 of administrative expenses were paid by the Plan. All other administrative costs are paid by the Plan sponsor.

5. Tax status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Fair value measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

6. Fair value measurements (continued)

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Pooled separate accounts: Valued at the net asset value of shares held by the Plan at year end.

General account: Valued at the contract value which is deemed to be fair value for an insurance company general account.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
