INDEPENDENT AUDITORS' REPORT

To the Trustees of the
Stay Green, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Stay Green, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion



NOTE 1: DESCRIPTION OF PLAN

The following description of the Stay Green, Inc. 401(K) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) and profit sharing plan covering substantially all eligible employees of Stay Green, Inc. ("Company") except employees covered under a collective bargaining agreement, nonresident aliens who receive no earned income from sources within the United States, leased employees and self-employed individuals. Employees who have completed three months of service and are age eighteen or older are eligible to participate in the Plan. Employees who have completed one year of service and are over eighteen of age are eligible to receive employer matching contributions and non-elective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code. The Plan also provides for transfers from other eligible plans. The Company has elected to make a safe harbor contribution of 100% of the first 3% and 50% of the next 2% of compensation that a participant contributes to the Plan. The Company may elect to contribute, on a discretionary basis, additional matching and/or discretionary profit sharing contributions which would be allocated to all eligible employees. No discretionary contributions were made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant is credited with the participant's contributions and allocations of (a) the Company's contribution, and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Vesting

Participants contributions, rollover and Employer safe harbor contributions, plus actual earnings thereon are immediately vested. Vesting in the Company's non-elective and matching contributions of their accounts is based upon years of continuous service. Participants vest 20% per year of service starting after the completion of two years of service, and are fully vested after the completion of six years of continual service. Company contributions are fully vested upon death, disability or the participant reaching normal retirement age.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments not to exceed the participant's (and beneficiary's, if applicable) life expectancy. If a participant's vested benefit in the Plan does not exceed \$5,000, then their distribution will be in a lump-sum payment. A participant may make a hardship withdrawal from the participant's account subject to certain ERISA provisions.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance of the participant's account and bear interest at rate of 5.25% - 10.50%, which is commensurate with local prevailing rates for similar type loans as determined by the Plan administrator. Loans must be repaid within five years of the date of issuance, unless the loan proceeds are used for the purchase of a participant's principal residence, then the terms may be modified at the determination of the Plan administrator. Principal and interest is paid ratably through payroll deductions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Forfeited Accounts

Forfeited nonvested Company contributions may be either be used to pay administrative expenses of the Plan or reduce future Company contributions. For Plan year ended December 31, 2024, no forfeitures were utilized by the Plan and the Plan had a forfeiture balance of \$515.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the term of the Plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Company pays all costs for administering the Plan including investment advisory, audit and other fees, with the exception of loan processing and benefit payment fees which are specifically allocated and deducted from the participants' accounts.

NOTE 4: PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS

Certain of the Plan's investments are funds managed by the Custodian and related entities. Therefore, these transactions qualify as party-in-interest transactions. The Company paid fees for investment management services directly.

NOTE 5: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Input to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 2: Input to the valuation methodology include (continued):

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024.

Pooled Separate Accounts: Valued at the accumulation unit value (AUV) multiplied by the accumulation units held. The AUV is based on the net asset value of the underlying mutual fund, the fund's dividends, and the contract's separate account changes. The AUV is not a publicly quoted price in an active market.

Common Collective Trust fund: Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the tables above are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. The portfolio's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The portfolio invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements) and enters into "wrap contracts" issued by third-parties, and invests in cash equivalents represented by shares in money market funds. There are no unfunded commitments at December 31, 2024 or 2023. The fund has a daily redemption frequency and redemption notice period.

NOTE 6: GUARANTEED ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan holds a portfolio of annuity contract issued by Voya Retirement Insurance and Annuity Company ("Voya"), the Custodian of the Plan. This annuity contract guarantees principal and a guaranteed minimum interest rate for the life of the portfolio as well as featuring two declared interest rates, one current rate determined monthly, and a guaranteed minimum floor rate declared for a defined period, currently one calendar year.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$599,426 and \$629,234, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7: EMPLOYER MATCHING CONTRIBUTION RECEIVABLE

It has been discovered that due to payroll errors, employer safe harbor matching contributions totaling \$37,546 have not been made to certain participants for the Plan years ended December 31, 2024 and 2023. The amount has been recorded as Employer Contribution Receivable on the Plan's statements of net assets available for benefits as of December 31, 2024. The Plan Sponsor is in the process of depositing the contributions to the affected participant accounts. Loss of earnings will be calculated when applicable.

NOTE 8: PLAN TERMINATION

The Company anticipates that the Plan will continue without interruption but reserves the right to discontinue the Plan at any time. In the event of discontinuance of the Plan, all participants will become 100% vested in their account balances and the net assets will be allocated among the participants and beneficiaries of the Plan.

NOTE 9: TAX STATUS

The Employer adopted the Dataair plan, which was approved under the volume submitter program and received a favorable opinion letter from the Internal Revenue Service dated March 31, 2008, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income examinations for years prior to 2022.

NOTE 10: RISKS AND UNCERTAINTIES

The Plan provides for various investment options in money market funds, mutual funds, and a collective investment trust. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the various risk factors, in the near term, could materially affect participants' account balances and amounts reported in the financial statements.

NOTE 11: RECONCILIATION TO FORM 5500

There are no material differences between the financial statements and the information included on Form 5500 as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE 12: NONEXEMPT TRANSACTIONS

As reported on the supplemental schedule of delinquent participant contributions (Schedule H, Part IV, Line 4a), certain employee contributions totaling \$5,637 were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting a nonexempt transaction between the Plan and the Company for the year ended December 31, 2023. The Plan is in the process of correcting these late remittances following applicable DOL rules and regulations.

NOTE 13: SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued and concluded there are no subsequent events to report.
