## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Regal Cutting Tools, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### **NOTE 1 – Description of Plan**

The following description of the Regal Cutting Tools, Inc. Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **A. Nature of the Plan**

The Plan provides a defined contribution plan with elective deferral 401(k) and Roth 401(k) features covering eligible employees of Regal Cutting Tools, Inc. (the Company) over the age of 18 who have completed one month of service with no minimum requirement for hours of service during that month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the plan is Fidelity Management Trust Company.

The Plan’s federal identification number is 20-4780971 and the Plan number is 001.

#### **B. Contributions**

Each year, participants may contribute the maximum deferral amount allowed by the IRS or up to 80% of their annual compensation if that is less, on a pre-tax basis or as Roth deferrals. Participants who will attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds along with an insurance company general account. Effective January 1, 2015, the Plan includes an auto-enroll provision whereby eligible employees are automatically enrolled in the Plan and will have 6% of compensation withheld from each paycheck as a salary deferral. The Company match is discretionary. Matching contributions were 50% of the first 6% of participant base compensation contributed to the Plan for the years ending December 31, 2024 and 2023. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to limitations. The Company did not make any profit-sharing contributions for the years ending December 31, 2024 and 2023.

#### **C. Participant Accounts and Rollovers**

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, (b) Plan earnings, (c) forfeitures of terminated participant’s non-vested accounts, and (d) an allocation of administrative expenses. Allocations are based on account balances or participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the transfer of funds from other qualified plans to a participant’s separate rollover account.

### **NOTE 1 – Description of Plan (continued)**

#### **D. Forfeitures**

The non-vested portion of the employer contribution account of a participant who is partially vested and has resigned or has been terminated is forfeited in the year after the participant receives a distribution of the entire vested portion or incurs five consecutive one year “breaks in service,” whichever occurs first. Forfeited amounts are used by the employer to reduce expenses, offset future contributions, or to be reallocated to participants as additional Company contributions. For the year ending December 31, 2024 and 2023 Plan expenses and contributions were reduced by \$4,238 and \$17,735, respectively from the forfeited non-vested accounts. The unallocated forfeitures at December 31, 2024 and 2023 were \$1,746 and \$13, respectively.

#### **E. Investment Options**

Participants may direct contributions in 1% increments in a variety of mutual funds along with an insurance company general account.

Participants may change their investment options daily.

#### **F. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Loan transactions are treated as a transfer from (to) the investment fund and to (from) the loan fund. Loan terms cannot exceed 5 years unless the loan qualifies as a home loan for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at rates that range from 3.25% to 9.50% which are based on the prevailing interest rate charged on similar commercial loans under like circumstances by persons in the business of lending. Principal and interest are paid through payroll deductions.

#### **G. Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become vested in Company contributions in accordance with the following schedule.

#### **H. Benefit Payments**

Upon termination of service due to death, disability, or retirement (age 65), a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or in installments over a period selected by the participant. In addition, in-service withdrawals are allowed for qualifying hardships, disability, or upon attainment of at least age 59 ½ years. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

### **NOTE 2 – Summary of Significant Accounting Policies**

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements is as follows.

#### **A. Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **B. Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **C. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

#### **D. Investment Valuation and Income Recognition**

The fair value of the registered investment companies are valued at quoted prices in an active market. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment return is reflected by net increase/(decrease) in investment unit values. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **E. Payment of Benefits**

Benefits are recorded when paid.

#### **F. Administration**

Fidelity Workplace Services, LLC is the third-party administrator and Fidelity Management Trust Company is the custodian and trustee of the Plan. The custodian is responsible for investing and safekeeping all the Plan assets. Costs of administering the Plan are paid by the Company and the Plan.

#### **G. Subsequent Events**

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through September 16, 2025 the date the financial statements were available for issuance.

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for benefits.

### **NOTE 3 – Fair Value Measurements (continued)**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs were available to the Plan, so Level 2 and 3 inputs were not used.

Mutual funds are valued at the net asset value of the shares held by the Plan at year end as determined by unadjusted quoted market prices.

### **NOTE 4 – Information Prepared and Certified by Custodian**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at year end, assets acquired and disposed of within the year, net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the custodian of the plan).

### **NOTE 5 – Fully Benefit Responsive Contract**

The Plan has entered into a fully benefit responsive contract with The Lincoln National Life Insurance Company, which maintains the contributions in an insurance company general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits at contract value. Contract value, as reported to the plan by Lincoln National Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$255,022 and \$276,961, respectively.

### **NOTE 6 – Party-In-Interest Transactions**

Parties-in-interest are defined under the Department of Labor's (DOL) Rules and Regulations as any fiduciary of the Plan, and party rendering services to the Plan, the Company, and certain others. Certain Plan investments are shares of mutual fund accounts managed by Fidelity Management Trust Company. As such, transactions conducted with Fidelity and the Company qualify as party-in-interest transactions.

### **NOTE 7 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, the Plan Agreement including all rights, titles, powers, duties, discretions, and immunities imposed upon or reserved to the Trustee and the Company will continue in effect until all assets have been distributed by the Custodian as directed by the Company. Each Plan participant's benefits will become 100% vested in the event the Plan is terminated.

### **NOTE 8 – Tax Status**

The Plan has received a favorable determination from the Internal Revenue Service, which qualifies it for tax-exempt status. The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code and are, therefore, not subject to tax under present income tax law. The Plan has been amended since adopting the non-standardized pre-approved plan document; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the US Federal authorities. Plan management determined there were no items to be recognized as of December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

### **NOTE 9 – Supplemental Schedules**

Disclosures required by regulations include separate schedules of: (1) assets (held at end of year), (2) assets (acquired and disposed of within the year), (3) nonexempt transactions with parties in interest, (4) loans in default or uncollectible, (5) leases in default or uncollectible and (6) reportable transactions. Schedules 2, 3, 4, 5, and 6 are not included herein as they are not applicable to this Plan as of or for the year ended December 31, 2024.

### **NOTE 10 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
