We have performed audits of the accompanying financial statements of American Litho, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of American Litho, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

The Firm of Philip+Rae & Associates, CPA's, which audited the financial statements of the Club for the year ended December 31, 2023, was acquired by Platform CPA's, LLP effective November 4, 2024.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of American Litho, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 – Description of the Plan

The following brief description of American Litho, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

On January 19, 2023, the Plan was amended from a traditional defined contribution plan to a multiple employer defined contribution plan covering all non-union employees and non-resident aliens of American Litho, Inc., Serv Logistics, Serv Transport, and Sonny Acres, (“Employers”) who have completed a minimum of six months of service, as defined in the plan documents, and are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Each year, participants may contribute in either dollars or whole percentages of pretax annual compensation, as defined in the Plan. The Employers have an automatic deferral feature. Accordingly, each Employer will automatically withhold a portion of eligible participants’ compensation each payroll period and contribute that amount to the Plan unless the participant makes a contrary election, initial withholding is 3%. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan’s year are eligible to make catch-up contributions. All contributions are participant directed. The Employer’s, in their sole discretion, may make a matching contribution to each participant. The matching contribution shall be contributed to each eligible participant in accordance with the nondiscriminatory formula determined by the Employer’s. During 2024 and 2023, the Employer’s contributed 10% of the first 4% of base compensation contributed by the participant. Contributions are subject to certain limitations.

Participant accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Employer’s contributions, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants’ non-vested accounts may be used to reduce future employer contributions.

Vesting

Participants’ contributions and earnings thereon are immediately fully vested. A participant’s portion of the Employer’s contributions and related investment income vests according to the following schedule:

Investment options

The assets of the Plan, both employee and employer, are allocated to the various funds at the direction of the participants. The Plan offers a variety of investment funds with Empower Retirement, (“Recordkeeper”). A participant may maintain their entire account in one of the funds or may elect to split their account among the funds in accordance with the Plan.

Participants may change their investment direction of future contributions and may elect to transfer their existing account balances from one fund to another daily.

Note 1 – Description of the Plan (continued)***Payment of benefits***

Upon termination of service due to death, disability, retirement or other reasons, participants may receive the value of the vested balance in the participant's account as a lump-sum distribution.

Notes Receivable from Participants

Participant loans are permitted in accordance with the Plan's established loan procedure as follows: The minimum amount of any loan is \$1,000 and the maximum amount is the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan. The Plan was amended for 2015 to allow loans without a specific reason. As of January 1, 2016 the Plan was again amended in regards to loans. Under the current plan document a participant must meet certain criteria to take a loan. Loans are secured by a maximum of 50% of the participant's vested account balance. Loans shall bear an interest rate reasonable at the time of application, considering the purpose of the loan and the rate being charged by persons and institutions in the business of lending money. Loans are to be repaid in equal installment payments on the basis of substantially level amortization over the term of the loan. All loans are required to be repaid within 5 years of the date of the loan except if the proceeds are used to acquire the principal residence of the participant. In those instances, the loans will be required to be repaid within 30 years of the original date of the loan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$506 and \$3,313, respectively. These accounts will be used to reduce future employer matching contributions and make up a significant portion of the cash on the Statement of Available Benefits. The cash carries the same interest rate as the guaranteed interest contract of 1.41% for 2024 and 1.23% for 2023. During 2024 and 2023, employer contributions were reduced by \$3,272 and \$2,428, respectively from forfeited non vested accounts.

Plan termination

The Employer's anticipate that the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event that the Plan is terminated, all participants shall be fully vested, and each participant will be entitled to a distribution equal to his or her contributions and his or her share of the Employer contributions, investment income and loss, and unrealized appreciation or depreciation in the fair value of investments.

Note 2 – Summary of Significant Accounting Policies***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation using fair value measurements

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Investment transactions and investment income

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 – Summary of Significant Accounting Policies (continued)***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

Payment of Benefits

Benefit distributions are recorded when paid.

Operating Expenses

The Employer's pay a portion of the administrative expenses on behalf of the Plan. Expenses paid by the Employer's are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants account and are included in administrative expenses.

Note 3 – Tax Status

The Plan obtained its latest determination letter on March 31, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Note 4 – Certified Investment Information

The Plan management has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan management instructed the plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company, the asset custodian, as complete and accurate, except for comparing such information certified by the custodian with information in the plan's financial statements and supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year).

Note 5 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 - Inputs are unobservable and significant to the fair value measurement.

Note 5 – Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the years ended December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held in the fund are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Note 6 – Guaranteed Investment Contracts

The Plan maintains a benefit-responsive guaranteed investment contract with Empower Trust Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The stated interest rate for the plan years of 2024 and 2023 were 1.41% and 1.23%, respectively.

Note 6 – Guaranteed Investment Contracts (continued)

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the plan by, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The occurrence of an event that limits the ability of the investment to transact at contract value between Empower Trust Company and a participant holding the investment is not probable. (If an event should ever occur such as a significant decline in creditworthiness of Empower Trust Company, the Key guaranteed portfolio fund choice may no longer be considered fully benefit-responsive.)

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 – Party in Interest Transactions

Certain Plan investments are managed by the Recordkeeper of the plan, therefore, these transactions qualify as party in interest transactions.
