## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries  
of the Toll Brothers 401(k) Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Toll Brothers 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Toll Brothers 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### [1] General:

The Plan was established in 1976 as a defined-contribution profit-sharing plan covering substantially all of the employees of Toll Brothers, Inc. (the "Company" or "Plan Sponsor"). The Plan contains a cash or deferred arrangement as defined in Internal Revenue Code ("IRC") Section 401(k). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Empower Trust Company, LLC is the trustee and recordkeeper of the Plan.

The Plan has adopted a non-standardized adoption agreement with a restatement effective date of January 3, 2022. All employees may make salary reduction contributions upon their hire date, or the date they attain the age of 21, if later, if regularly scheduled to work 20 hours a week or more. Participants are eligible for employer contributions upon their hire date, or the date they attain the age of 21, if later, if regularly scheduled to work 20 hours a week or more. To receive discretionary contributions, eligible employees must also be employed on the last day of the Plan year.

##### [2] Contributions:

The Plan provides for the following categories of contributions:

- a. *Salary reduction contributions* – Participants may elect to defer 1% to 90% of eligible compensation, as defined, not to exceed statutory limitations. Salary reduction contributions shall be limited as needed to meet nondiscrimination tests.
- b. *Catch-up contributions* – Participants who have attained age 50 or older before the end of the Plan year may elect to defer additional amounts to the Plan, subject to the federal limit set by law.
- c. *Matching contributions* – The Company may make a matching contribution for each participant equal to an amount determined by the Company. For 2024, the Company matched contributions for each eligible participant equal to \$0.50 for each \$1.00 deferred by the participant, up to 6% of the participant's eligible compensation, for a maximum matching contribution equal to 3% of eligible compensation.
- d. *Qualified matching contributions* – The Company may contribute such additional amounts as it shall determine to be allocated to nonhighly-compensated employees who are employed on the last business day of the Plan year in the same proportion that the salary reduction contributions of each participant bear to the aggregate salary reduction contributions of all participants for such Plan year. For 2024, there were no such contributions made or approved by the Company.
- e. *Initial discretionary contributions* – The Company may, within its discretion, make an initial discretionary contribution to all eligible participants of the Plan. For 2024, the Company made an initial discretionary contribution of 1% of eligible compensation.
- f. *Profit-sharing contributions* – The Company may determine, for each Plan year, an amount which shall be allocated to each eligible participant in the same proportion that his or her eligible compensation bears to the aggregate eligible compensation of all eligible participants for such Plan year. For 2024, there were no such contributions made or approved by the Company.

#### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

##### [2] Contributions: (continued)

- g. *Qualified nonelective contributions* – The Company may determine, for each Plan year, an amount which shall be allocated to each eligible participant who is nonhighly-compensated in the same proportion that his or her compensation bears to the aggregate compensation of all eligible nonhighly-compensated participants for such Plan year. For 2024, there were no such contributions made or approved by the Company.
- h. *Rollover contributions* – A participant may make a rollover contribution to the Plan of all or any portion of the entire amount, which is an eligible rollover distribution from other defined-benefit or contribution plans.
- i. *After-tax Roth contributions* – Participants may make Roth contributions with after-tax dollars, not to exceed statutory limitations.

##### [3] Participant accounts:

The Plan provides for self-directed investment programs with a selection of mutual funds and pooled separate accounts. Although certain employer discretionary contributions are invested in employer stock, this option is no longer available for participants. Each participant's account is credited with the participant's contributions and allocations of (a) employer contributions, if any, and (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may change their investment options daily.

##### [4] Vesting:

Participants are immediately vested in their salary reduction contributions, catch-up contributions, rollover contributions, qualified matching contributions, qualified nonelective contributions and after-tax Roth contributions, plus actual earnings thereon.

Any amount not distributed because a participant is less than 100% vested is forfeited. Upon normal retirement age, disability or death, a participant (or the beneficiary of the participant) is paid his or her entire account balance in the Plan. Upon a distribution for any other reason, a participant receives only the vested portion of his or her account balance attributable to matching contributions, initial discretionary contributions and profit-sharing contributions and earnings thereon, according to his or her years of service as set out in the following table:

##### **[5] Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balances, plus any accrued but unpaid interest. A participant may borrow from his or her fund account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. Each loan is secured by the balance in the participant's account and bears interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. Interest rates on outstanding loan balances range from 4.25% to 9.50% as of December 31, 2024 and 2023. In its sole discretion, the Plan administrator may require the additional security of assets outside of the Plan as it deems necessary. Principal and interest are paid ratably through payroll deductions or any such manner as the Plan administrator may determine. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed as incurred.

##### **[6] Payment of benefits:**

Participants withdrawing from the Plan receive their vested balance by transfer to another qualified plan, transfer to an individual retirement account or distribution of a lump sum. Participants withdrawing from the Plan may elect to receive their vested balance in the form of monthly, quarterly or annual installments paid over any period of time. Participants who hold investments in employer stock may elect to receive all or a portion of the employer stock held in their participant account in cash or by transfer in kind in accordance with procedures established by the Plan administrator.

##### **[7] Forfeited amounts:**

Forfeited nonvested amounts may be used to reduce future employer contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of approximately \$891,000 were used to reduce employer contributions. Forfeited nonvested accounts available as of December 31, 2024 and 2023 were approximately \$922,000 and \$837,000, respectively.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **[1] Basis of accounting:**

The financial statements are prepared on the accrual method of accounting.

##### **[2] Investment valuation and income recognition:**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

##### [3] Payment of benefits:

Benefits are recorded when paid.

##### [4] Plan expenses:

Certain expenses incurred in connection with the administration of the Plan are paid by the Company, and certain Plan expenses are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

##### [5] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Empower Trust Company, LLC and Empower Annuity Insurance Company have certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

*Registered investment companies* – Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Pooled separate accounts* – Valued at NAV, as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly-quoted price in an active market. The pooled separate accounts are comprised of a wide variety of underlying investments such as stocks and bonds. These accounts may be redeemed daily; however, transfers and distributions may be deferred for up to 30 days if there is negative cash flow. The investment strategies of the pooled separate accounts are balanced. There were no redemption restrictions noted for these investments.

*Employer common stock* – Valued at the closing price reported on the active market on which the individual security is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

#### NOTE E - PLAN CONTRIBUTIONS

For the year ended December 31, 2024, the Company's initial discretionary contribution was approximately \$5,752,000 (net of forfeitures allocated of approximately \$126,000) and there were employer matching contributions of approximately \$13,296,000 (net of forfeitures allocated of approximately \$896,000). Participant contributions to the Plan (deferred at the election of the participants) were approximately \$40,148,000. Rollover contributions were approximately \$7,794,000 for the year ended December 31, 2024. There was no profit-sharing contribution for the year ended December 31, 2024.

#### NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Prudential Investments, an affiliate of Empower Trust Company, LLC, and Empower Annuity Insurance Company. Therefore, transactions related to these investments qualify as party-in-interest transactions.

The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions. Fees paid by the Plan were approximately \$380,000 for the year ended December 31, 2024.

#### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)**

The trustee provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the trustee provides to the funds. This revenue is used to offset certain amounts owed to the trustee for its administrative services to the Plan. If the revenue received by the trustee from such mutual fund service providers exceeds the amounts owed, the trustee remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, approximately \$406,000 was received from the trustee and is reflected in net realized/unrealized appreciation in fair value of investments in the statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, the ERISA account balance was approximately \$128,000 and \$124,000, respectively. During 2024, approximately \$279,000 was used to pay Plan expenses and approximately \$124,000 was allocated to participants' accounts.

Toll Brothers, Inc. is the Plan sponsor and the Plan administrator; therefore, Toll Brothers, Inc.'s common stock transactions qualify as party-in-interest transactions.

#### **NOTE G - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated September 22, 2022 that the Plan was qualified under the IRC and, therefore, the related trust was exempt from taxation. Thus, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial market may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of the investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE J - REGISTERED INVESTMENT COMPANY FEES**

Certain investments in registered investment companies are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### **NOTE K - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

In November 2024, participants of the Toll Manufacturing 401(k) Plan became eligible to participate in the Toll Brothers 401(k) Savings Plan. On March 2, 2025, all assets from the Toll Manufacturing 401(k) Plan were transferred into the Toll Brothers 401(k) Savings Plan.
